1. PURPOSE OF THE NOTICE

The purpose of this notice is to request qualifying services providers to submit quotations for the provision of the development of a revised 2021-2026 organisational strategy and 2024-2025 annual performance plan.

2. SCOPE OF WORK/DELIVERABLES

The preferred service provider will be expected to facilitate workshops, assist with report writing and development/ review and produce the following documents:

- 1. Review, revise and/or update the 2021-2026 five-year strategic plan based on the research and outcomes of the workshops with management, board, and the shareholder.
- 2. Review and package the 2024-25 Annual Performance Plan aligned with the budget for financial year.

The preferred service provider will be expected to have a proven track record in facilitating, development and reviewing of organisational strategies for municipal entities. The estimated number and duration of strategic sessions are to be held as follows:

- 1. BCMDA Board and management strategy workshop- estimated 1 day.
- 2. BCMDA Stakeholder, Board and Shareholder strategy workshop- estimated 2 days.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
