## 2. **COMPANY OVERVIEW**

South African Broadcasting Corporation (SABC) is a Public Entity founded in August 1936 and listed in terms of Schedule 2 of the Public Finance Management Act, Act No. 1 of 1999, as a public broadcaster in South Africa, and provides 19 radio stations as well as five television broadcasts to the general public.

## 3. **BACKGROUND**

SABC Auckland Park operates a total of 31 transformers that supply power to both TV and Radio Park buildings. These transformers are critical to the uninterrupted broadcasting operations of the SABC. To restore reliability, protect SABC's electrical infrastructure, and optimize electricity usage and costs, comprehensive major maintenance is now urgently required across all transformer units.

## 4. **OBJECTIVES OF THE MAINTENANCE**

- Restore transformers to optimal operational condition.
- Improve overall power factor and reduce electricity losses.
- Extend the lifespan of the equipment.
- Ensure compliance with electrical and safety regulations.
- Prevent equipment failure that could disrupt broadcasting operations.
- Ensure accurate readings and billing with the municipality.

## 5. **TOTAL TRANSFORMERS ON SITE**

### **TV and Radio Park: 31 transformers**

- Sub A: 2x 1500kVA
- Sub B: 2x 1500kVA
- Sub C: 1x 1000kVA
- Sub D: 2x 1500kVA
- Sub F: 3x 1000kVA
- Ground Floor Sub: 1x 500Kva
- Chiller Plant: 1x 600kVA
- TV Side Transformers: 20x units (varied capacity)

## 6. **REQUIREMENTS AND SCOPE OF SERVICES**

### **6.1 Sub F Transformer No. 1 & 2 (2x 1000kVA)**

- Purify transformers @ 4 circulations
- Take after-oil sample
- Replace silica gel

### **6.2 Sub A Transformer No. 1 & 2 (2x 1500kVA)**

- Isolate, drain oil, and re-gasket LT bushings
- Flush with 10% new virgin oil

- Refill with new virgin oil & purify (4 circulations)
- Full transformer test (ratio, pressure, iron/copper losses)
- Replace silica gel & take after sample

**6.3 Sub C Transformer No.1 (1000kVA)**

- (Same scope as Sub A)

**6.4 Sub D Transformer No.1 & 2 (2x 1500kVA)**

- Same as Sub A plus:
- Remove top cover
- Repair tap changer leak
- Re-gasket top cover

**6.5 Sub B Transformer No.1 & 2 (2x 1500kVA)**

- Same as Sub D plus:
- Re-gasket HT bushings
- Repair/replace top drain valve
- Re-tape HT bushings

**6.6 Ground Floor Sub (500kVA)**

- Isolate & drain oil
- Re-gasket HT bushings & top cover
- Refill oil, purify (4 circulations)
- Replace silica gel & take after sample

**6.7 Chiller Plant Transformer (600kVA)**

- Isolate & drain oil
- Re-gasket LT bushings & Buchholz relay
- Repair leaking cooling fins
- Refill, top-up oil & purify (4 circulations)
- Replace silica gel & take after sample

**6.8 TV Side Transformers (20 units)**

- Isolate & drain oil
- Repair/replace leaking top drain valve
- Flush (10% virgin oil), refill & purify (4 circulations)
- Full transformer testing
- Replace silica gel & take after sample
- Re-gasket LV & HT bushings, Buchholz relay
- Repair tap changer, winding temp relays
- Re-torque top cover

***Note: Compliant Safety File as per OHS Act under regulation 17 (Maintenance of electrical machinery) will be required before the commencement of work.***

### 13.3 ADJUDICATION USING A POINT SYSTEM

- The bidder obtaining the highest number of total points will be awarded the contract.
- Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

### 13.4 OBJECTIVE CRITERIA

- The SABC reserves the right not to award this tender to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- The SABC will not award contract/s to the bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance, company financials, etc. will be eliminated from the bid process.
- The SABC reserves the right not to award this tender to any bidder who fails the financial stability assessment.
- No SABC former employees shall be awarded contracts with the SABC within **Twelve (12) months** after termination of employment with the SABC.
- Should employees resign or retire from the employment of the SABC and become directors of other businesses tendering with the SABC, such tender shall not be considered until the cooling off period of **Twelve (12) months** has expired.
- Should the employee be dismissed from the SABC employment, such employees shall be prohibited from conducting business with SABC for a period of **Five (5) years** from the date of dismissal.
- Should the employee be found guilty in a court of law due to criminal conduct/act, such employee will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.
- The SABC shall not procure any goods, services, works or Content from any Board member or Board member owned business, to ensure that suppliers competing for the SABC's business have confidence in the integrity of SABC's selection process.
- Should the SABC's Board members no longer serve on the SABC Board but become directors of other companies, the SABC shall not conduct business with those companies until the cooling off period of **Twelve (12) months** has expired.
- Should the Board member be found guilty in a court of law due to criminal conduct/act, such Board member will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.

## 14. COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

**All enquiries relating to this RFQ should be emailed three days before the closing date.**

## 15. CONDITIONS TO BE OBSERVED WHEN TENDERING

- The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- No tender shall be deemed to have been accepted unless or until a formal contract / letter of award is signed by both parties.
- **The Corporation reserves the right to:**
  - Make a selection solely on the information received in the submissions
  - Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
  - Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.
  - Cancel this RFQ or any part thereof at any time.
- Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the BEE & Price.

## 16. COST OF BIDDING

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under any circumstances be responsible or liable for any such costs, regardless of, without limitation, the outcome of the bidding, evaluation, and selection process.

## 17. PAYMENT TERMS

SABC will effect payment sixty (60) days after the service provider has rendered the service and submitted an invoice / statement.

**1. GENERAL CONDITIONS**

1.1 The following preference point systems are applicable to invitations to tender:

- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

**1.2 To be completed by the organ of state**

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;

#### 3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

**4. POINTS AWARDED FOR SPECIFIC GOALS**

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
