PART 1: INVITATION TO TENDER



1 GENERAL

Submissions to this Request for Proposal (RFP) [hereinafter referred to as a Tender or a Proposal] are requested from persons, companies, close corporations or enterprises [hereinafter referred to as an entity or Tenderer].

South Africa's state-owned Strategic Fuel Fund ("SFF") Association has appointed PV-SA Energy Services ("PV-SA") to project manage the exploration programme for Block B2 in South Sudan. PV-SA's project management tasks include all matters relating to the current RFP. As such, queries relating to this RFP and any future exploration sub-projects for Block B2, unless explicitly instructed by SFF, need to be communicated in writing to PV-SA using the following email address:

1.1 DESCRIPTION OF SUB-PROJECT#2

RFP number SFF/2022/NOE/SP#2 is for a technical service provider, referred to as the Tenderer in this tender document, to Carry Out *Sub-Project#2 Comprising* Quality Control, Data Processing, Modelling, Inversion and Interpretation of Gravity and Magnetic Data (GAMD) for Licence Block B2 in South Sudan.

1.2 TENDER DEADLINES

Confirm receipt and intention to bid using form in APPENDIX 1 by 19/04/2022

Deadline for tender queries is 22/04/2022

All responses to queries will be provided by 29/04/2022

Deadline for proposal submission is **06/05/2022** at **16:00** hrs **South African Time.** Tenderers must ensure that tenders are delivered timeously. As a general rule, if a Tender is late or delivered to the incorrect address, it will not be accepted for consideration.

1.3 PROPOSAL SUBMISSION OPTIONS

Proposals can be physically delivered or emailed.

Also, please note that each proposal submitted by email is limited to attachments that have a maximum total file size of 20MB. If the attachments exceed 20MB in total file size, the tenderer should submit the proposal in multiple emails clearly marked 1 of 3, 2 of 3, etc.

2 DELIVERY INSTRUCTIONS FOR RFP

2.1 Delivery by hand

If delivered by hand, envelopes must be deposited in the tender box which is located at the PV-SA office in Foyer 3, 1st Floor, The Colosseum, Century Way, Century City, 7447, Cape Town, South Africa. It should also be noted that the above tender box will be accessible to tenderers between office hours 08h00 to 16h00 week days only.

2.2 <u>Dispatch by courier</u>

- 2.2.1. If dispatched by courier, the envelope must be addressed as above and delivered to the above address. Couriered documents must be in the tender box by the closing date and time.
- 2.2.2. If tender responses are not delivered as stipulated herein, such tenders will not be considered.
- 2.2.3. No faxed Submissions will be considered.
- 2.2.4. The tender responses to this RFP will be opened as soon as possible after the closing date and time. SFF or PV-SA shall not, at the opening of Submissions, disclose to any other company any confidential details pertaining to the Proposals / information received, i.e. pricing, delivery, etc. The names and locations of the Tenderers will be divulged to other Tenderers upon request after award of the contract.
- 2.2.5. Envelopes must not contain documents relating to any RFP other than that shown on the envelope.

3 BROAD-BASED BLACK ECONOMIC EMPOWERMENT AND SOCIO-ECONOMIC OBLIGATIONS

SFF Association fully endorses and supports the Government's objective of Broad-Based Black Economic Empowerment and it is strongly of the opinion that all South African business enterprises have an equal obligation to redress the imbalances of the past.

SFF Association would therefore prefer to do business with enterprises who share these same values and who are prepared to contribute to meaningful B-BBEE initiatives [including, but not limited to subcontracting and Joint Ventures] as part of their tendered Submissions. All procurement transactions will be evaluated accordingly.

3.1 <u>B-BBEE Scorecard and Rating</u>

- the 80/20 system for requirements with a Rand value of up to R50,000,000 (all applicable taxes included) OR
- the 90/10 system for requirements with a Rand value above R50,000,000 (all applicable taxes included)



When SFF association invites prospective Service Providers to submit Proposals for its various expenditure programmes, it requires Tenderers to have their B-BBEE status verified in compliance with the Codes of Good Practice issued in terms of the Broad Based Black Economic Empowerment Act No. 53 of 2003.

Tenderers are required to complete Annexure A [the B-BBEE Preference Point Claim Form] and submit it together with proof of their B-BBEE Status as stipulated in the Claim Form in order to obtain preference points for their B-BBEE status.

Note: Failure to submit a valid and original B-BBEE certificate or a certified copy thereof at the Closing Date of this RFP will result in a score of zero being allocated for B-BBEE.

3.2 <u>B-BBEE Joint Ventures or Consortiums</u>

Tenderers who would wish to respond to this RFP as a Joint Venture [JV] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Tenderers must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If such a JV or consortium agreement is unavailable, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by SFF association through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to SFF Association.

Tenderers are to note that for the purpose of evaluation, a JV will be evaluated based on one consolidated B-BBEE score card as per the **Preferential Procurement Regulations 2017** preference point scoring.

Note: Failure to submit a valid and original B-BBEE certificate for the JV or a certified copy thereof at the Closing Date of this RFP will result in a score of zero being allocated for B-BBEE.

3.3 <u>Subcontracting</u>

SFF Association fully endorses Government's transformation and empowerment objectives and when contemplating subcontracting. Tenderers are requested to give preference to companies which are Black Owned, Black Women Owned, Black Youth Owned, owned by Black People with Disabilities, EMEs and QSEs.

In terms of sub-regulation 5 of Regulations 6 and 7 of the Preferential Procurement Regulations, 2017 respectively, if contemplating subcontracting, a tenderer will not be awarded points for B-BBEE status level of contributor if the tender documents indicate that the tenderer intends sub-contracting more than 25% of the value of the contract to any other person not qualifying for at least the points that the tenderer qualifies for, unless the intended subcontractor is an EME that has the capability to execute the subcontract.

In terms of Annexure A of this RFP [the B-BBEE Preference Point Claim Form], Tenderers are required to indicate the percentage of the contract that will be sub-contracted as well as the B-BBEE status of the sub-contractor/s.



In addition, tenderers are required to attach a letter from the intended sub-contractor in the event of the Tenderer's appointment.

- 4.2 Any correspondence with regards to this RFP must be in writing only to the provided email address.
- 4.3 After the closing date of the RFP, a Tenderer may only communicate with the **Tender Administrator**, who is responsible for this RFP, on any matter relating to this RFP.
- 4.4 Tenderers are to note that changes to its submission will not be considered after the closing date.
- 4.5 Tenderers are warned that a proposal will be liable to disqualification should any attempt be made by a Tenderer either directly or indirectly to canvass any officer or employee of SFF in respect of this RFP between the closing date and the date of the award of the contract.
- 4.6 Furthermore, Tenderers found to be in collusion with one another will be automatically disqualified and restricted from doing business with SFF in the future.

5 INSTRUCTIONS FOR COMPLETING THE RFP

- 5.1. Hard copy proposals must be submitted as an original and 1 copy, unless an electronic submission is made.
- 5.2. For hard copy submissions, both sets of documents are to be submitted to the office address specified under point 1.3 above.
- 5.3. All returnable documents tabled in the Proposal Form [Part 5] must be returned with your proposal.
- 5.4. Unless otherwise expressly stated, all proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.

6 COMPLIANCE

The successful Tenderer shall be in full and complete compliance with any and all applicable laws and regulations.

7 DISCLAIMERS

Tenderers are hereby advised that SFF is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that SFF reserves the right to:



- 7.1. modify the RFP's Scope of Work and request Tenderers to re-tender on any such changes;
- 7.2. reject any Proposal which does not conform to instructions and scope of work which are detailed herein;
- 7.3. disqualify Proposals submitted after the stated submission deadline [Closing Date];
- 7.4. not necessarily accept the lowest priced Proposal or an alternative Tender;
- 7.5. validate any information submitted by Tenderers in response to this tender. This would include but not limited to, requesting the Tenderer to provide supporting evidence. By submitting a tender, the Tenderer hereby irrevocable grant the necessary consent to SFF to do so;
- 7.6. request audited financial statement or other documentation for the purposes of a due diligence exercise;
- 7.7. award a contract in connection with this Proposal at any time after the RFP's closing date;
- 7.8. award a contract for only a portion of the proposed Services which are reflected in the scope of this RFP;
- 7.9. split the award of the contract between more than one Service Provider, should it at SFF's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- 7.10. cancel the tender process.
- 7.11 exclude any Tenderer from the Tendering process who has been found guilty of a serious breach of law during the preceding 5 [five] years, including but not limited to breaches of the Competition Act 89 of 1998. Tenderers are required to declare such serious breach of law during the past 5 [five] years in Part 10 [Breach of Law].
- 7.12 undertake post-tender negotiations [PTN] with the view to achieving a market related price or to cancel the tender. PTN will be done in a sequential manner.
- 7.13 award the business to the highest scoring Tenderer/s unless objective criteria justify the award to another Tenderer.
- 7.14 award the business to the next ranked Tenderer, provided that the Tenderer is still prepared to provide the required Services at the quoted price, should the preferred Tenderer fail to sign or commence with the contract within a reasonable period after being requested to do so. Under such circumstances, the validity of the tenders of the next ranked Tenderer(s) will be deemed to remain valid, irrespective of whether the next ranked Tenderer(s) were issued with a Letter of Regret. Tenderers may therefore be requested to advise whether they would still be prepared to provide the required Services at their quoted price, even after they have been issued with a Letter of Regret.

Kindly note that the SFF Association will not reimburse any Tenderer for any preparatory costs or other work performed in connection with its Proposal, whether or not the Tenderer is awarded a contract.

8 LEGAL REVIEW

A Proposal submitted by a Tenderer will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by SFF Legal Advisor, prior to consideration for an award of business.

9 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Tenderers are required to self-register on National Treasury's Central Supplier Database ("CSD") which has been established to centrally administer supplier information for all organs of the State and facilitate the verification of certain key supplier information. Tenderers must register on the CSD prior to submitting their bids. Business may not be awarded to a Tenderer who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD.



For this purpose, the attached SBD1 form must be completed and submitted as a mandatory returnable document by the closing date and time of the bid (Please see ANNEXURE E).

10 TAX COMPLIANCE

Tenderers must be compliant when submitting a proposal to SFF and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this tender that the tax matters of the successful Tenderer be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Tenderer's tax obligations.

The Tax Compliance status requirements are also applicable to foreign Tenderers who wish to submit tenders.

Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

11 PROTECTION OF PERSONAL INFORMATION ACT, NO.4 OF 2013

SFF Association acknowledges that the Tenderer may be required to process the personal information of SFF Association and other relevant data subjects in connection with and for the purposes of this RFP.

The Tenderer shall -

- (a) only process such personal information for the purpose connected with this RFP, except to the extent specifically requested to do otherwise by SFF association in writing or required by the Protection of Personal Information Act, No.4 of 2013 (POPI) or other applicable laws;
- (b) comply with all directions and instructions which may be given by SFF association regarding the processing of such personal information;
- (c) only process personal information strictly in compliance with POPI;
- (d) secure the integrity and confidentiality of the personal information it processes pursuant to this RFP by taking appropriate, reasonably technical and organisational measures to prevent
 - (i) loss of, damage to, or unauthorised destruction of such personal information; and/or
 - (ii) unlawful access to or unlawful processing of such personal information.

The Tenderer shall be liable to SFF for its failure to comply with any of its obligations, and shall indemnify SFF against all claims, damages, costs or administrative fines arising from the Tenderer's failure to comply with POPI, except to the extent caused by SFF association.

PART 2: BACKGROUND OVERVIEW AND SCOPE OF WORK

12 BACKGROUND OVERVIEW

Planned Potential Fields Geophysical Work as Follows:

As part of its committed Exploration programme, SFF is soliciting the following technical services through its appointed Project Management Company "PV-SA":

- A. Sub-Project#1: Airborne Gravity and Magnetic Survey (AGAMS) for Block B2, South Sudan.
- **B. Sub-Project#2**: Quality Assurance / Quality Control of acquired data, Data processing, Modelling, Inversion and interpretation of Gravity and Magnetic data in specified area\s of Block B2, South Sudan.

Both sub-projects will run concurrently and in collaboration with each other. Input and advice of an Expert/Company appointed for Sub-project#2 is required prior to commencement of the AGAMS in Block B2 in order to fix the survey acquisition parameters to be considered by the Sub-Project#1 Contractor during data acquisition. Any data not approved by the Contractor of Sub-Project#2 on technical grounds and/or due to quality control issues, will not be accepted by SFF and Project Management consultants (PV-SA). In the event of any dispute, PV-SA and the SFF Technical team will have final authority for dispute resolution.

The tender for Sub-Project#1 has already being issued separately. Under no circumstances will both sub-projects be awarded to the same company to avoid a "Conflict of interest" and to get the best possible results.

The present tender is for Sub-Project#2.

12.1 Description of Sub-Project#2

RFP number SFF/2022/NOE/SP#2 is for a service provider, referred to as the Tenderer in this tender document, to carry out Sub-Project#2 comprising Quality Control, Data Processing, Modelling, Inversion and Interpretation of Gravity and Magnetic Data (GAMD) for Licence Block B2 in South Sudan.

12.2 Project Information

South Africa's state-owned Strategic Fuel Fund ("SFF") signed an Exploration and Production Sharing Agreement (EPSA) with the Ministry of Petroleum, South Sudan government during May 2019. Under this agreement, SFF will carry out E&P activities in Block B2 in partnership with South Sudan's national oil company, Nile Petroleum Corp (carried partner).

As part of its obligations, SFF requires the Tenderer to carry out Sub-Project#2 comprising Quality Control, Data Processing, Modelling, Inversion and Interpretation of Gravity and Magnetic Data (GAMD) for Licence Block B2 in South Sudan. SFF is seeking a Tenderer that can demonstrate capability and record of accomplishment in conducting such technical work in the African region in general and preferably within South Sudan.

12.3 Technical Overview

For the fulfilment of the EPSA responsibilities and commitments in licence Block B2 in South Sudan, SFF plans to develop an understanding of the Block B2 Petroleum system and will also



develop a Geological model as part of exploration risk mitigation. It includes acquisition of new airborne gravity and magnetic data across licence Block B2. This process will assist in scaling down and delineating target areas for the petroleum exploration programme.

The survey area of interest is located in the south-eastern portion of South Sudan and extends over an area estimated at around 37000 sq-km, equivalent to around 26000 Line-km of geophysical data (based upon preferred main line spacing). During this acquisition phase, given the locations of Bor and Juba airports within or close to licence Block B2, it is anticipated that either or both airports may be used as base stations for daily flight departures. This potentially offers the option of simultaneous flights from the two airports to help fast-track survey data acquisition while also shortening survey time.

Survey design parameters, specifications and products of this survey will be determined essentially on subsurface depth of geological targets and legacy data in consultation with Experts engaged for Sub Project#2. Legacy data over the area of interest is limited to basic geological mapping, a small vintage 2D seismic interpretation, and vintage gravity coverage and satellite gravity data.

Airborne traverse lines will be flown in a south west to north east (N 40° E) direction with a traverse line spacing of 2,000m. Tie lines are required to be flown perpendicular to the traverse lines at a spacing of 6,000m apart.

Survey quality control, Data Processing, Modelling, Inversion and Interpretation of GAMD is required and therefore forms the basis of the SOW for Sub-Project#2 that needs to be carried out by an independent contractor.

12.4 Survey Location





Figure 1: Topography map with survey boundary and tabulated co-ordinates

<u>Location and Terrain:</u> The survey is situated in South Sudan. A project area map is provided below with the survey boundary (red line) shown together with a tabulated list of block boundary coordinates (Figure 1). The terrain is moderate and therefore a gentle drape survey is recommended.

<u>Survey Specifications</u>: A summary of the survey line directions and line kilometres is provided in the map and inset table below.





12.5 Sub-Project#2 Objectives

The objectives of Sub-Project#2 are as follows:

- The Sub-Project#2 Service provider must optimise the parameters of survey data acquisition in consultation with the Service provider of Sub-Project#1 on reasonable limits without compromising safety of crew, machine and\or aircraft.
- Sub-Project#2 Service provider has to develop a communication channel with the survey data acquisition team to preferably get data in live real time while the survey is in progress or at least at the end of each day to assess the quality of data.
- Sub-Project#2 Service provider will inform the Sub-Project#1 survey data acquisition team immediately regarding data acceptability while communicating similar to the Project Management Consultant PV-SA and the SFF technical team.
- The Sub-Project#2 service provider must ensure that SFF receives the best possible quality survey data set on a timely basis and to ensure that the usability of the survey result is not impacted by errors, omissions or data noise generated by equipment, methodology and\or processing.
- Time keeping and any stand by time is to be logged and communicated with reasons thereof.
- To improve regional to basin scale understanding of the area of interest by defining the basement depth, interpreted lithology, fault throws and major lineaments, structure of sediment fairways and depositional-centers which may be present in the sedimentary section. This will promote future exploration activities in this under-explored region through the integration of independent data within a geologically coherent regional structural framework.



12.6 Scope of Work

The scope of work (goals, and deliverables) for Sub-Project#2 are as follows:

- On-site / remote quality control of the AGAMS, ensuring all instrument tolerances, calibration requirements, re-flight tolerances, and overall survey accuracy-resolution requirements are in order and according to acceptable international standards.
- Provide contractual specifications for data quality, review and approval of pre-survey start-up calibrations including test line data, static gravity tests, drift tests, GPS accuracy plots, altimeter calibrations, magnetic compensation and figures of merit, and review ongoing production data (Daily/weekly), among others;
- Reporting and presentation (Quality control);
- Provide regional context by compiling and comparing different data types and interpretations (e.g. legacy and public domain data);
- Airborne Survey Data processing, filtering and image processing;
- Produce updated structural maps to delineate basins, basement highs and major faults through integrated interpretation of gravity and magnetic data;
- Produce 3D regional basement relief over the project area;
- Assess the regional lithospheric discontinuities through 2.5D gravity modelling along selected profiles;
- Inversion studies and interpreted results
- Refine the shallow-sediment model using all available data and information;
- Integrated potential field data interpretation incorporating legacy seismic and data from well Kedelai-1 in order to obtain a preliminary structural interpretation in the shallow section, which could be set to design and plan new seismic surveys and/or support seismic interpretation;
- Reporting and presentation (Processing-Interpretation).

12.7 Work Execution Plan

A Project Execution Plan (PEP) is required that defines how the quality control, processing, modelling, and interpretation of the airborne gravity and magnetic acquisition survey in Block B2 will be undertaken. It will detail the specific activities in the project, the resources applied to the project, and the organization of the project. The major elements of a project execution plan are:

- Scope Definition
- Project scheduling
- Timelines as per deliverables (Milestones)
- Quality and technical specifications
- Resource allocation
- Safety and Environmental Management System (refer to Appendix IV for basic guidance)

12.8 Deliverables:

The Sub-Project#2 Service provider is required to provide the following service components:

A. Quality Control

• To provide quality control for an upcoming airborne gravity and magnetic survey in South Sudan. The survey area of interest is located in the south eastern portion of South Sudan and covers an extensive area estimated at 37,000 km².



- Provide review of contractual specifications for data quality including instrument tolerances, calibration requirements, re-flight tolerances, and overall survey accuracy resolution requirements prior to survey commencement;
- Review and approval of pre-survey start-up calibration test line data, static gravity tests, drift tests, GPS accuracy plots, altimeter calibrations, magnetic compensation and figures of merit prior to airborne survey commencement;
- Review ongoing survey data (daily and weekly) including daily repeat lines, calibrations, free air grids, tie-traverse crossovers, turbulence indicators, magnetic spiking and compensation results to ensure that the results fall within required contractual specifications;
- Prompt survey demobilisation approval;
- Provide a short summary report on the results and overall accuracy resolution of results acquired during the survey;
- Review delivery of final data products.

B. Structure, Modelling, Inversion and Other Studies

The Contractor undertakes to execute the Services as specified below:

- To carry out desktop study comprising <u>modelling</u>, <u>inversion and interpretation</u> of airborne gravity and magnetic data in order to review and/or validate available geological, seismic, regional gravity and magnetic legacy data relating to Block B2, South Sudan as provided by SFF and or available in the public domain.
- Review available data including results from basins to the NW of the current AOI;
- Establish physical property contrasts for the basins of interest (particularly density) noting legacy data for the study area is limited to basic geological coverage, a small vintage seismic interpretation, vintage ground gravity coverage (North Western portion of the AOI) and satellite gravity data. Interpretation will rely on extrapolating data from known oil fields in contiguous blocks such as Block 5A.
- Data processing and filtering:
 - (a) Spectral filter data to establish the optimal accuracy-resolution dataset for gravity modelling;
 - (b) Carry out 3D terrain inversion to derive the Bouguer Anomaly;
 - (c) Use available seismic sounding data to perform isostatic correction to the Bouguer Anomaly;
 - (d) Create a series of filtered products from the isostatically corrected Bouguer Anomaly including derivative and spectral slices;
 - (e) Filter and image magnetic data;
- Unconstrained inversion:
 - (a) Perform simple 3D unconstrained inversions on gravity and magnetic data, and
 - (b) Extract depth slices from these datasets;
- Perform automated depth to basement analysis: on magnetic data (including Werner Deconvolution, Naudi and Euler Deconvolution);
- Digitise magnetic form lines: and characterise these by automated modelling results;
- Create a first-pass depth to magnetic basement: by digitising results in 3D space and running picks through implicit modelling software;
- Carry out a structural interpretation: using SFF information, historical data, gravity and magnetic results.



- Create series of 2.5D gravity forward models: (supported by magnetic results) starting from the NW
 where basin controls are better defined and using geological interpretations as starting points;
- Use the structural interpretation, geology, magnetic basement model and 2.5D forward models to build an implicit 3D basin model for the entire AOI;
- Run a 3D inversion on the starting model with physical property constraints from the earlier studies and forward modelling results. The objectives of this exercise serve two purposes:
 - (a) Create a conceptual 3D exploration model of the survey area;
 - (b) Use the conceptual model to constrain geophysical inversion results and/or build on the conceptual model using geophysical inversion results.

1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to all bids:

2. **DEFINITIONS**

- 2.1 "all applicable taxes" includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- 2.2 **"B-BBEE"** means broad-based black economic empowerment as defined in section 1 of the Broad -Based Black Economic Empowerment Act;
- 2.3 "B-BBEE status level of contributor" means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 **"bid"** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 **"Broad-Based Black Economic Empowerment Act"** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **"comparative price"** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 "consortium or joint venture" means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 "contract" means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 "EME" means any enterprise with an annual total revenue of R10 million or less.
- 2.10 **"Firm price"** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 "functionality" means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 "non-firm prices" means all prices other than "firm" prices;
- 2.13 **"person"** includes a juristic person;



- 2.14 **"rand value"** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 **"sub-contract"** means the primary contractor's assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 "total revenue" bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act (as may be amended) and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 **"trust"** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.

APPENDIX (IV): SAFETY ARRANGEMENTS AND PROCEDURAL COMPLIANCE WITH THE OCCUPATIONAL HEALTH AND SAFETY ACT (ACT 85 OF 1993) AND APPLICABLE REGULATIONS

1. General

- 1.1 The Contractor and SFF (hereinafter referred to as "the Client") are individual employers, each in its own right, with their respective duties and obligations set out in the Occupational Health and Safety Act, Act 85 of 1993 (the Act) and applicable Regulations.
- 1.2 The Contractor accepts, in terms of the General Conditions of Contract and in terms of the Act, his obligations as an employer in respect of all persons in his employ, other persons on the premises or the Site or place of work or on the work to be executed by him, and under his control. He shall, before commencement with the execution of the contract work, comply with the provisions set out in the Act, and shall implement and maintain a Health and Safety Plan as described in the Construction Regulations, 2003 and as approved by SFF, on the Site and place of work for the duration of the Contract.
- 1.3 The Contractor accepts his obligation to complying fully with the Act and applicable Regulations notwithstanding the omission of some of the provisions of the Act and the Regulations from this document.
- 1.4 SFF accepts, in terms of the Act, its obligations as an employer of its own employees working on or associated with the site or place of work, and the Contractor and Procurement Manager / SHEQ Manager / Technical Manager or his deputy shall at all times, co-operate in respect of the health and safety management of the site, and shall agree on the practical arrangements and procedures to be implemented and maintained during execution of the Works.
- 1.5 In the event of any discrepancies between any legislation and this specification, the applicable legislation will take precedence.

2. Definitions

- 2.1 In this Specification any word or expression to which a meaning has been assigned in the Construction Regulations, shall have the meaning so assigned to it, unless the context otherwise indicates: -
- 2.2 "competent person" in relation to construction work, means any person having the knowledge, training and experience specific to the work or task being performed:
 Provided that where appropriate qualifications and training are registered as per the South African Qualifications Authority Act, 1995 these qualifications and training shall be deemed to be the required qualifications and training;
- 2.4 **"contractor"** means principal contractor and "subcontractor" means contractor as defined by the Construction Regulations, 2003.
- 2.5 **"fall protection plan"** means a documented plan, of all risks relating to working from an elevated position, considering the nature of work undertaken, and setting out the procedures and methods applied to eliminate the risk;
- 2.6 **"health and safety file"** means a file or other record in permanent form, containing the information required to be kept on site in accordance with the Act and applicable Regulations;



- 2.7 **"Health and Safety Plan"** means a documented plan which addresses the hazards identified and include safe work procedures to mitigate, reduce or control the hazards identified;
- 2.8 **"Risk Assessment"** means a programme to determine any risk associated with any hazard at a construction site, in order to identify the steps needed to be taken to remove, reduce or control such hazard;
- 2.9 "the Act" means the Occupational Health and Safety Act No. 85 of 1993.
- 3. The Contractor shall, in accordance with the Act and applicable Regulations, make all the necessary appointments of competent persons in writing on a form similar to Annexure 2 of this Specification and deliver copies thereof to the Procurement Manager / SHEQ Manager / Technical Manager. Copies should also be retained on the health and safety file.
- 3.1 Subcontractors shall also make the above written appointments and the Contractor shall deliver copies thereof to the Procurement Manager / SHEQ Manager / Technical Manager.
- 3.2 In the case of a self-employed Contractor or any subcontractor who has the appropriate competencies and supervises the work himself, the appointment of a construction supervisor in terms of regulation 6.1 of the Construction Regulations, 2003 will not be necessary. The Contractor shall in such a case execute and sign a declaration, as in Annexure 3, by which he personally undertakes the duties and obligations of the "Chief Executive Officer" in terms of section 16(1) of the Act.
- 3.3 The Contractor shall, before commencing any work, obtain from the Procurement Manager / SHEQ Manager / Technical Manager an access certificate as in Annexure 4 executed and signed by him, permitting and limiting access to the designated site or place of work by the Contractor and any subcontractors under his control.
- 3.4 Procedural compliance with Act and Regulations, as above, shall also apply to any subcontractors as employers in their own right. The Contractor shall furnish the Procurement Manager / SHEQ

Manager / Technical Manager with full particulars of such subcontractors and shall ensure that they comply with the Act and Regulations and safety requirements and procedures.

4. Special Permits

Where special permits are required before work may be carried out such as for hot work, isolation permits, work permits and occupations, the Contractor shall apply to the Procurement Manager / SHEQ Manager / Technical Manager or the relevant authority for such permits to be issued. The Contractor shall strictly comply with the conditions and requirements pertaining to the issue of such permits.

5. Health and Safety Programme

- 5.1 The Tenderer shall, with his tender, submit a Health and Safety Programme setting out the practical arrangements and procedures to be implemented by him to ensure compliance by him with the Act and Regulations and particularly in respect of: -
 - (i) The provision, as far as is reasonably practical, of a working environment that is safe and without risk to the health of his employees and subcontractors in terms of section 8 of the Act;



- (ii) the execution of the contract work in such a manner as to ensure in terms of section 9 of the Act that persons other than those in the Contractor's employment, who may be directly affected by the contract work are not thereby exposed to hazards to their health and safety;
- (iv) ensuring, as far as is reasonably practical, in terms of section 37 of the Act that no employee or subcontractor of the Contractor does or omits to do any act which would be an offence for the Contractor to do or omit to do.
- 5.2 The Contractor's Health and Safety Programme shall be based on a risk assessment in respect of the hazards to health and safety of his employees and other persons under his control that are associated with or directly affected by the Contractor's activities in performing the contract work and shall establish precautionary measures as are reasonable and practical in protecting the safety and health of such employees and persons.
- 5.3 The Contractor shall cause a risk assessment contemplated in clause 5.2 above to be performed by a competent person, appointed in writing, before commencement of any **Construction Work** and reviewed during construction. The Risk Assessments shall form part of the Health and Safety programme to be applied on the site and shall include at least the following:
- The identification of the risks and hazards that persons may be exposed to;
- the analysis and evaluation of the hazards identified;
- a documented Health and Safety Plan, including safe work procedures to mitigate, reduce or control the risks identified;
- a monitoring and review plan.
- 5.4 The Health and Safety Plan shall include full particulars in respect of: -
- The safety management structure to be instituted on site or place of work and the names of the Contractor's health and safety representatives and members of safety committees where applicable;
- the safe working methods and procedures to be implemented to ensure the work is performed in compliance with the Act and Regulations;
- the safety equipment, devices and clothing to be made available by the Contractor to his employees;
- he site access control measures pertaining to health and safety to be implemented;
- The introduction of control measures for ensuring that the Safety Plan is maintained and monitored for the duration of the Contract.
- 5.5 The Health and Safety programme shall be subject to the Procurement Manager / SHEQ Manager / Technical Manager's approval and he may, in consultation with the Contractor, order that additional and/or supplementary practical arrangements and procedures be implemented and maintained by the Contractor or that different working methods or safety equipment be used or safety clothes be issued which, in the Procurement Manager / SHEQ Manager / Technical Manager's opinion, are necessary to ensure full compliance by the Contractor with his obligations as an employer in terms



of the Act and Regulations. The Procurement Manager / SHEQ Manager / Technical Manager or his deputy shall be allowed to attend meetings of the Contractor's safety committee as an observer.

- 5.6 The Contractor shall take reasonable steps to ensure that each subcontractor's Health and Safety Plan is implemented and maintained on the construction site: Provided that the steps taken shall include periodic audits at intervals mutually agreed to between the them, but at least once every month.
- 5.7 The Contractor shall stop any subcontractor from executing any construction work, which is not in accordance with the Contractor's, and/or subcontractor's Health and Safety Plan for the site or which poses a threat to the health and safety of persons.
- 5.8 The Contractor shall ensure that a copy of the Health and Safety Plan is available on site for inspection by an inspector, Procurement Manager / SHEQ Manager / Technical Manager, agent, subcontractor, employee, registered employee organization, health and safety representative or any member of the health and safety committee.
- 5.9 The Contractor shall consult with the health and safety committee or, if no health and safety committee exists, with a representative group of employees, on the development, monitoring and review of the Risk Assessment.
- 5.10 The Contractor shall ensure that all employees under his control are informed, instructed and trained by a competent person regarding any hazard and the related work procedures before any work commences, and thereafter at such times as may be determined in the Risk Assessment.
- 5.11 The Contractor shall ensure that all subcontractors are informed regarding any hazard as stipulated in the Risk Assessment before any work commences, and thereafter at such times as may be determined in the Risk Assessment.
- 5.12 The Contractor shall ensure that all visitors to a construction site undergoes health and safety induction pertaining to the hazards prevalent on the site and shall be provided with the necessary personal protective equipment.

6. Fall Protection Plan

- 6.1 In the event of the risk and hazard identification, as required in terms of clause 5.3 of this Specification, revealing risks relating to working from an elevated position the contractor shall cause the designation of a competent person, responsible for the preparation of a fall protection plan;
- 6.2 The Contractor shall implement, maintain and monitor the fall protection plan for the duration of Contract. The Contractor shall also take such steps to ensure the continued adherence to the fall protection plan.
- 6.3 The fall protection plan shall include: -
 - A Risk Assessment of all work carried out from an elevated position;
 - The procedures and methods to address all the identified risks per location;
 - The evaluation of the employees' physical and psychological fitness necessary to work at elevated positions;



- The training of employees working from elevated positions; and
- The procedure addressing the inspection, testing and maintenance of all fall protection equipment.

7. Hazards and Potential Hazardous Situations

The Contractor and the Procurement Manager / SHEQ Manager / Technical Manager shall immediately notify one another of any hazardous or potentially hazardous situations which may arise during performance of the Contract by the Contractor or any subcontractor and, in particular, of such hazards as may be caused by the design, execution and/or location and any other aspect pertaining to the contract work.

8. Health and Safety File

- 8.1 The Contractor shall ensure that a health and safety file is opened and kept on site and shall include all documentation required as per the Act and applicable regulations, and made available to an inspector, the Procurement Manager / SHEQ Manager / Technical Manager, or subcontractor upon request.
- 8.2 The Contractor shall ensure that a copy of the both his Health and Safety Plan as well as any subcontractor's Health and Safety Plan is available on request to an employee, inspector, contractor or the Procurement Manager / SHEQ Manager / Technical Manager.
- 8.3 The Contractor shall hand over a consolidated health and safety file to the Procurement Manager / SHEQ Manager / Technical Manager upon completion of the **Works** and shall in addition to documentation mentioned in the Act and applicable Regulations include a record of all drawings, designs, materials used and other similar information concerning the completed structure.

HSE philosophy

Inherent safety and protection of the environment is a prerequisite from the beginning of the design process. The HSE philosophy must be included in the design premise document, and should include considerations on waste reduction, minimisation of fugitive emissions, ground water pollution prevention, minimisation of manning levels for hazardous processes, hazardous materials handling, early detection systems and specific measures to reduce risks to ALARP levels.

Risk analysis

The risk analysis at pre-feasibility and feasibility level is expected to be qualitative and progress to a quantitative technique at the FEED level. There may however be some need for quantitative information in the feasibility phase to support the EIA. The analysis of risks includes those risks to human life, environment and material assets. The results of the risk analysis need to be compared to



an agreed risk acceptance criteria and necessary risk reducing measures will be identified and implemented (e.g. detection and early warning systems etc).

Hazard identification study

A systematic evaluation of all hazards shall be performed in the hazard study. The hazard study is the basis for the area classification drawings and may alter the location of for example buildings, process units on the plot plan or may lead to additional preventive measures (firewalls, other material types etc) being required.
