**1 Agreement**

**2 Completion of Bid Documents**

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

**3 Alteration or Qualification of Bid**

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

**4 Authorised Signatory**

- (a) *A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.*
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

**5 Submission of Bid**

**1.Scope of work:**

Scheduled Inspections & Routine Maintenance

Standby electrical generator sets and UPS's ,situated within Garden Route District Municipality needs to be inspected test run and maintained at regular quarterly intervals to ensure that they will perform properly, when required, to supply emergency power during mains failure.

**2.Call Outs**

In addition, a 24 hour local call out specialist service is required to attend to generator sets and UPS's which fail to start or to perform properly when needed.

To connect generators as and when needed for the following and specify hourly rate for each;

- 200Kva
- 160kva

Provide rates for adhoc hire of the above generators for emergency purposes as and when needed.

**3. Repairs**

A speedy repair service, either on site or by means of an exchange unit, shall be offered to take care breakdowns,

**4. Tender Rates**

**The contractor shall regularly inspect each generator/UPS site on a 3monthly basis, by arrangement with the Municipal staff in charge, and do the following:**

- Complete the plant logbook specifying dates of visit, test done adjustments made, oil and parts used, defects noted and whether repaired, and any other relevant information.
- Clean the plant as necessary
- Lubricate moving parts as necessary
- Check all filters and where necessary, clean filters and replace filter oil or alternatively, change filter elements.
- Check lubrication oil level and top up if necessary
