

# TERMS OF REFERENCE FOR THE APPOINTMENT OF SERVICE PROVIDER TO CONDUCT COBIT PROCESS MATURITY ASSESSMENT

## 1. Executive Summary

The South African Maritime Safety Authority (SAMSA) seeks to appoint a competent service provider for the provisioning of COBIT process assessment on the identified COBIT processes.

Service provider must have relevant certification such as:

- COBIT Implementor.
- COBIT Assessor.
- CISA.
- CGEIT.
- CRISC.

The service provider is expected to possess relevant skills, experience, and capacity to deliver on the scope of work within the required time frame.

The Public Service Corporate Governance of Information and Communication Technology Policy Framework (CGICTPF) forms the basis of SAMSA's ICT Governance Framework. that prioritises 12 (twelve) COBIT processes. Over and above the prioritised processes, SAMSA added an additional process to focus on thirteen (13) processes to ensure optimal governance of information and technology.

The maturity assessment of the prioritised processes is critical to determine the current level of maturity with the development plan to address any identified deficiencies and indicate areas for improvement.

2.1. SAMSA seeks to appoint a service provider for the provisioning of COBIT 2019 process maturity assessment on the identified and prioritised processes including development of maturity development roadmap.

- 3.1.7. Structure and frequency of the reports during the project.
- 3.1.8. Assist in deepening awareness of ICT Governance within SAMSA and the COBIT processes supporting the SAMSA ICT Governance Framework.
- 3.1.9. Presentation of the final report to the Executive Committee and the applicable Board Committees.

- 3.2.1. Proposal on the implementation of the adopted COBIT Process maturity assessment recommendations.
