#### 1. INTRODUCTION

The City of Tshwane is seeking service providers to submit bids for the supply, delivery, offloading and assembling of anti-illegal dumping signs. This is a citywide supply of anti-Illegal dumping signs at Waste Management depots which are in various regions. The City reserves the right to appoint more than one supplier.

#### 2. BACKGROUND

The City has in the recent years been experiencing increasing amounts of waste being dumped unlawfully, thereby calling for a more effective way of controlling and eliminating this social challenge. Combating and eliminating the unlawful dumping of waste is a key priority for the city because of its negative impact to the environment and human health. In addressing this problem, the city's anti-dumping and prevention strategy entails amongst others rehabilitation of sites and erection of anti-dumping signage to deter continued dumping of waste.

#### 3. PROJECT SCOPE

The prospective suppliers are expected to supply, deliver, offload and assemble anti-illegal dumping signs at the City's waste management depot in the 7 regions of the City.

The anti-illegal dumping signs deter the continued dumping of waste at a rehabilitated illegal dumping hotspot.

#### 9 MARKET ANALYSIS

The City of Tshwane reserves the right to conduct a market analysis. Should the City exercise this option, where a bidder offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the bidder to seek confirmation of whether the bidder will be disqualified based on being non-responsive.

If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the service provider to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a bidder scoring the highest points. If the bidder does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the bidder scoring the second highest points, if the bidder the second highest points does not agree to a market-related price, the City will negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the City reserves the right to cancel the quotation.
