1. TERMS OF REFERENCE

1.1. INTRODUCTION AND BACKGROUND

1.1.1. The Safety and Security Sector Education and Training Authority (SASSETA) is one of the twenty-one Sector Education and Training Authorities (SETAs) established in terms of the Skills Development Act (Act 97 of 1998) as amended. SASSETA's licence has been renewed until 31st March 2030. SASSETA is classified as a schedule 3A Public Entity in terms of the Public Finance Management Act, (Act 1 of 1999, as amended). SASSETA reports to the Department of Higher Education and Training.

1.2. PURPOSE

1.2.1. SASSETA requires to procure the services of a suitable and experienced training provider to capacitate twenty-five (25) staff members as the Occupational Health and Safety Representatives, Fire Marshalls, and First Aiders.

1.3. SCOPE OF WORK

1.3.1. The service provider will be required to deliver Occupational Health and Safety training in line with the Regulations and the Occupational Health and Safety Act.

1.3.2. The Occupational Health and Safety training should include, but not limited to the following topics:

- 1.3.3.1 SHE Representatives: two (2) days face-to-face training
- 1.3.3.2 First Aid Level 1 to 3: five (5) days face-to-face training
- 1.3.3.3 Basic Fire Fighting: two (2) days face-to-face training

1.3.3. Prepare training manuals which shall serve as future reference documents.

1.3.4. Issue the relevant certificate in Occupational Health and Safety to employees after the completion of training.

1.3.5. Services shall be used as and when required for the duration of the contract and payment shall be as per services rendered.

1.4. SKILLS AND EXPERIENCE OF THE BIDDING COMPANY AND THE TEAM MEMBERS PROPOSED FOR THE ASSIGNMENT

1.4.1 The service provider must:

1.4.1.1 Have a Facilitator with three (3) or more assignments in conducting training on Occupational Health and Safety, Fire Marshalls, and First Aiders Representatives. **A detailed CV must be attached.**

1.4.1.2 Submit three (3) or more signed reference letters from different clients for each completed assignment in conducting training on Occupational Health and Safety, Fire Marshalls, and First Aiders. Reference letters must be on the client's letterhead, signed, and

clearly detailing the scope of work, duration, and impression the client has with the service provider.

1.5. SUBMISSION REQUIREMENTS

- 1.5.1. The service provider should be registered with the **South African Institute of Occupational Safety and Health (SAIOSH)** or any other registered professional Body.

NB: Failure to submit SAIOSH Certificate or proof of membership from any other registered professional Body will lead to automatic disqualification.

- 1.5.2. The service provider should be accredited by the **Health and Welfare Sector Education and Training Authority (HWSETA), Services Seta (SSETA)** or by any other Accredited Training Authorities.

NB: Failure to submit an Accreditation Training Certificate from HWSETA, SSETA or from any other Accredited Training Authority will lead to automatic disqualification

1.6. TIMEFRAMES FOR THE DELIVERY OF THE WORK

- 1.6.1 The contract will be effective from the date of appointment until 31 December 2027.

1.7. PRICING

- 1.7.1. Service Providers are requested to provide an all-inclusive cost of this project assignment on SBD 3.3.
- 1.7.2. Where the contract requires the successful bidder to travel to a venue different from SASSETA, the following travel and disbursement processes will be undertaken:
 - 1.7.2.1. Claim travel mileage costs applicable to this contract as per the Department of Transport rates.
 - 1.7.2.2. Book only economy-class flights
 - 1.7.2.3. Book Group A hire cars, otherwise, Group B is to be used for Service Providers outside of Gauteng.
 - 1.7.2.4. Utilise cost-effective modes of transport such as Uber/Taxify/Gautrain or shuttle services when traveling to and from the airport.
 - 1.7.2.5. Book only Bed and Breakfast, Hotels, or other equivalent accommodations up to a Rand value of R1 400/ three (3) Star per night per person (including dinner, breakfast, and parking).
 - 1.7.2.6. Submit all applicable invoices/receipts for the travel undertaken and a Google map of the trip where travel by private car was undertaken for payment.
 - 1.7.2.7. All travel is to be approved by SASSETA before being undertaken.

1.8. ACCOUNTABILITY AND REPORTING

- 1.8.1 The service provider will report directly to the Auxiliary Practitioner for the duration of the contract.

1.9. CONDITIONS OF CONTRACT (GCC) (ANNEXURE A)

1.9.1. Bidders are requested to initial each page of the General Conditions of Contract (GCC) (Annexure A) and submit their response to this Request for Quotations. The GCC will form part of the contract with the successful Bidder.

1.10. INTELLECTUAL PROPERTY

1.10.1. The service provider will be contracting with SASSETA. All products and data of this project, in whatever format raw or analyzed, will be confidential information for utilization by SASSETA. All information and documents, received from SASSETA or stakeholders, is to be kept confidential and may not be used or distributed in any format without the written approval of SASSETA. To this end, the service provider will be required to sign a confidentiality agreement within the Contract.

1.11 PROTECTION OF PERSONAL INFORMATION ACT
