1. PURPOSE

The purpose of this RFQ is to appoint a service provider to conduct an analysis of the socio-economic benefits of the contractual / co-management agreements signed by SANParks

2. INTRODUCTION

Protected Areas are well-defined geographical spaces that are recognized, dedicated, and managed through legal or other effective means to ensure the long-term conservation of nature, along with its associated ecosystem services and cultural values. They provide essential solutions to some of the most pressing global challenges, including climate change, species extinction, water scarcity, food insecurity, and poverty. These areas serve as safe havens for endangered species, help store carbon and generate a significant portion of our clean air and water. They also encompass sites of cultural and spiritual importance and support the livelihoods of millions of people.

Historically, local communities were often evicted from their lands to create Protected Areas around the world. In some instances, indigenous peoples have lost access to resources without being physically removed from their locations. The eviction of local communities involves the violation of several interconnected human rights. These include the right to property, the right to culture, the right to food and natural resources, the right to health, and the right to economic, social, and cultural development.

A new era of PAs Management began when South Africa became a democracy in 1994. Post-apartheid government in South Africa drafted a new constitution to establish a democratic society based on human rights and social justice. To address the injustice of the past, Section 25(7) of the Constitution of Republic of South Africa state that a person or community dispossessed of property after 19 June 1913 because of past racially discriminatory laws or practices is entitled to restitution or equitable redress. Restitution of Land Rights Act (RLRA) empowers the Minister to make awards to restitution claimants where he/she is satisfied that there is a valid restitution claim, by restoring the lost land, awarding alternative land at state expense, and awarding financial compensation or other appropriate relief.

Land claims in South Africa also affected Protected Areas including National Parks. According to Cabinet Memorandum number 5 of 2002, restoration for claims against PAs could be made feasible through the transfer of title without settlement rights and the transfer of title coupled with registered notarial deed restrictions on the use of the land in terms of settlement of land claims within PAs. The Cabinet Memorandum emphasised that sustainable partnerships between claimants and managers of the PAs must be established to achieve effective biodiversity conservation of the area, including economic viability, holistic and coherent management. In addition, the Cabinet Memorandum, state that in the settlement of land claims, economic benefits for claimant community could include a partial financial pay-out to claimants in lieu of opportunity costs which include a percentage of the annual gross turnover generated by commercial activities and a certain portion of land excised for grazing or agricultural purposes, conditional upon an Environmental Impact Assessment (EIA) legislation and policy. To give effect to Cabinet Memorandum number 5 of 2002, the National Environmental Management: Protected Areas Act (Act 57 of 2003) was passed by parliament, which provides for the co-management of protected areas between the management authority and the land claimants. In case of South Africa National Parks, the arrangements were in a form of contractual agreements.

The contractual agreements were signed with the following historical landowners:

- Maluleke CPA at Kruger National Park
- SAN and Mier Community at Kgalagadi National Park; and
- Richtersveld RGBK at Richtersveld National Park.

3. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

4. SCOPE OF WORK

The service provider is required to conduct the impact assessment on the effectiveness of the post land claims settlement programme implemented in the three communities viz; Makuleke, SAN and Mier; and Richtersveld in respect to but not limited to the following;

- The compliance of SANParks to the settlement and beneficiation agreement signed
- Effectiveness of governance structures established (Joint Management Boards)
- % Equity sharing with historic landowners in commercial opportunities created
- The economic benefits that accrued to historic landowners
- Other opportunities for entrepreneurship created
- Jobs created (direct and indirect);
- Capacity building, including professional and technical skills transferred and other educational opportunities created.
- Infrastructure investments and improvement in services furthering historic Landowners
- Increased awareness and education of environmental issues;
- Access rights granted for cultural and spiritual rights; and
- Other community social initiatives.

The objectives of the study are:

- To examine the socio-economic impacts of the post settlement programme implemented with particular reference to the three communities of Makuleke, SAN and Mier and Richtersveld; by exploring the alignment of the programme to the settlement and co-management agreements signed, and how these have benefitted these historical landowners.
- To identify the challenges related to the implementation of settlement and co-management agreements and remedies thereof.
- To produce a comprehensive set of recommendations for SANParks for improving the flow of benefits to the land claimants and minimise negative impacts.
- The recommendations should outline approaches for leveraging on potential opportunities to maximise benefit flow to historic landowners without compromising the sustainability of national parks, drawing from international and local case studies as well as lessons learned within the context of SANParks and other similar protected areas.
- To propose a framework for the ongoing monitoring and evaluation of benefit flow.

DELIVERABLES

The final deliverables should be:

- A comprehensive report on the impact assessment of the socio-economic benefits accrued to historical landowners flowing from the settlement and co-management agreements signed with SANParks, also including the challenges.
- The report to contain selected relevant case studies on the settlement programme in protected areas that have successfully maximised socio-economic benefits to historical landowners and key lessons learnt.
- A report offering a set of actionable recommendations to maximise the flow of socio-economic benefits and minimise negative impacts of land claims on historical landowners
- A report on the monitoring and evaluation mechanisms ensuring effective implementation of the land claims programme in SANParks

MEETINGS AND / OR REPORTING

The successful bidder will report to and work closely with the Socio- Economic Transformation Division and the Land Claims Unit as well as the head: Socio-Economic Transformation as and when necessary.

The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination. 15.2. This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC. 15.3. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

	15.4. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser. 15.5. If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights, which the purchaser may have against the supplier under the contract.
GCC16	16. Payment
	16.1. The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC. 16.2. The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract. 16.3. Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier. 16.4. Payment will be made in Rand unless otherwise stipulated in SCC
GCC17	17. Prices
	17.1. Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
GCC18	18. Contract amendment
	18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

GCC19	19. Assignment
	19.1. The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
GCC20	20. Subcontract
	20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract
GCC21	21. Delays in supplier's performance
	21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract. 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract. 21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority. 21.4. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

	21.5. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties. 21.6. Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.
GCC22	22. Penalties
	22.1. Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.
GCC23	23. Termination for default
	23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part: 23.1.1. If the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2; 23.1.2. If the Supplier fails to perform any other obligation(s) under the contract; or 23.1.3. If the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

	23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated. 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years. 23.4. If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier. 23.5. Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated. 23.6. If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information: 23.6.1. The name and address of the supplier and / or person restricted by the purchaser; 23.6.2. The date of commencement of the restriction 23.6.3. The period of restriction; and 23.6.4. The reasons for the restriction. These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice
