The uMgungundlovu District Municipality seeks Professional Engineering Consulting Services entities to form a panel of Engineers in accordance with the Engineering Council of South Africa (ECSA), i.e., Guideline for Services and Processes for Estimating Fees for Persons Registered in terms of the Engineering Professions, for a period of three years.

Non-attendance at the Compulsory Briefing Session will render any submission invalid. **Please note that late comers will not be permitted to join the briefing session.**

Tender submissions must be properly bound and must be placed in the tender box situated on the ground floor of the uMgungundlovu District Municipality, 242 Langalibalele Street, Pietermaritzburg, before **12H00 on 19 June 2025**, in a sealed envelope which is clearly marked with the Tender Number and Tender Description. Late quotations or Tenders received by way of Facsimile or E-Mail will under no circumstances be considered.

Tenderers will be evaluated in terms of functionality as part of the minimum requirements before evaluated on price and preference based on the following criteria:

- Bidders must have <u>specific experience</u>, i.e., Professional Engineering Consulting Services and submit: a minimum of three (3) recent references awarded within the past 5 years; with a minimum project value of R 1 500,000.00 per reference letter for state entities.
- Tenderers must be registered with CESA (Consulting Engineers South Africa) or SABTACO
