1. INTRODUCTION AND PURPOSE

Environmental Management Inspectors (EMI's), responsible for environmental compliance and enforcement, has a uniform identify throughout the country and are required to wear prescribed uniform when carrying out their duties. These duties also require the use of specialised protective clothing as EMI's often work in industrial/hazardous environment, as well as baseline equipment.

The purpose of this bid is to obtain a quotation to appoint a service provider for supply and delivery of EMI branded uniform to the Environment and Agriculture Management Department (EAMD).

2. BACKGROUND

The Group Head for EAMD has identified the building of a common identity and a uniform approach to environmental compliance work as important for improving the impact of the EMI within the (City of Tshwane).

In terms of the EMIs code of conduct all inspectors are required to wear full uniform, particularly when carrying out compliance and enforcement duties and when attending meetings. Currently, EMIs have limited uniform to carry out compliance and enforcement duties.



Furthermore, in accordance with the Occupational Health and Safety Act, 1993 (Act 85 of 1993), the employer must provide and maintain a safe and healthy work environment. Controlling a hazard at its source is the best way to protect employees, but if it is not reasonably practicable to eliminate or mitigate a foreseeable or potential risk, the employer must control the risk or exposure. When




engineering controls, work practices and administrative controls are not feasible or do not provide enough protection, employers must provide personal protective equipment to their employees and make sure that it is correctly used and maintained.





3. PROJECT SCOPE





This request is for quotations to supply and deliver EMI branded uniform, to the Environment and Agriculture Management Department on a once-off basis.

CERTIFICATE OF INDEPENDENT BID DETERMINATION
