INTRODUCTION TO SANParks

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

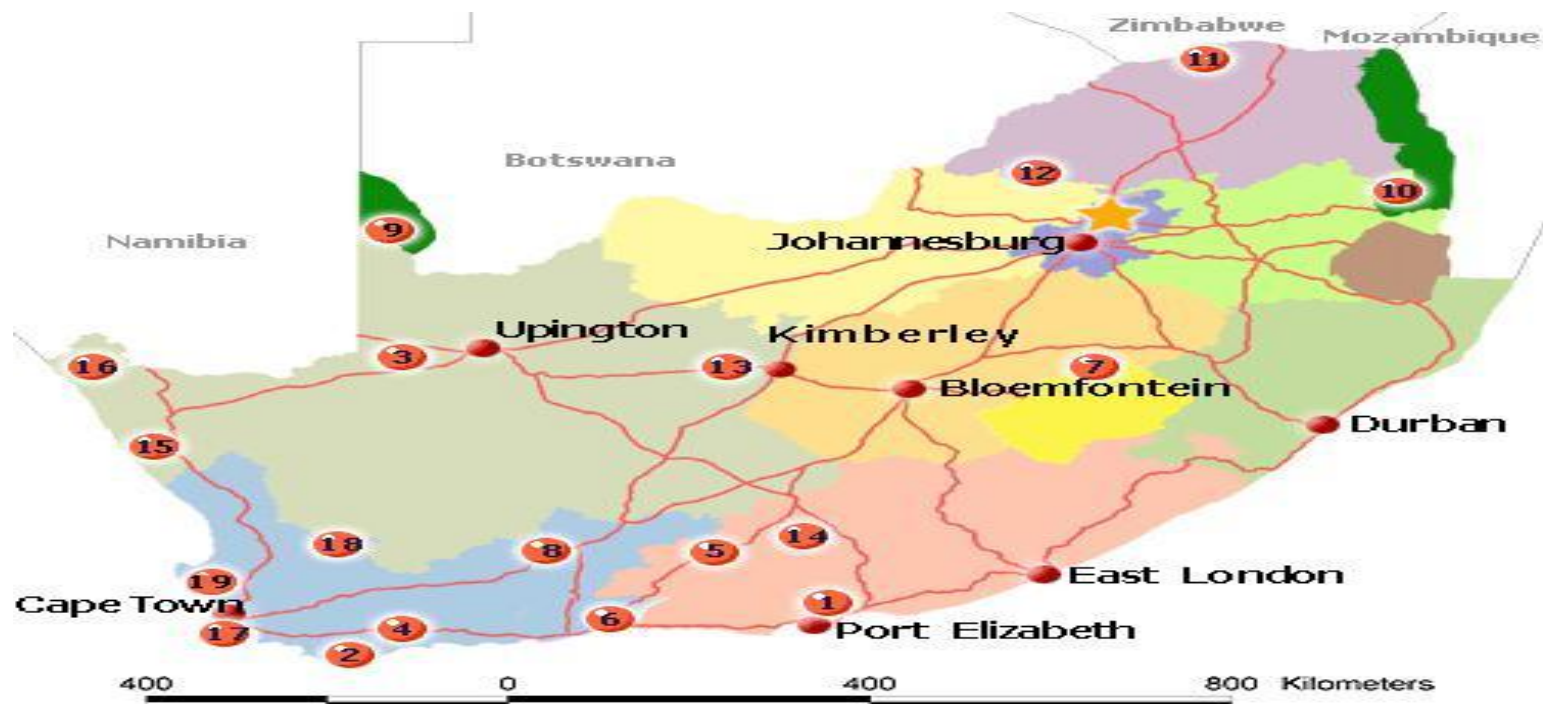
Our vision is a future where people and nature thrive together in sustainable mega living landscapes.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System.

Our mission is to conserve, expand and sustainably manage South Africa's natural and cultural assets, for the well-being of present and future generations, through innovation and inclusive partnerships with communities.

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

The Corporate Communications Department is responsible for reputation and brand management as well as the promotion of a collaborative and partnership approach to stakeholder engagement and relations as well as advocacy of organisational campaigns.

CONTEXT OF THIS PROCUREMENT

SANParks is a globally recognised and respected corporate brand responsible for managing South Africa's national parks, conserving the country's biodiversity, landscapes, and cultural heritage. SANParks oversees 22 national parks, including well-known ones like Kruger National Park and Table Mountain National Park, covering over 4 million hectares. Its mission includes promoting sustainable tourism, supporting local communities, and ensuring responsible conservation practices. Its operations generate significant revenue through ecotourism while fostering biodiversity and community development.

Managing 70% of South Africa's conservation estate; SANParks is the largest and leading entity mandated to conserve the biodiversity and cultural heritage of the country. As such, it is imperative that it maintains an impeccable reputation record at all times.

SANParks enjoys overall favourable media ratings, but it is occasionally subjected to occurrences that threaten its reputation and credibility amongst its key stakeholders.

It is within this context that SANParks is seeking the services of a professional strategic communications and public relations agency with global reach that can provide it with sound strategic support, counsel, and advice.

CONTRACT PERIOD

The contract period commences from the date that both parties sign the contract's signature page. The contract will be for a period of thirty-six (36) months.

The service provider will be provided with a verbal brief regarding the issue/s that will be responded to in the proposals.

SPECIFICATIONS/SCOPE OF WORK

SANParks is seeking the services of a professional strategic communications agency with national and global reach to provide SANParks with sound strategic counsel and advice, media (traditional and new) and stakeholder relations for the protection and growth of the organisation's reputation and its corporate brand.

The scope of work includes strategic counsel, crisis management, stakeholder management, media relations, monitoring, analysis and subsequent content generation in relation to the issue/s at hand.

It is expected of the service providers to submit their proposals, including costing thereof, regarding their approach to managing issues.

As part of their proposal, the service provider must demonstrate:

- Experience working with government and corporates on communication and crises that have national, international, and political implications;
- Experience of working with listed companies either locally or internationally on major reputational management issues with demonstrable success.
- Experience of working with state-owned entities on major reputational management issues with demonstrable success.
- A presence in South Africa and internationally (the international footprint could be through associates).
- Experience in employee engagement with regard to major reputational management issues.
- Experience in stakeholder engagement with regard to major reputational management issues.

The appointed service provider must undertake activities detailed below:

- Provide strategic communication, advocacy as well as stakeholder relations support and advice at executive level. This will include to the Board, Chief Executive Officer, Head of Communications and Spokesperson, and Executive Committee.
- Establish a SANParks-aligned strategic communication framework that ensures a structured approach to planning, execution and evaluation to ensure clarity, coherence and measurable impact.
- Draft proactive stakeholder engagement, communication, and marketing solutions and plans as and when required.
- Develop and implement a stakeholder segmentation and engagement solution.
- Develop and maintain frequently updated storyboards and key message sheets that supports message alignment, audience engagement, cross-channel planning, and crisis communication incidents.

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
