### **BID SUBMISSION:**

- Bids must be submitted by the stipulated time to the email address stipulated above. Late bids will not be accepted for consideration.
- All bids must be submitted on the official forms provided (not to be re-typed) or in the manner prescribed in the bid document.
- No bids will be considered from persons in the service of the state, companies with directors who are persons in the service of the state, or close corporations with members / persons in the service of the state."
- Rand Water will provide any clarifications / addenda / extension of closing date by no later than one (1) calendar

day before the closing date.

### 1. SCOPE OF WORK

### 1.1. **DESCRIPTION**

Rand Water requires an ISO 17025 accredited laboratory to conduct analyses for all SANS 241:2015 determinands (41 parameters, indicated in table below) and additional 4 parameters (calcium, hardness, magnesium and potassium) monthly for 12 consecutive months. Of the five samples taken per month, one sample will be monitored for cryptosporidium and giardia, this will be the furthest sample point.

Duplicate samples will be taken by Rand Water and the successful laboratory on the same day. Each lab will analyse the samples and the results of both laboratories will be sent to Rand Water..

The objective of the work is to conduct sampling in Rand Water's distribution sampling points, analyse for all SANS 241:2015 determinands and four additional determinands (45 parameters) and provide a report monthly for twelve (12) months.

The scope of work is as follows:

The scope of work includes sampling, conducting field (free chlorine and monochloramine measurements) and laboratory analyses, monthly reporting, and an unbiased opinion regarding the quality of the water supplied by Rand Water as measured against the SANS 241 drinking water standard.

All samplers are to meet at Rand Water (Zwartkopjes – approximately 10km from Rand Water's Head Office - 522 Impala Road, Glenvista) on the day of sampling at 6:00am. Rand Water sampling vehicles will be used to go to all the sampling sites. Rand Water will prepare the sampling bottles for both laboratories. Samplers from both laboratories will test for free chlorine and monochloramine onsite during sampling using their respective field instruments. Respondents should therefore have their own field instruments for measuring free and monochloramine onsite. Rand Water will not sample and submit samples to the lab, rather the appointed laboratory samplers will go and sample with Rand Water samplers on the day of sampling. Rand Water will provide sample bottles, the samplers need to bring cooler boxes to transport the samples to their laboratory after sampling.

This work is for a twelve months' period, five samples per month, measuring all SANS241:2015 determinands (see table below for determinands). Cryptosporidium and giardia are to be monitored on only one sample per month (not 5 samples as per the other determinands).

Sample points are to be selected by the successful laboratory randomly in Rand Water's distribution network ensuring that proper representation is achieved throughout the twelve month's period. Rand Water will provide the list and locations of sample points and assist where necessary.

The flow of work will be as follows:

The identified credible and SANAS ISO 17025 accredited laboratory will meet with Rand Water for a kick off meeting.

Rand Water will provide a list of sample points and locations to the successful service provider (SANAS ISO 17025 accredited laboratory)

Identified credible and SANAS ISO 17025 accredited laboratory will select 5 sample points with consultation from Rand Water each month. A list of the selected points will be sent to Rand Water for approval and

alternative sample points will be offered where necessary. During the 12 months cycle no sample can be sampled / tested more than once. Rand Water sample points are in areas indicated in the table below. The furthest sample point is approximately 200 km from the Rand Water meeting point (Rand Water Zwartkopjes). The service provider must take this into account and ensure that the microbiological and other samples are taken, stored properly, and analysed within acceptable time.

Sampling and testing will be conducted on an agreed date by Rand Water and the identified credible and SANAS accredited laboratory using SANAS accredited methods.

The service provider and Rand Water personnel will conduct field analyses (free chlorine and monochloramine) in the field during sampling using approved method, competent samplers, and calibrated instruments.

The service provider will transport the samples in an appropriate vehicle (closed car / closed bakkie) that can fit sample cooler boxes. Samples must be stored in cooler boxes, for microbiological samples ice packs must be used.

The identified laboratory will communicate the results via a report with Rand Water within 14 working days' turnaround times. This excludes results for protozoa (cryptosporidium and giardia). The final analyses report should be signed off by the designated technical signatory. Results that do not comply with SANS 241 requirements should be confirmed (re-tested) except for microbiological analyses. Where Rand Water's results and that of the external laboratory significantly differ, both labs will be required to analyse the sample again to confirm the results. The reanalyses samples will be collected and delivered by Rand Water's WQSS personnel.

If the 14 days' turnaround times cannot be met for whatever reason, the identified laboratory shall communicate this to Rand Water in writing and provide reasons for deviations and a reasonable alternate date for submission of results.

### SUMMARY OF EVENTS

- Selection of sample points and sampling date: Service provider to communicate with Rand Water
  - Each month a route to be selected i.e. East, West etc.
  - Check proximity of selected samples to each other Rand Water to assist
- 2. On sampling day: samplers meet at Rand Water Zwartkopjes at 6:00 am
- 3. Rand Water to provide sample bottles, these will be the same bottles used by Rand Water (these must be returned on the day of next sampling)
- 4. Rand Water and service provider sampler drive to the sampling points in a Rand Water vehicle
- 5. At each sampling point samplers conduct free chlorine and monochloramine measurements and collect samples
- 6. Samplers drive form the sampling points back to Rand Water Zwartkopjes, service provider transfers their samples to their car and drive to own laboratory. Rand Water samplers drive to Rand Water laboratory to deliver the samples
- 7. At the laboratory: All five samples are tested for all parameters EXCEPT for cryptosporidium and giardia. Only one sample (the furthest sample point) will be tested for cryptosporidium and giardia.

- 8. Laboratory to email a report within 14 days' turnaround time.
- Laboratory to resolve any Rand Water queries regarding the results within reasonable time.

### EXPLANATION OF EVALUATION CRITERIA / RETURNABLES

### Previous Related Experience

This aspect seeks to understand if the company has performed the similar scope of work before and is assessed on the following dimensions:

  - NB: Relevant means have conducted drinking water quality analyses for SANS 241 determinands.

Human Resource Capacity (Qualification and experience dimensions).

The purpose is to establish an overall picture of the company's human resource capacity and ability to undertake the work. This criterion is looking at the field work and laboratory work dimensions:

- 1. Field work capacity
- Competent (qualification and experience) samplers / field technicians to take samples
- Samplers / field technicians competent in conducting field analysis (free chlorine, monochloramine, and total chlorine).
- 2. Laboratory work capacity
- Competent (qualification and experience) analysts to conduct all analysis (microbiological, physical and chemical analyses). This is taken care of by SANAS accreditation. In cases where the method is not accredited i.e. chlorine method: a calibration / verification certificate must be provided
- Number of analysts: this gives an indication on whether the respondent can conduct work within required time and has analyst who can perform all types of analyses (microbiological and chemical).
- For how long has the company been conducting these analyses
- 3. For outsourced analysis:

- Field analyses work equipment same as above for in-house analyses

### 2. AWARDING STRATEGY

The maximum number of suppliers to be awarded this RFQ is 1.

### 3. EVALUATION CRITERIA

The RFQ will be evaluated based on the criterion below:

### 3.1. Test for Responsiveness/ Pre- qualification

The respondent must be a SANAS - ISO 17025 accredited laboratory with SANAS - ISO 17025 accredited methods.

Must provide proof of laboratory accreditation and proof of all ISO 17025 accredited methods. 70% of SANS 241 methods must be accredited.

For non - ISO 17025 accredited methods: proof of good laboratory practice examples can be: method used by the laboratory (laboratory developed or use of standard method) OR participation in PTS schemes with acceptable Z-scores OR intra-laboratory comparisons OR method validation documents etc. must be provided.

Respondents must be accredited laboratories only, IF subcontracting, subcontracting can be to ONLY TWO laboratories that are ISO 17025 accredited HOWEVER, the respondent must conduct more analyses in-house (60% or more of the analyses or determinands outlined in this document).

Competency in conducting drinking water sampling and field analyses (free chlorine and monochloramine): Proof = sampling method and field instrument used: For field instruments proof can be: instrument manual for field testing or procedure used.

Responses that fail to meet pre-qualifying criteria stipulated will not be further evaluated.

The delivery time or date stated in the Purchase Order shall be regarded as fixed and the Supplier shall adhere strictly thereto. Rand Water reserves the right to cancel any order issued if delivery is not made as agreed and the Supplier will not be entitled to any cancellation fees

### 5.4. PURCHASE ORDER

- In terms of this order Rand Water undertakes to procure, 5.4.1. and the Supplier undertakes to supply the products and/or services as contained on the Purchase Order. This however, does not prohibit Rand Water to procure additional products/services, and or to procure the same/similar products/services, from any other Supplier.
- 5.4.2. The Purchase Order number stated in the Order shall be indicated clearly on all documentation to be issued by either party to the other.

### 5.5. CANCELLATION OF ORDER

- Should the Supplier fail to deliver the goods at the time agreed to, or should it not comply with any other essential condition of the Purchase Order, Rand Water shall be entitled in writing to cancel the Purchase Order, without any adverse cost implications for Rand Water
- 5.5.2. The aforesaid cancellation shall not prevent Rand Water from exercising any of its rights available in terms of the Purchase Order.

### 5.6. DISPATCH OF SUPPLIES

Rand Water shall not be responsible for any risk in and to the goods before delivery of such goods has taken place.

## 5.7. SPECIFICATIONS

- The Supplier shall ensure that the service to be rendered 5.7.1. shall in all respects be in accordance with the requirements and stipulations set out in the Purchase Order. All materials and consumable items if applicable shall be new and unused, unless otherwise agreed to in writing.
- Rand Water shall be entitled to return any goods with 5.7.2. defects or deviations from the agreed specification within 7 days after date of delivery and will not be liable for any cost.

### 5.8. **GUARANTEE**

Save for consumables, the Supplier guarantees the workmanship and materials and any components thereof will be free of any defects for a period of at least 12 (twelve) months after the acceptance thereof by Rand Water, reasonable wear and tear will be accepted.

### 5.9. PAYMENT

### 5.12. FORCE MAJEURE

Any Force Majeure event experienced by the Supplier that is likely to affect the timeous delivery of any items on the Purchase Order shall be communicated to Rand Water in writing within forty-eight (48) hours of the Supplier becoming aware of such circumstance. Force Majeure event means:

- a. natural disasters
- b. war, act of foreign enemies
- riot, civil commotion
- d. strike, lockout, other labour disturbance (including those involving the Supplier's employees) or

any other circumstances beyond the control of the Supplier and which in the absence of this paragraph will operate to frustrate the timeous delivery of the item and/or service.

#### 5 13 WARRANTY

- The Supplier warrants that all goods and Services supplied under this Purchase Order will be in accordance with all contract requirements 5 13 1 and free from defects or inferior materials, equipment, and workmanship for twelve (12) months after final acceptance of the goods
- If Rand Water finds the warranted goods or Services need to be repaired, changed or re-performed, Rand Water shall so inform the Supplier in writing and the Supplier shall promptly and without expense to Rand Water replace or satisfactorily correct the goods or Services. 5.13.2.
- 5.13.3. Any goods, services or parts thereof so corrected, shall also be subject to the provisions of this Clause, and the warranties for such goods, Services or part thereof shall be for twelve (12) months from the date of Rand Water's final acceptance of such corrected goods or Services. 5.13.4.
- The Supplier further warrants the goods/services will meet and are suitable for the purpose intended. These warranties shall survive inspection, acceptance, and payment. Goods/services that do not conform to the above warranties may, at any time within 12 months after delivery to Rand Water, be rejected and returned to the Supplier, and if Rand Water has incurred any expenses as a result thereof, Rand Water will be entitled to recover same from the Supplier.

### 5.14. TERMINATION FOR CONVENIENCE

Rand Water reserves the right, at any time, in its own best interest, and without liability, to terminate a Purchase Order in whole or in part, by written notice of termination for convenience to the Supplier. If the Purchase Order is so terminated, then, within thirty (30) days following the Supplier's receipt of the termination notice, the Supplier shall submit a claim for equitable adjustment. If the termination involves only services, Rand Water shall be obligated to pay only for services performed satisfactorily before the termination date.

### 5.15. TERMINATION FOR DEFAULT

Rand Water may, without liability, and in addition to any other rights or remedies provided herein or by law, terminate a Purchase Order in whole or in part by written notice of default if the Supplier:

- fails to deliver in terms of the Purchase Order or perform the services within the time specified;
- fails to make sufficient progress with the work, thereby endangering completion of performance within the time b) specified; or
- fails to comply with any of the other instructions, terms, or c) conditions. Rand Water's right to terminate for default may be exercised if the Supplier does not cure the failure within ten (10) days after receiving the notice of such failure.

### 5.16. AMENDMENT OF ORDER

- No amendment or variations to the Purchase Order shall 5.16.1. be permitted without the written approval of Rand Water.
- No price adjustments shall be accepted unless stipulated 5.16.2. in the quotation document received. The Supplier shall be obliged to supply the goods and services on the quoted prices, if the Purchase Order was placed within valid time of quotation.

### 5.17. CESSION OF CONTRACTS

The Supplier may not, cede, delegate, relinquish or transfer to anyone his rights and/or obligations without the prior written consent of Rand Water.

### 5.18. **DISPUTE RESOLUTION**

All disputes between the parties shall, when all efforts to resolve such dispute by negotiation have failed shall be resolved by way of arbitration under the auspices of the Arbitration Foundation of Southern Africa ("AFSA") as per AFSA's rules, in Sandton, Johannesburg. Either party shall however be entitled to proceed to the South Gauteng High Court (to which jurisdiction the parties hereby consent) for any urgent, interim or interdictory relief, as that party may deem necessary in the circumstances in order to protect its rights or interests under a Purchase Order or these terms and conditions.

#### Rand Water does not allow advance payments to the Supplier.

- 5.9.1. Payment of an invoice shall not prevent Rand Water from subsequently disputing all or any of the fees in good faith whether during or after the term of the Purchase Order.
- 5.9.2. Payments shall be effected within 30 days after submission of monthly statement.
- 5.9.3. Rand Water shall endeavour to make payment within 30 days from date of monthly statement, date of the aforesaid monthly statement should reflect the last day of the month wherein the services being invoiced were rendered.

### 5.10. LIABILITY FOR COSTS, DAMAGES OR EXPENSES

Rand Water may deduct all costs, damages or expenses, or any other amount for which the Supplier is liable in terms of the Purchase Order, from moneys due to or becoming due to the Supplier in terms of any subsequent Purchase Orders or the contract between the Supplier and Rand Water. Rand Water is herewith irrevocably and *in rem suam* authorized.

### 5.11. PENALTY AND PERFORMANCE CLAUSE

- 5.11.1. Should the Supplier fail to perform and make delivery in terms of the Purchase Order, exception of Force Majeure specified in Clause 8.13, Rand Water shall be entitled to impose a penalty, which shall be deducted from the payment statement. The imposition of such penalty shall no relieve the Supplier from its obligation to complete the services or from any of its obligations and liabilities under the Purchase Order.
- 5.11.2. Every day, following the day on which a Failure arose ("day 1"), that a Failure persists without being rectified, shall be deemed a new incidence of a Failure for which the Supplier shall incur a penalty deduction.

### 5.19. DOMICILIUM CITANDI ET EXECUTANDI AND NOTICES

- 5.19.1. The Parties hereto respectively choose as their domicilium citandi et executandi for all purposes of, and in connection with this Agreement, the physical addresses as they appear on the Purchase Order.
- 5.19.2. Any notice to be given hereunder shall be given in writing and may be given either personally (i.e. per hand or courier) or may be sent by registered post and addressed to the relevant party at its domicilium or to such other address as shall be notified in writing by either of the parties to the other from time to time. Any notice given by registered post shall be deemed to have been served on the expiry of 7 (seven) calendar days after same is posted. Any notice delivered personally shall be deemed to have been served at the time of delivery.

#### 5.20. LAW

The Purchase Order shall be governed and interpreted in accordance with the law of the Republic of South Africa and shall be subject to the jurisdiction of the South African courts to which the Supplier hereby irrevocably submits but without prejudice to Rand Water's right to take proceedings against the Supplier in other jurisdictions.
