**Pest Control Operator Training and supervision for Mamahlola CPA Pty Ltd (Tzaneen) and Simunye Sibambisene Primary Cooperative ( Kaapsehoop) area**

### **Background**

Training and supervision by an accredited Pest Control Operator training provider is hereby required for entities that are offering silviculture services at SAFCOL based in Tzaneen – Limpopo and the Kaapsehoop area- Mpumalanga.

**Training Duration: Three-day theoretical training followed by six months of practical training.**

**Skills program NQF Level 4 : Pest Control Operator (PCO) Category – Agriculture and Forestry, covering:**

1. Inspection procedures
2. Identification of weeds, declared invaders, and plant pests
3. Selection of herbicides, weed killers, and pesticides
4. Equipment selection and calibration
5. Safety precautions
6. Application techniques
7. Monitoring procedures
8. Clean-up procedures
9. Compliance with Act 36 of 1947 (Pesticide Label Guidelines)

### **Scope of Practical Training:**

- Six-months supervised practical training under a licensed Pest Control Operator.
- The service provider must facilitate training in alignment with the required PCO category.
- Supervisory or mentorship sessions to be conducted at separate sites in Tzaneen - Limpopo and Kaapsehoop- Mpumalanga, these sites are to be provided by and made available to use during the practical training term (period of six months) by the winning bidder.

- A Pest Control licence for a person conducting supervisory or practical training sessions
- Supervisor (Certified PCO) must draft a report for each learner, submitted with a sworn affidavit commissioned by a commissioner of oaths as part of the package for applying for the PCO licence.

- Cover the application fee for lodging the PCO license with the Department of Agriculture, Land Reform, and Rural Development.
- Proof of payment for lodging the application with the department.

  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
