#### 1. INTRODUCTION AND PURPOSE

Gas detection devices are required to alert the Water and Sanitation personnel to presences of dangerous and flammable gases that can be generated at the waste water treatment works, sewage pump stations and in the sewage network. The quotation is for the supply, delivery and off-loading of portable gas detection devices, as and when required for a period of three years.

#### 2. BACKGROUND

Water and Sanitation personnel for health and safety purposes are required to test for the presence of harmful gasses when entering confined spaces, where the occurrence of hydrogen sulphide or methane can potentially be present. The portable gas detection devices are carried by personnel. The gas detection device sound an alarm when hydrogen sulphide, carbon monoxide, lack of oxygen or natural explosive gasses like methane are detected.

The gas detection devices will be ordered on an as and when basis subject to the approval of sufficient funds in the 2025/26 and 2026/2027 financial years and other priorities within the WWTW capital budget.

#### 3. PROJECT SCOPE

#### 3.1 SPECIFIC EQUIPMENT SPECIFICATION

- 3.1.1 The device must be capable of full time detection for the following gasses:
  - Natural combustible gasses (LEL) Methane CH<sub>4</sub>
  - Hydrogen Sulphide (H<sub>2</sub>S)
  - Lack or to high Oxygen (O<sub>2</sub>)
  - Carbon monoxide (CO)
- 3.1.2 Design, dust and water resistant requirements:
  - The unit must be a serviceable unit
  - Compliant to IP67 or IP68 ingress protection
  - Operating temperature must be between -20°C and 50°C and operating humidity range between 15% and 95% relative humidity
  - The device must be durable and of sturdy construction with a rugged cover.
  - Maximum size: 115 mm length, 80 mm height, and 60 mm in depth.
  - Weight: Maximum 300 g
- 3.1.3 The unit shall have the following alarms:
  - Visual flashing light
  - Audible alarm, louder than 90 dB
  - Vibrating alarm
- 3.1.4 Every device must have the following:
  - Powered from a rechargeable battery
  - Be able to operate at least 12 hours before a recharge
  - The unit must be supplied with 220 Volt charger to fit into a domestic power outlet typically used in the Republic of South Africa.
- 3.1.5 Service and Maintenance
  - The supplier must have access to a facility which will be able to service and calibrate instruments and chargers.
  - The service facility must be located in South Africa and be able to certify that the instruments are working according to the product's specifications.
  - A service turnaround time of not more than 7 days must be realistic.
  - All goods must have at least a one-year material and workmanship guarantee.
- 3.1.6 Technical Data Sheet and Schedule of Particulars and Requirements

• The technical data sheet and brochures for the unit must be submitted with the quotation. The technical data sheets shall indicate all available technical data for the unit and must correspond to the information filled in the Schedule of Particulars and Requirements.

The city further reserves the right to negotiate a market related price with a tenderer scoring the highest points.
