Closing time will **only** be determined by the Municipal watch displayed on the Municipal wall at the reception. Only bidders registered on Central Supply Database (CSD) will be considered.**

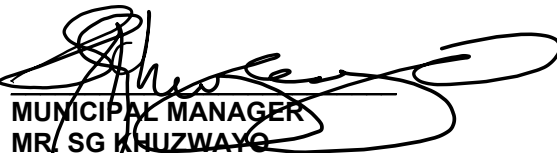
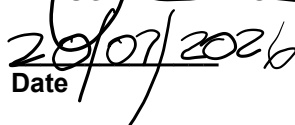
