2. SCOPE OF WORK

2.1 The **National Radioactive Waste Disposal Institute (NRWDI)** currently operates without dedicated data centre facilities at both its Head Office (to be relocated to Midrand, Gauteng) and its Operational Office in Vaalputs–Springbok, Northern Cape Province.

2.2 NRWDI seeks to procure professional services to design, build, and commission two fully equipped mini data centres (approximately 6 square meters each) that will support secure, efficient, and compliant IT operations across both sites.

2.3 The proposed data centres will be designed to meet key international IT governance and security standards, including:

- **ISO/IEC 27001 – Information Security Management** - Ensures the protection of confidentiality, integrity, and availability of NRWDI's data through structured security controls.
- **ISO 20000-1 – IT Service Management** - Promotes consistent service quality, predictable IT operations, and improved service delivery.
- **ISO/IEC 42001 – Artificial Intelligence Management** - Enables responsible AI governance, risk management, and transparency as NRWDI increasingly adopts digital and AI-supported systems.
- **ISO 22301 – Business Continuity Management** - Ensures resilient operations and rapid recovery in the event of disruptions.
- **ISO 9001 – Quality Management Systems** - Supports consistent, repeatable processes and continuous improvement across IT environments.

3. EVALUATION CRITERIA

3.1 Mandatory Requirement (At RFQ Closing Date)

- i. A service provider who fails to quote fully or according to the price structure/table and scope of work will be disqualified.
- ii. Quotation submitted after the closing date and time will not be considered for evaluation.
- iii. Quotations that are not sent through the procurement central email will not be considered for evaluation.
- iv. Submit a minimum of three (3) reference letters from previous clients where data centre(s) was established.



3.2 Mandatory Requirements (at Award Stage)

- i. Non tax compliant Bidders will not be awarded the RFQ
- ii. Bidders listed in the Register of Restricted Suppliers or in the Tender Defaulters Register from National Treasury will be disqualified.

Failure to comply to the above mandatory requirements (3.1&3.2) will lead to disqualification of your quotation.

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to invitations to tender:

 - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).
- 1.2 The applicable preference point system for this tender is the **80/20** preference point system.
- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

 - (b) Specific Goals.
- 1.4 The maximum points for this tender are allocated as follows:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“black people”** is a generic term which means Africans, Coloureds and Indians—

- a) who are citizens of the Republic of South Africa by birth or descent; or

 - i) before 27 April 1994; or

- (b) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

- (d) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (e) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (f) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000); and
- (g) **“women”** means a person of female gender who is a citizen of the Republic of South Africa.

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
