**1. BACKGROUND**

The Nelson Mandela Museum (NMM) is a not for profit institution established by the government of South Africa as an agency of the National Department of Sports, Arts and Culture. It was established as part of a portfolio of legacy projects that seek to transform the heritage landscape from our apartheid past. At the same time, it is a resource for promoting economic development through tourism in an impoverished region of the country. The museum primarily houses collections of gifts to the nation given by Nelson Mandela to the museum to share his legacy with the nation.

The mandate of the Nelson Mandela Museum is to preserve and promote the legacy of Nelson Mandela, and one of its main strategic goals is to improve the museum's public profile and access. This mandate is executed through the museum's four main facilities, the Qunu Youth and Heritage Centre, Bhunga Building, Ingquza Hill Museum in Flagstaff, and OR Tambo Garden of Remembrance in Bizana (eNkantolo) in Mthatha CBD. The Bhunga Building doubles as the administrative office of the museum

**2. PURPOSE**

The Nelson Mandela Museum intends to appoint a reputable service provider to host the NMM website for a period of five (5) years. Prospective service providers are advised to go through the existing NMM website to have an understanding of the magnitude and diversity of information collected and hosted on this website.

### **3. PROJECT BACKGROUND**

The current Nelson Mandela Museum website has been redesigned, developed and completed in the year 2023. The service provider to be appointed must only host the website and ensure its uptime and security. The website and all its content will remain the sole property of Nelson Mandela Museum. On the proposal, the bidder should detail how support and maintenance for period of five years of hosting will be carried out.

### **4. SCOPE OF WORK**

Current State of the NMM Website:

PHP Version

- Required PHP Version: PHP 7.4 or higher (PHP 8.x recommended for optimal performance and security)

Database Type and Version

- Database Type: MySQL

Web Server

- Web Server Type: Apache
- SSL Support: SSL Certificate (HTTPS) for secure communication.

Storage Requirements

- Website Size (Current): [ 6.45GB].
- Storage Space Required: [ 50GB].

## **4.2 Migration**

The service provider must be able to migrate the website from the current hosting provider to their hosting infrastructure without causing any downtime or loss of data. The service provider must have a well - defined migration plan and must execute it with minimal disruption to the NMM business operations

- Migration of the existing website from the current hosting service to the new vendor hosting environment, including all the website artefacts, database, files and documents.
- Migration should ensure that all email aliases are updated, all URLs and links are updated and accessible and all website functionality and corporate identity is preserved.
- Bidders must supply a migration plan, as part of the project plan

## **4.3 Website Hosting**

- The service provider must provide reliable website hosting services that ensure 24/7 availability of our public-facing website. The hosting services must support the latest web technologies. The service provider must also provide scalable hosting solutions that can accommodate our website's growth.
- Configuration of the hosting environment, including server setup, domain management, SSL certification, and security protocols
- The service provider must provide robust website security measures to prevent unauthorised access, malicious malware and other cyber - attacks. The service provider must implement security protocols that comply with industry standards and regulations. The service provider must also retain a record of unwanted intrusions and provide timely alerts to the Nelson Mandela Museum.
- The service provider shall be responsible for ensuring the website's security and resilience against all cyberthreats and vulnerabilities, including but not limited to the following:
  - Keeping all the website software components up-to-date.
  - Keeping the plugins up-to-date for annual plugin licence renewal before their expiration.

- Ensure the website is using high-standard encryption, equivalent to or higher than the SHA-256 standard.
- Keeping Socket Secure Layer (SSL) certificates up-to-date for the duration of the contract to ensure secure data transfer.
- Limit and manage user permissions and access.
- Keep the anti-malware software up-to-date.
- Implement security measures against common attacks, including XSS injections, SQL injections, session hijacking, distributed denial of service (DDoS) attacks, et cetera.
- Keep the web app firewall up-to-date.
- Protection against defacement and hacking of the website.
- Implementation of CAPTCHA to prevent email harvesting.
- To implement advance JavaScript to obfuscate emails from your website.
- Maintain a reliable online contact form for users to fill out and submit in place of showing Nelson Mandela Museum email addresses.
- Maintain consistent use of graphics or scripts to display email addresses on your websites.
- Implement network security controls such as firewalls and IDS/IPS to ensure blocking of unauthorised access to cloud metadata.
- Perform regular monitoring of the website's cloud environment for unauthorised access or abnormal behaviour.
- Ensure that anti-CSRF tokens are implemented and validated properly on all forms and requests that could lead to sensitive actions. This includes validating the origin of the request and ensuring that the token is unique for each session and cannot be reused.
- Ensure that the CSP header is properly configured and set to restrict the sources of content that can be loaded on the web page. This includes setting policies to restrict loading of scripts, stylesheets, and other types of content to trusted sources only.
- Ensure that all pages of the website use only HTTPS instead of HTTP.
- Ensure the implementation of strong password policies, as per the Nelson Mandela Museum password policies, use key-based authentication, regularly

monitor and patch any vulnerabilities in your SSH server software, and use secure protocols such as SSHv2 to mitigate vulnerabilities for port 22 (SSH). Additionally, ensure that access to SSH servers is restricted to only trusted users and devices, and use firewalls to block unauthorised access to the port.

- Provide a secure environment specifically designed for Nelson Mandela Museum, ensuring data sovereignty, security, and compliance with national policies and tailored to the needs of public entities, providing but not limited to the following;
  - Dedicated server infrastructure for hosting the NMM website.
  - Experienced, dedicated team available to respond in a timely manner.
  - Rapid response to monitoring alerts.
  - Daily backups with rolling archives.
  - Ensure website security, firewalls, plug-ins, the operating system, and all website artefacts are up-to-date and functioning effectively.
- Host the website of the Nelson Mandela Museum for the contract period and ensure an uptime of 99.5% for the duration of the contract.
- Implementation of automated backup and recovery procedures.
- A comprehensive maintenance plan detailing how the bidder will liaise with the Nelson Mandela Museum's ICT unit on equipment repairs and keeping equipment serviced with clear time frames.
- Network uptime- The service provider must guarantee network uptime to be 100%. This guarantee assures that all major routing devices within are reachable from the global internet 100% of the time. Minimize and avoid downtime.
- Hardware replacement- The service provider must guarantee that in the event of a hosting server hardware failure, the faulty hardware will be replaced within one (1) hour of identifying the problem and the services will be normal within 24 hours. Minimize and avoid downtime.
- Software maintenance- It is important to manage dedicated server to keep the software up to date to address security and performance issues. Minimize and avoid downtime.
- Data Backup and Retention- Weekly complete or successful backup to ensure integrity and safety of website. Backups should be rotated every week. The service provider

must have a restore strategy should the disaster strikes. Backup costs should be inclusive of total amount.

### **Reports**

- Provide monthly maintenance reports outlining updates, security patches, performance optimizations, and any support activities conducted.
- Provide monthly security and technical support for the duration of the contract.
- Provide monthly analytics reports detailing website usage, performance, user engagement /user behaviour, and engagement metrics.

### **Timeframes**

- Delivery should be made within 14 days from the date the Service Provider received an official Purchase Order

## **5. TERMS AND CONDITIONS**

- All costs and expenses incurred by the potential service provider relating to their project proposal will be borne by each respective service provider. NMM is not liable to pay such costs and expenses or to reimburse or compensate service providers in the process under any circumstances, including the rejection of any proposal or the cancellation of this project.
- NMM may require responsive bidders to present and discuss their proposals in person.
- NMM reserves the right not to make any appointment from the proposals submitted.
- Bidders shall not issue any press release or other public announcement pertaining to details of their project proposal without the prior written approval of NMM.
- Bidders are required to declare any conflict of interest they may have in the transaction for which the bid is submitted or any potential conflict of interest. It is important that bidders declare their conflict of interest through completion of relevant attached forms.
- NMM reserves the right not to consider further any bid where such a conflict of interest exists or where such potential conflict of interest may arise.
- Any and all project proposals shall become the property of NMM and shall not be returned.

- The bid offers and proposals should be valid and open for acceptance by NMM for a period of 120 days from the date of submission.
- NMM reserves the right not to award the bid to the bidder that scores the highest points. Disputes that may arise between NMM and a bidder must be settled by means of mutual consultation, mediation (with or without legal representation) or, when unsuccessful, in a South African court of law.
- In addition to adherence to the specific terms and conditions of proposals, provided in this document, the bidder shall be bound by the provisions of the General Conditions of Contract, an original signed copy of which must be submitted together with all other bid documentation.
- After the successful service provider has received the appointment letter, they must be able to deliver in full compliance with South African approved standards and in compliance with the specifications provided

## **6. PRICING INSTRUCTION**

- The provision of website hosting services must be rendered as per the requirements of the NMM, and it must be invoiced monthly for the duration of the contract
- The bid and the total price for the provision of website hosting services may not be exceeded;
- Amounts due to the Service Provider shall be paid by the NMM within thirty (30) days of receipt of the correct invoice.
- The NMM reserves the right by giving written notice to the service provider to stop the works' progress at any time. Should the client exercise this right, the NMM will pay the service provider for work done and expenses incurred only up to the time that the notice was given.

## **7. ACCOUNTABILITY**

The service provider will be accountable to and under the direction of the CEO of the NMM in the performance of the assigned duties.

## 8. RETURNABLE DOCUMENTS

Service providers are required to submit all the returnable documents together with their proposal. ***Failure to provide all the Compulsory Returnable Documents at the closing date and time of this RFP will result in a respondent's disqualification. ## 11. EVALUATION CRITERIA

### **Criterion 1- Compulsory Requirements**

Bidders will first be evaluated in terms of the gatekeeper/minimum requirements stipulated. Bidders who do not fulfil all the requirements or do not submit the required documents will be disqualified. Those who fulfil all the requirements or have submitted the required documents will be further evaluated on functionality.

### **Criterion 2- Functionality**

Functionality is worth 100 points. The **minimum threshold is 75 points**. Bidders who score less than 75 points on functionality will therefore not be evaluated further. Those who score 75 points or more will be evaluated in terms of price and preference points (points allocated for specific goals). The functionality evaluation is broken down as follows:
