#### 1. INTRODUCTION AND PURPOSE

The purpose of this report is to acquire a service provider to perform cataloguing and classification of library information resources on SIRSI DYNIX (Symphony)

#### 2. BACKGROUND

Library information resources material are procured centrally at head office. After the procurement process, information resources are catalogued and classified on SIRSI library system then they are processed and send to libraries to be accessed by library patrons

All Library resources and materials received require a specific system for acquisition and adding to the city's asset register. To that point the City has acquired the technical and software system which is SIRSI Dynix Symphony which enables the libraries to catalogue all entries in accordance to the global standards and allows for easy retrieval and configuration with the online public access catalogue for library patrons.

Currently we have 4 librarians that are cataloguing for all 60 libraries, this poses a challenge in terms of asset management compliance. Books are classified as assets and currently librarians in cataloguing section are under pressure of meeting the deadlines as set by asset finance section.

A service provider is required to assist the current team of cataloguers to comply with asset control and to speed up the process in the section. For this reason, we require a cataloguing service provider to assist the current library team to speed up the process in the section.

#### 3. PROJECT SCOPE

The supplier of cataloguing and classification of City of Tshwane library information resources material should cover the following steps.

#### SCOPE OF WORK:

The appointed service provider to conduct cataloguing and classification services to the identified batch of resources marked backlog in order to assist with the regulatory compliance with the GRAP Standards by executing the following Tasks:

#### Step 1:

The book should already have allocation slip indicating the library where the books are allocated to, and the price.

#### Step 2:

Each library should have loaded funds on Sirsi as per the budget allocation.

Each library should be updated to the current financial year on SIRSI system.

#### Step 3:


Search ISBN of approval copy on Symphony. When match is found order, receive & barcode material. When no match is found, create a short record.

Order books and allocate copies according to the allocation slip.

#### Step 4:

Receive copies before sending to cataloguing.

#### CATALOGUING OF COT LIBRARY BOOK

- Manual of the City of Tshwane Library Services
- Dewey Decimal Classification System
- Resource Description and Access Manual
- MARC21 (Bibliographic Machine-Readable Cataloging)

- Symphony catalogue of the City of Tshwane Libraries

#### When cataloguing of a book is done the cataloguer must:

- Barcodes each of the copies
- Receives the copies on Symphony
- Add the copies to the catalogue

#### Verification of catalogue records

NF books that were added to the catalogue either from OCLC or newly catalogued are verified and sent to book processing.

#### 4. DELIVERABLES

The successful bidder must submit a comprehensive documented plan that clearly indicates how cataloguing, and classification of COT information Resources will be catalogued a step-by-step guide. The service provider should have a clue on SIRSI DYNIX library system.

#### 5. STAGES OF EVALUATION

This bid will be evaluated in three evaluation stages namely:

Stage 1: Administrative compliance Stage 2: Mandatory requirements Stage 3: Preference Points System

#### **5.1 ADMINISTRATIVE COMPLIANCE**

All the bids will be evaluated against the administrative responsiveness requirements as set out in the list of returnable documents.

#### **5.2 MANDATORY REQUIREMENTS**

Special disqualification criteria for the specific bid/project must be indicated, which could include non-submission of the following:

- The service provider must have relevant previous experience in cataloguing on SIRSI DYNIX (SYMPHONY) library system with at least 3 completed projects. Proof in a form of reference letters.
- Evidence of documented guidelines covering all the steps required when cataloguing information resources on SIRSI DYNIX. Proof in a form of a procedure manual.
- The service provider must provide number of qualified Librarians available and CV's provided with at least 3 years' experience:

Evaluation in terms of the 80/20 preferential procurement system as prescribed, 2017. The system consists of the following two elements:

#### 8. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct a market analysis. Should the City exercise this option, where a tenderer offers a price that is deemed not to be viable to the services as required, written confirmation will be made with the tenderer if they will be able to deliver on the price determined by the City. If a tenderer confirms that they cannot, the tenderer will be disqualified based on being non-responsive.

If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract, including performance warnings, and listing on the database of restricted suppliers.

If the tenderer scoring the second-highest points does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring the third-highest points. If a market-related price is not agreed upon, the City reserves the right to cancel the tender.

- 1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

- (j) "Firm price" means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- (k) "functionality" means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- (I) "non-firm prices" means all prices other than "firm" prices;
- (m) "person" includes a juristic person;
- (n) "QSE" means a Qualifying Small Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (o) "rand value" means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties:
- (p) "sub-contract" means the primary contractor's assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- (q) "total revenue" bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- (r) "trust" means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- (s) "trustee" means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

#### 3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

#### 4. POINTS AWARDED FOR PRICE

#### 4.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis: **80/20** 

$$Ps = 80 \left( 1 - \frac{Pt - P\min}{P\min} \right)$$

Where

Ps = Points scored for comparative price of bid under consideration

Pt = Comparative price of bid under consideration

Pmin = Comparative price of lowest acceptable bid

#### 5. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTION

5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.3 A Bidder other than EME or QSE must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating

- issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary Institutions and Public Entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.
