As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

- Price adjustment shall be based on CPI.
- All prospective bidders shall be required to quote SANParks on all the items required as listed on the Pricing schedule. **Annexure D**. NB Failure to complete the whole pricing schedule shall lead to disqualification.
- Delivery shall be within fourteen (14) working days from the date of the purchase order.

SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.**
