Bill of Quantities – Mechanical Items (Specific Supplier Reference)	Error in the document The following Bill of Quantities items reference a specific equipment by suppliers' name, with no provision for an equivalent product to be offered: Item M2.3.2.1, Item M3.2.1.2, Item M5.2.1.1, Item M6.2.1.1, and Item M7.2.1.1. Naming a single supplier without an equivalence clause effectively restricts the tender to that supplier, which may expose the tender to challenge or audit findings on the basis that the specification was not competitively neutral. Correction Items M2.3.2.1, M3.2.1.2, M5.2.1.1, M6.2.1.1 and M7.2.1.1 of the Bill of Quantities have been amended to include the wording "<i>or similar approved</i>" alongside the named supplier.

	This preserves the Intended specification standard while allowing tenderers to offer an equivalent product for approval, keeping the tender compliant with Section 217 of the Constitution and the fair, equitable, transparent and competitive procurement requirements of the PPPFA and PFMA. All other details of the Bill of Quantities remain the same.
