2. Project Description

Necsa is currently in a process of upgrading some of its experimentation infrastructure in brown field. Experimentation infrastructure required that the building to be used must comply with relevant codes and standards for fire and gas. It is therefore required that an inspection of the earmarked building be conducted to establish compliance with relevant codes and standards.

3. Expected Deliverables

On completion of the inspection it will be required that the appointed service provider provides Necsa with a gap/shortcoming report that as a minimum contains the following information.

- 1. Gap/shortcoming report
- 1.1. Applicable South African codes and standards for Fire and Gas system design, installation and maintenance.
- 1.2. Areas that need to be attended to
- 1.3. List of current material to be avoided.
- 2. The service provider will also be required to compile an RFQ for the design and installation of a fire detection and protection system
- 3. The service provider will also be required to compile an RFQ for the design and installation of a gas detection and protection system

4. Duration

The duration to supply the services must not exceed 2 months.

5. List of compulsory information and documentation

The potential service providers should supply the following information and documentation in response to the RFQ, failure to do so will disqualify the potential supplier:

- Response document must be signed by a duly authorised representative of the company.

7. Evaluation

• Phase 1- Functionality Evaluation / Technical Evaluation
