1. Background to the National Museum

2. Purpose

The Museum would like to source a quote from an experienced and authorised reseller to sell, configure and install zoom video communications services

3. Scope of Service

The Museum is requesting the following;

1. Renewal of three (3) existing zoom licences for video conferences
2. Purchase of one (1) additional zoom licence

4 Compulsory requirements

4.1.1 The training provider must be an authorised agent to sell zoom video communications services.

4.1.2 The agent must have at least 1 year experience in acting as an zoom agent

4.1.4 The training provider must provide a list of 3 contactable references of organizations where they provided similar service or purchase of zoom licence

4.1.6 The training provider must submit the SBD 4 Form signed and completed.

4.1.7 BBBEE certificate or Declaration is not compulsory but may be submitted to score points on preferential point system of 80/20 on price and BBBEE points.

4.1.7 CSD registration and tax clearance

4.1.8 The service provider must be registered on CSD and must be tax compliant

4.1.9 The service provider must be a company registered in South Africa with CIPC

Matters for noting

1. Non-compliance to the above compulsory requirements will lead to a disqualification of the bidder, except for non-tax compliant with tax matter which is subject to grace period of at least 7 days that will be provided to a preferred service provider should that service provider is not compliant following bid evaluation.
2. Failure by this preferred service provider to rectify its tax matters to a compliant status within the grace period provided will lead to an automatic disqualification.
3. Validity period for bids or formal written quotations submitted shall be valid for a minimum period of thirty (30) days. The formal written price quotations received from the service provider/supplier will be regarded as valid for 30 days despite expiry date less than 30 days indicated on a quote.

6 Bid Evaluation.
