## **T1.1 TENDER NOTICE AND INVITATION TO TENDER (Incorporating SBD1)**

The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the design, supply and erection of a modular steel deck and appurtenant works to the Tongaat River (B1237) Located on Main Road P398 Section 2 at km 10.4. The works envisage entails the design, supply and erection of the modular steel bridge deck to span across the adjacent decks that have collapsed due to the pier settlement following the KZN flooding of 12 April 2022. This project is in the province of Kwa-Zulu Natal in the eThekweni Metropolitan Municipality. The approximate duration is 2 months.

CIDB Regulation 25(1B) will not be applicable to this contract

Only tenderers with a B-BBEE contributor status level of 1, 2, 3 or 4 and who are registered on the National Treasury Central Supplier Database and meet the minimum threshold designated for local production and content as stated in the Tender Data C.2.1, are eligible to tender.

It is estimated that tenderers should have a CIDB contractor grading designation of 8CE or higher, however tenderers attention is drawn to clause C.2.1 of the Tender Data when submitting their tender.

Tenders from tenderers registered as potentially emerging enterprises but with a CIDB contractor grading designation lower than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25(7A) of the Construction Industry Development Regulations, will not be accepted.

It is a requirement of this project that the successful tenderer subcontract a minimum of thirty percent (30%) of the work by the end of the contract to Targeted Enterprise(s) as defined in the Section D of Part C3 Scope of Work.
