## **1. PURPOSE**

the purpose of this exercise is to appoint a reputable supplier for the training of employees for fleet management in the Garden Route National Park.

## **2. BACKGROUND**

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## **3. SCOPE OF WORKS AND PRICING SCHEDULE**

### **3. Background and Purpose**

Garden Route National Park operates a diverse fleet of vehicles and equipment across multiple sections and operational environments. Effective fleet management is essential to ensure service delivery, safety, cost efficiency, compliance with legislation, and alignment with SANParks policies.

This training intervention is aimed at capacitating eight (8) employees from different sections of the Garden Route National Park with relevant, accredited fleet management competencies aligned to the Energy and Water Sector Education and Training Authority (EWSETA) and the Quality Council for Trades and Occupations (QCTO).

The training will form part of SANParks' skills development and capacity-building initiatives and will support improved operational efficiency and governance within fleet operations.

### **4. Target Group**

- Eight (8) employees from different sections of the Garden Route National Park
- Employees responsible for fleet administration, supervision, coordination, or oversight

### **5. Skills Development Alignment (Non-Accredited)**

The training programme is **non-accredited** and will not result in formal credits or unit standard certification.

The programme must, however, be **aligned to EWSETA good-practice guidelines and relevant QCTO occupational knowledge areas** related to fleet and transport management, to ensure relevance, quality, and applicability within a public-sector and conservation environment.

The training is intended as a **skills development and capacity-building intervention** focusing on practical competence, workplace application, and improved operational performance rather than formal qualification outcomes.

No EWSETA accreditation is required; however, the service provider must demonstrate subject-matter expertise and experience in fleet management training.

## **6. Training Objectives**

The overall objective of the training is to equip participants with the knowledge and practical skills required to effectively manage fleet operations within their respective departments, in line with SANParks policies and EWSETA standards.

Specific objectives include:

- Understanding core principles of fleet management
- Improving vehicle utilisation and operational planning
- Managing maintenance, repairs, and service schedules
- Ensuring legal and policy compliance
- Improving record keeping and reporting
- Managing fuel consumption and fleet-related costs
- Enhancing driver management, safety, and accountability

- b) The **80/20 preference point system** will be applicable in this tender. The lowest acceptable tender will be used to determine the accurate system once tenders are received.

**1.3** Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (b) Specific Goals.

## 2. DEFINITIONS

- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
