1. TERMS OF REFERENCE FOR THE MOTIVATIONAL SPEAKER

1.1. INTRODUCTION AND BACKGROUND

1.1.1. SASSETA is one of the twenty-one (21) Sector Education and Training Authorities (SETAs) established in terms of the Skills Development Act (Act 97 of 1998) as amended. SASSETA's licence has been renewed until 31st March 2030. SASSETA is classified as a schedule 3A Public Entity in terms of the Public Finance Management Act, (Act 1 of 1999, as amended). SASSETA reports to the Department of Higher Education and Training.

1.2. **PURPOSE**

1.2.1. SASSETA requires a suitable and experienced service provider to provide motivational speaking and good work culture promotion services to SASSETA management and staff from the date of appointment until 31 December 2027.

1.3. **SCOPE OF WORK**

- 1.3.1. The service provider will be required to provide the initial assignment on motivational speaking and good/acceptable work culture promotion services to SASSETA management and staff during the Organisational Strategic session taking place in the Sun City on 27 November 2025.
- 1.3.2. Other motivational speaking assignments will be undertaken on an ad hoc basis at SASSETA specified dates and venues.

1.4. REQUIRED DELIVERABLES

- 1.4.1. The service provider will be required to deliver the following items for a maximum of up to two (2) hours:
 - 1.4.1.1. motivation to SASSETA management and staff.
 - 1.4.1.2. promotion of good/acceptable work culture to SASSETA management and staff.

- 1.8.3. Where the contract requires the successful bidder to travel to a venue different from SASSETA, the following travel and disbursement processes will be undertaken:
