- vii.) The contractor undertakes to adhere to Act No. 9 of 2018 or the latest relevant gazette: National Minimum Wage Act, 2018 AND Gazette 03 February 2026 No. 54075 failure to adhere to this law/gazette will result in termination and cancellation of the contract.
- viii.) The service provider must factor in the consumer price index (CPI) escalations as per the statutory requirements for the following years
- ix.) Contractor to ensure they comply will all the other regulated labour conditions and SARS requirements for accounting i.e UIF ect with in their pricing structure.
