The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the Special Maintenance of Structures and Drainage on an Ad-Hoc Basis on the National Road Network in the Western and Northern Cape Package 1 to 7. This project is in the province of Western and Northern Cape in the following municipalities: De Doorns, Heidelberg, City of Cape Town, Springbok, Bot River, Upington and Magareng (Warrenton). The approximate duration is 12 months including 2 months for the Mobilisation Period.

CIDB Regulation 25(1B) will not be applicable to this contract.

Only tenderers who are registered on the National Treasury Central Supplier Database as stated in the tender data C.2.1.1, are eligible to tender.

It is a requirement of this project that the successful tenderer subcontract a minimum of 40 percent (40%) or higher as tendered of the work by the end of the contract to Targeted Enterprise(s) as defined in the Contract Data.

It is estimated that tenderers should have a CIDB contractor grading designation of 7CE or higher, however tenderers attention is drawn to clause C.2.1.1 of the Tender Data when submitting their tender.

Tenders from tenderers registered as potentially emerging enterprises but with a CIDB contractor grading designation lower than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25(7A) of the Construction Industry Development Regulations, will not be accepted.
