# **DETAILED TECHNICAL SPECIFICATION**

# 1. Background

In compliance with SABC IT Directive, Information Security policy and aligned risk strategy, the Information Security department is required to annually commission an independent external vulnerability assessment (ethical hack) of the SABC internet websites, internal network, core systems such as the TV License system that hosts client information and processes financial transactions – and wired/ wireless networks.

The vulnerability assessment forms part of the risk mitigation strategy to ensure industry IT security standards compliance, minimising of risk and to provide the corporation with the assurance that websites developed and commissioned by the Digital Media team introduce no undue risk for systems and content hosted on the sites. This initiative will reinforce Information Security and Governance profile in the protection of SABC information assets, Intellectual Property and image that will serve to enhance business assurance.

# 2. Scope of work

The proposed scope of the ethical hack and emergency services includes amongst others but is not limited to Managed services monthly hours/rate for on demand support, especially in the event of an incident or crises (cyber-attack) that we are unable to remediate, Vulnerability assessments for IT Security (WEB, systems and networks), phishing simulations, social engineering, Zero day threat alerts and general security trends, including Security presentations to identified key staff, covering the below mentioned platforms:-

- SABC LAN and WAN vulnerability assessments (systems, network, anything associated with an IP address).
- Web Application
  - ✓ SABC websites
  - ✓ Internet WEB email Portal
- SABC mobility devices
- Wireless Network
- Penetration Test
- Risk Assessment Report to include: -
  - ✓ Recommendations for remediation of identified vulnerabilities.
  - ✓ A proposal for Emergency IT Security Services (potentially an Annual SLA for Managed Services)
  - ✓ Wireless/hotspots/Bluetooth, vulnerabilities, etc.
  - ✓ Periodic cyber-security presentation to SABC executive

- Provide emergency support services in the event of a cyber-attack or incident that the SABC IT and Internet Services Provider teams are unable to contain.
- It is expected that the relevant in-house skills will be transferred during the course of the project. Furthermore, it will be expected that the potential service provider will comply SABC Information Security policies and National Key-Point (NK-P) requirements in the National Security Intelligence dispensation service supply chain.
- Onsite staff and remote staff of service provider needs to be vetted by SABC via SAPS as per National Key Point requirements.

# 3. RFQ Response Information

#### Effective Date of Bid

Vendors should state in writing that their quotation to the SABC and all furnished information, including price, will remain valid and applicable for 90 days from the date the vendor quotation is received by the SABC.

# 4. Costing

The quotation must reflect a detailed cost breakdown, and any indirect costs associated with the rendering of required service as per the schedule in the **Scope of Service**.

## 5. Duration of the Contract

Three (3) years

# 6. Evaluation criteria

#### 6.1 BBBEE and Price

• The RFQ responses will be evaluated on the **80/20** points system

# 6.2 Technical Evaluation

- The tender submission will be technically evaluated out of 100
- A minimum threshold of **80 out of a maximum of 100** has been set.
- Bidders achieving less than the set threshold will be declared non-responsive.

# 6.3 Objective Criteria

- The SABC further reserve the right not to award this tender to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- Bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance company, financials, etc. will be eliminated from the bid process.

#### 9 COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

# 10 CONDITIONS TO BE OBSERVED WHEN TENDERING

- 10.1 The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- 10.2 No tender shall be deemed to have been accepted unless and until a formal contract / letter of intent is prepared and executed.
- 10.3 The Corporation reserves the right to:

Not evaluate and award submissions that do not comply strictly with his RFQ document.

# Make a selection solely on the information received in the submissions and

- Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
- Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.
- Award a contract to one or more bidder(s).
- Accept any tender in part or full at its own discretion.
- Cancel this RFQ or any part thereof at any time.
- Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs & Preference Point system.

# CONSORTIUMS, JOINT VENTURES AND SUB-CONTRACTING REGULATIONS

## 1. CONSORTIUMS AND JOINT VENTURES

- 1.1 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 1.2 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.

#### 2 SUB-CONTRACTING

- 2.1 A person awarded a contract may only enter into a subcontracting arrangement with the approval of the organ of state.
- 2.2 A person awarded a contract in relation to a designated sector, may not subcontract in such a manner that the local production and content of the overall value of the contract is reduced to below the stipulated minimum threshold.
- 2.3 A person awarded a contract may not subcontract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level of contributor than the person concerned, unless the contract is subcontracted to an EME that has the capability and ability to execute the subcontract.

#### 1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to invitations to tender:
  - the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
  - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

# 1.2 To be completed by the organ of state

- a) The applicable preference point system for this tender is the 80/20 preference point system.
- b) 80/20 preference point system will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.
- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

# 2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts:
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

#### CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
