1. QUOTATION CONDITIONS

- a. **MICT SETA** does not bind itself to accept the lowest or any RFQ, nor shall it be responsible for or pay any expenses or losses which may be incurred by the bidder in the preparation and delivery of the RFQ.
- b. No RFQ shall be deemed to have been accepted unless and until a formal contract / letter of intent is prepared and executed.

1.1 **MICT SETA** reserves the right to:

- a. Not evaluate and award RFQ that do not comply strictly with the requirements of this RFQ.
- b. Make a selection solely on the information received in the RFQs and Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this RFQ.
- c. Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders and no change in the content of the RFQ shall be sought, offered or permitted.

The bidder shall bear all costs and expenses associated with preparation and submission of its RFQ or RFQ, and the MICT SETA shall under no circumstances be responsible or liable for any such costs, regardless of, without limitation, the conduct or outcome of the bidding, evaluation, and selection processes.

DETAILED SPECIFICATION

APPOINTMENT OF A PANEL OF RECRUITMENT AGENCIES FOR A PERIOD OF THREE (03) YEARS.

1. Background

The Media, Information and Communication Technologies Sector Education and Training Authority, the "MICT SETA", was established in terms of the Skills Development Act, 1998 (Act No. 97 of 1998). Is responsible for skills development for its respective sub-sectors. The MICT sector is made up of five sub-sectors that are interconnected but also quite distinct and identifiable. These are Advertising, Film and Electronic Media, Electronics, Information Technology and Telecommunications.

2. Objective

To invite prospective service providers to submit a proposal for appointment to a panel of recruitment agencies to headhunt/recommend appointable candidates to fill vacancies that will address MICT SETA employment's equity targets.

3. Scope of work

- 3.1. The bidder will be required to provide recruitment services as and when required by MICT SETA. Service provider will be required to conduct the recruitment process by doing the following:
 - 3.1.1. Determine competency level or match an applicant with the job description provided by MICT SETA considering the key performance areas of the position.
 - 3.1.2. The recruitment agency will send the applications / CV of their candidates.
 - 3.1.3. Provide the MICT SETA with a shortlist of possibly suitable candidates within five (5) working days of appointment of the service provider.

- 3.2. The MICT SETA will be responsible for conducting the interview/s
 - 3.2.1. Further provision for the following should be made:
 - Annual leave: 21/27 days inclusive of shutdown period
 - Sick leave: 1 day for every 26 days worked
 - Provision for all leave types should be made
 - The leave days must be fully paid

The requirements are not limited to the above, other recruitment requirements may be required should it be necessary.

MICT SETA reserves the right to limit the number of shortlisted recruitment agencies to be appointed in the panel.

4. DURATION OF THE PROJECT

Successful bidders will be appointed to be part of the panel for a period of three (03) years on an "as and when required" basis.

5. PROPOSED COST STRUCTURE

Since the services required are as and when needed, the recruitment agency must attach the following price breakdown list in the RFQ submission:

- 5.1. Percentage fee charged on temporary employment and other positions and annual fee increase projections.
- 5.2. Once-off placement fees percentage that will be charged in respect of the successful placement of Fixed Term Contract / permanent employment for management positions and other positions including an annual fee increase projections.

Services providers who qualify to be in the panel may be invited to submit quotations for available vacant position as and when required. The MICT SETA will invite the services providers qualified for this panel to compete for allocated projects during these three (03) years.

RFQ's received will be evaluated on Functional evaluation and preference points system.

RFQ submission will be evaluated on technical functionality out of a maximum of 100 points. RFQ submission must achieve the minimum threshold of 70 points out of the 100 points.

Only RFQ submission that have met 70 points or exceeded the qualification threshold on technical functionality of points will be evaluated further on price and BBBEE for them to qualify to be appointed on a panel of recruitment agencies to for a period of three (3) years.

 - c. In the event that two or more bids have scored equal points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
 - d. However, when functionality is part of the evaluation process and two or more bids have scored equal points for B-BBEE, the successful bid must be the one scoring the highest score for functionality
 - e. Should two or more bids be equal in all respect, the award shall be decided by the drawing of lots.
