**CALL FOR PROPOSAL: AUDITING OF ELECTRICITY METERS AND IMPLEMENTATION OF THE TID ROLLOVER PROCESS IN THE CEDERBERG MUNICIPAL AREA FOR A CONTRACT PERIOD ENDING 30 JUNE 2024**

Cederberg Municipality invites tenders for contract no: CED 23/2021-2022 for the Call for proposal of auditing, electricity meters and implementation of the TID rollover process in the Cederberg Municipal Area for a contract period ending 30 June 2024.

Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data (Clause C.2.1) are eligible to submit tenders. It is estimated that tenderers should have a CIDB contractor grading designation of 6EP or higher.

Only locally produced or locally manufactured electricity meters (70%) with stipulated minimum thresholds for local production and content will be considered.

All bids received shall be evaluated in terms of the Cederberg Municipality's Supply Chain Management Policy, read with the Preferential Procurement Regulations of 2017. It is estimated that the 80/20 preference points system will be applicable. Tenders will be evaluated in terms of price and preference.

Tender documents, in English, are obtainable from Monday, 17 January 2022, at the reception of Cederberg Municipality, 2A Voortrekker Street, Clanwilliam, between 08:00 and 16:00 (Monday-Thursday) and Friday 08:00 - 14:00 and on E-tender website.
