2 PROPOSAL SUBMISSION

Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

- 4.6 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

The successful Respondent [hereinafter referred to as the [**Service provider**] shall be in full and complete compliance with any and all applicable laws and regulations.

7 EMPLOYMENT EQUITY ACT

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

8 DISCLAIMERS

Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Transnet reserves the right to:

- 8.1 modify the RFP's Goods/Services;
- 8.2 award a contract in connection with this Proposal at any time after the RFP's closing date;
- 8.3 award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP;
- 8.4 split the award of the contract between more than one Supplier/Service provider, as may be explicitly articulated in the conditions or objective criteria to this RFP;

- 8.5 cancel the bid process;
- 8.6 validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;

SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

1 BACKGROUND

Transnet Freight Rail owns and operates 47 diesel depots across the country. Each Depot has diesel storage tank and refuelling pumps with varied capacities for purposes of storing diesel and reticulating diesel into refuelling pumps used for the refuelling of diesel locomotives. Prior to 1 April 2010, the diesel storage facilities were not required to have a registration certificate in terms of the Atmospheric Pollution Prevention Act, 1965 ("APPA") since it was not regarded as a scheduled activity. On 22 November 2013, the Minister of Water and Environmental Affairs published the Notice which provided that an Atmospheric Emission License (AEL) is required where the threshold for the storing of fuel is more than 1000m^3 .

The storage and handling of petroleum products where the storage capacity exceeds 1000m³, is a listed activity in terms of the National Environmental Management: Air Quality Act No 39 of 2004 and requires an AEL. TFR has five Atmospheric Emission Licenses (AEL) with the conditions to monitor atmospheric emissions.

It is against this background that (TFR) seeks to appoint a competent Service Provider to monitor atmospheric emissions at five (5) selected diesel depots countrywide. These are:-

- i. iNsezi Depot (Kwa-Zulu Natal Province);
- ii. Millsite Depot (Gauteng Province);
- iii. Ermelo Depot (Mpumalanga Province);
- iv. Wentworth (Kwa-Zulu Natal Province); and
- v. Masons Mill (Kwa-Zulu Natal Province)

Each of the diesel storage tanks has a combined storage capacity greater than one thousand cubic metres (1000m³).

2 EXECUTIVE OVERVIEW

Whereas Transnet is seeking to appoint a suitably qualified Service Provider to conduct air quality monitoring at Transnet Freight Rail (TFR) diesel refuelling sites as required by the Atmospheric Emission Licenses (AELs) for a period of five (5) years, it also seeks to improve its current processes for providing these Services to its end user community throughout its locations.

The selected Supplier/Service provider(s) must share in the mission and business objectives of Transnet. These mutual goals will be met by meeting contractual requirements and new challenges in an environment of teamwork, joint participation, flexibility, innovation and open communications. In this spirit of partnership, Transnet and its Supplier/Service provider(s) will study the current ways they do business to enhance current practices and support processes and systems. Such a partnership will allow Transnet to reach higher levels of quality, service and profitability.

TFR also owns diesel storage tanks for refuelling of locomotives. Air quality monitoring in the surroundings of these tanks is required to meet legislative requirements.

Specifically, Transnet seeks to benefit from this partnership in the following ways:

- 2.1 Transnet must receive reduced cost of acquisition and improved service benefits resulting from the Supplier/Service provider's economies of scale and streamlined service processes.
- 2.2 Transnet must achieve appropriate availability that meets user needs while reducing costs for both Transnet and the chosen Supplier/Service provider(s).

- 3.1.3 To conduct air emission measurements in the manner that satisfy all the requirements of Annuexure E-Section 21 Schedule A **Methods for Sampling and Analysis** (Listed Activities and Associated Minimum Emissions Standards Identified in terms of Section 21 of the National Environmental Management: Air Quality Act, 2004 (Act No. 39 of 2004)

NB: All tests must be conducted by SANAS accredited laboratories.

3.2 TECHNICAL REQUIREMENTS

Qualified prospective service providers shall:

- 3.2.1 Submit CVs of at least Three (3) Project Team members including Team leader: CVs of project team members indicating experience in industrial air quality monitoring, air sampling, analysis, interpretation and report writing.
- 3.2.2 Submit certified copies of qualifications (not older than 3 Months) of Project Team Leader and other members indicating relevant professional training in the fields such as Environmental Management Meteorology, Environmental Sciences, Natural Sciences, Environmental Chemistry.
- 3.2.3 Submit valid certificates of SANAS Accredited Laboratories and analytical methodologies (NB: Expired SANAS certificates will not be considered for this Tender) to be used to conduct air analysis.
- 3.2.4 Submit Details at least 3 signed reference letters in a company letterhead details of their current and/or previous clients to whom the similar services have been rendered. TFR shall have the right to make contact with referenced clients to verify the nature and quality of the service provided.
- 3.2.5 Submit a detailed Project Proposal/ Methodology describing all activities to be conducted during the undertaking of this project starting from the sample collection, sample preservation and transportation to the laboratory, sample analysis, results interpretation and reporting. The methodology must cover details of relevant Personal Protective Equipment (PPE), apparatus and equipment to be used.

- 3.2.6 Submit an organogram of the Project Team showing its capacity to deliver the required services adequately.
- 3.2.7 Submit a Project Proposal describing the general project methodology regarding how the Scope of Work of the Project will be delivered.
- 3.2.8 Submit a Safety and Health Management Plan demonstrating compliance to all applicable legislative requirements.

3.3 **FUNCTIONAL REQUIREMENTS**

The successful Service Provider shall be required to deliver the following: -

To submit monthly Atmospheric Emissions Monitoring Reports for each refuelling site detailing the following reporting requirements: -

- 3.3.1 The name and description (including pictures, maps, etc.) of the locomotive diesel depot/ site;
- 3.3.2 The name and address of the accredited measurement laboratory that carried out or verified the emission test, including the test report produced by the accredited measurement laboratory.
- 3.3.3 The date and time on which the emission test was conducted.
- 3.3.4 A declaration to the effect that normal operating conditions were maintained during the emission tests.
- 3.3.5 The total volumetric flow of gas, expressed in normal cubic metres (Nm³) per unit time and mass flow (kg per unit time) being emitted by the listed activity or activities measured during the emission test, as the average of at least two (2) measurements.
- 3.3.6 The concentration or mass of pollutant for which emissions standards have been set as the average of at least two (2) measurements; each measured over a minimum sample period of 60 minutes and a maximum of 8 hours to obtain a representative sample.
- 3.3.7 The method or combination of methods used to determine the flow rate and concentration as contemplated in ANNEXURE E-Section 21 Schedule A **Methods for Sampling and Analysis; and**
- 3.3.8 Details of all instances where minimum emission standards were exceeded and remediation measures as well as associated implementation plans aimed at preventing recurrence of the exceedances.

3.4 The successful Service Provider shall be required to submit the Annual Project Report

The Successful Service Provider shall be required to submit a comprehensive annual report showing all the annual trends of parameters monitored over the period, and all non-compliances. The annual report shall be submitted at the period agreed with the successful Service Provider. The annual report will be submitted in electronic format.

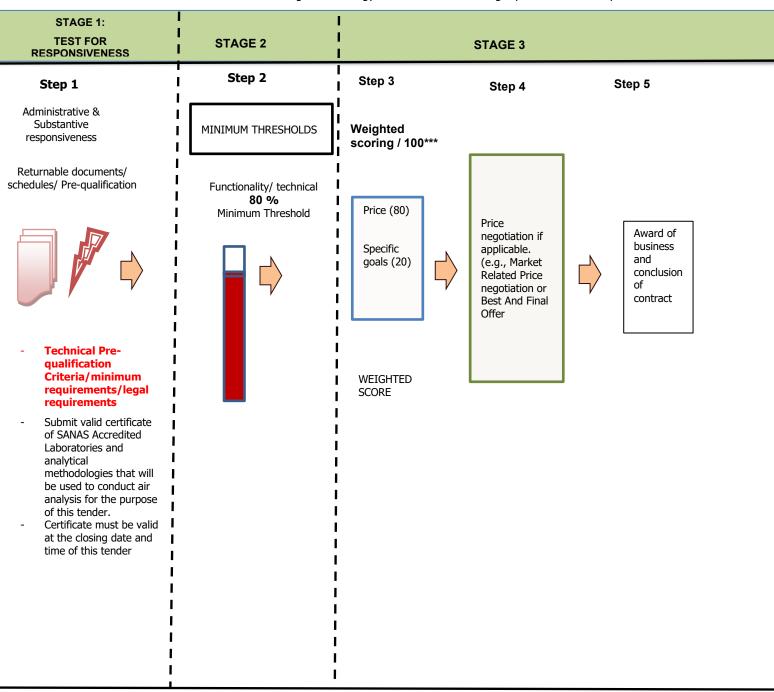
