CONSTRUCTION OF BERGSIG SPORTS FACILITY PHASE ONE

Laingsburg Municipality invites tenders for Tender No. T05 – 2023 / 2024 – Construction of Bergsig Sports Facility Phase One.

It is estimated that tenderers should have a CIDB contractor grading designation of **5CE** or higher.

Only tenderers who can demonstrate that they will have, in their employ, staff who satisfy EPWP requirements during the contract validity are eligible to submit tenders.

Only tenders with a functionality score of a minimum of **60** out of **100** will be considered further for evaluation.

Completed tenders in a sealed envelope endorsed with “**Tender T05 - 2023/2024 – Construction of Bergsig Sports Facility Phase One**” must be placed in the tender box in the foyer between 08H00 – 15H00 at the Municipal Buildings, 02 Van Riebeeck Street, Laingsburg to reach the Municipal Manager not later than **12:00 p.m.** on **10 November 2023**, after which tenders will be opened in public.

Tenders may only be submitted on the prescribed tender documents that are obtainable from **23 October 2023**, starting at 08h00 at Laingsburg Municipality, 02 Van Riebeeck Street, Laingsburg, 6900, during office hours (08h00 – 15h00) or at WEC Consult, Unit 24, Oewerpark, Rokewood Road, Die Boord, Stellenbosch, 7613.

A compulsory briefing session will be held at **11:00 a.m.** on **Friday, 27 October 2023**, at the EE Centre, Meiring Street, Laingsburg (-33.197890, 20.856644). No grace period will be allowed.

Tenderers must be represented at the site visit/clarification meeting by a suitably qualified and experienced person to comprehend the implications of the work involved. The representative must be an employee of the Tenderer. No representative at the meeting may represent more than one Tenderer.

A non-refundable participation fee of **R 500-00 (Five Hundred Rand)** will be applicable. The participation fee must be deposited into the account of the Laingsburg Municipality at **Standard Bank**, Branch Code **51108**, Account Number **203 247 663**. The reference number for payment confirmation is **T05-2023/2024 - Company Name**.

The **bid must be valid for a period of 90 days** after the closing date. The bid will be subject to the Council's Supply Chain Management Policy, the Municipal Preferential Procurement Policy, and the Preferential Procurement Regulations, 2022.

Telegraphic, telephonic, facsimile, emailed, and late bids will not be accepted.
