Advertised Formal Quotations: RFQ: 10 till 11/07/2022 will be evaluated in terms of **80/20** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (Act 5 of 2011) and the Municipality's Supply Chain Management Policy. Further, that valid proof of previous experience (concerning this request) must be submitted with the document.
