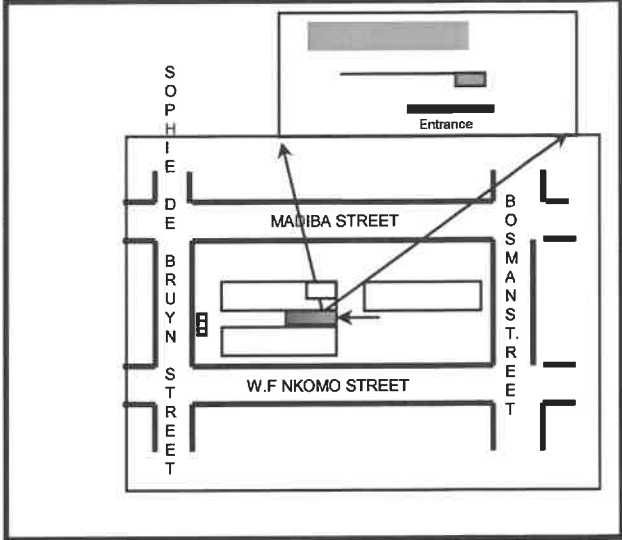

1. INTRODUCTION

- 1.1 This quotation and all contracts emanating there from will be subject to the General Conditions of Contract issued in accordance with Treasury Regulation 16A published in terms of the Public Finance Management Act, 1999 (Act 1 of 1999).
- 1.2 The Special Conditions of Contract are supplementary to that of the General Conditions of Contract. Where, however, the Special Conditions of Contract are in conflict with the General Conditions of Contract, the Special Conditions of Contract prevail.
- 1.3 These conditions form part of the quotation and bidders need to familiarize themselves with the content thereof.

2. REGISTRATION ON CENTRAL SUPPLIERS DATABASE

- 2.1 Bidders need to register on the National Treasury Central Supplier Database in order to do business with the state. Accounting Officers cannot award any bid or price quotation to any supplier who is not registered on the Central Suppliers Database. Bidders must log on www.csd.gov.za for self registration.

3. CERTIFICATION OF DOCUMENTS BY A COMMISSIONER OF OATH

- 3.1 Bidders must ensure that all certified copies comply with the regulation governing the administering of an oath or affirmation. The Commissioner of Oath must append a signature, date and also print out name. Copies that do not comply with this regulation will be regarded as invalid.
- 3.2 **The date of certification of the original on all copies submitted should not be older than six (6) months.**

4. CONTRACT PERIOD

- 4.1 The contract period shall be for a period of six (6) months after the signing of the contract for appointment of service provider (s) for supply, delivery and off-loading fertilizer to various correctional centre farms.
- 4.2 The department reserve the right to terminate this contract within the six months of the contract and will purchase items as and when the need arises.



5. QUANTITIES

- 5.1 The quantities furnished in the quotation are **estimated quantities** and no guarantee can be given regarding the actual quantities that will be ordered. The fertilizer will be ordered as when required by DCS.

6. RESPONSE FIELDS

- 6.1 It is imperative that bidders submit responsive quotations by completing all mandatory response fields and item questionnaires for the individual items. In this regard bidder's attention is drawn to the response field and price structure explanations and examples supplied in the quotation document.
- 6.2 Quotation documents should not be retyped or redrafted.
- 6.3 The following quotation documents must be completed in black ink, signed and submitted **in an original format**:

- 6.3.1 Bidder must complete pricing schedules on SBD 3.1.
- 6.4 Bidders shall check the numbers of the pages and satisfy themselves that none are missing or duplicated in line with the index provided. No liability shall be accepted with regard to claims arising from the fact that pages are missing or duplicated.

7. EVALUATION CRITERIA

The evaluation process will be conducted in two (2) phases as follows:

7.1 **Phase 1: Mandatory Requirements**

7.1.1 **CSD Registration**

7.1.1.1 Bidder must be registered on the **Central Supplier Database (CSD)** and provide its CSD number and TCS Pin as per SBD 1.

7.1.1.2 When a Consortium/ Joint Venture/ Sub-contractors is involved, each party must be registered on the Central Suppliers Database and their tax compliance status will be verified through the Central Suppliers Database.

7.1.2 **Certificate: Confirmation of supply arrangements between the bidder and his/her supplier (BD 27)**

7.1.2.1 Any bidder who does not normally keep stock of the item and is sourcing the goods and services from a third party (manufacturer/producer or dealer/distributor who normally keeps stock) for the purpose of delivering the item to the Department, must ensure that the attached BD 27 is completed by his/her supplier after they have familiarised themselves with the item(s) / description(s) / specifications and conditions of the quotation for all relevant goods and services required from this quotation.

7.1.2.2 List of item (s) numbers, item description and brand name must be attached with BD 27. The list must have a letterhead of the bidder's supplier and it must be signed. The date on the list must not be older than the date of the advertisement .

7.1.2.3 Third parties must especially acquaint themselves with the conditions applicable to price increases.

7.1.2.4 If a contract has been concluded on the basis of sourcing the product(s) from a manufacturer/dealer, distributor and the bidder for some or the other reason change the manufacturer/dealer, the Department should immediately be notified and a new BD 27-form (confirmation of supply arrangements between the bidder and his/her supplier) should be submitted.

7.1.2.5 The Department will only accept an original or certified copy of the completed and signed BD 27 and it must be attached with the standard bidding documents. **Failure to submit a signed (BD 27) signed by the bidder and his/her supplier will invalidate the quotation.**



7.1.2.6 An original signed letter issued on the official letterhead of the third party addressing the information below is acceptable.

7.1.2.6.1.1 List of item (s) numbers, item description and brand name must be attached with BD 27. The list must have a letterhead of the bidder's supplier and it must be signed. The date on the list must not be older than the date of the advertisement .

7.1.2.6.1.2 The date of letter must not be older than the date of the advertisement of this quotation and must clearly indicate the information of this quotation.

7.1.2.6.1.3 The bidder must ensure that the supply arrangements for the required goods and services have been mutually agreed upon with his/her supplier. No agreement between the bidder and his/her supplier will be binding on the Department.

7.1.2.6.1.4 The Department reserves the right to verify any information supplied by the bidder and should the information be found to be false or incorrect, it will invalidate your quotation.

7.1.3 Specifications

7.1.3.1 Bidders are required to comply with the attached National Department of Correctional Services Product Specification.

7.1.4 Legislative and regulatory requirements

7.1.4.1 Fertilizer offered must be registered in terms of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act (Act No.36 of 1947) as amended and all further regulations issued in terms of the said Act.

7.1.4.2 The following documentation must be submitted with the quotation documents:

7.1.4.2.1 Bidders must submit a valid registration certificate for each fertilizer item, formulation offered or an approved application for renewal of registration certificate for fertilizers issued by the Department of Agriculture, Land Reform and Rural Development on or before the closing date and time of quotation.

7.1.4.2.2 The bidder must submit the copy of **composition/product labels and attach to the registration certificate** for all item's offered at



the closing date and time of quotation. The registration number on the certificate must correspond with the number on the composition/product labels.

7.1.4.2.3 Items that are not registered with Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act (Act No.36 of 1947) as amended will not be considered for further evaluation.

7.1.5 References

7.1.5.1 Please submit atleast one signed reference letter with a contactable details of current and previous clients for the supply and delivery of agricultural products and production inputs to any private organisation, government departments and/or municipality where business was gained in the last (3) three years by means of a price quotation/bidding process.

7.1.5.2 Reference letters from clients must be **on the letterhead of the client and** must be signed, the date must not be older than three (3) years of advertisement date.

7.1.6 Bidding for item.

7.1.6.1 Bidder need to bid for all sub-items per item. Quotation will be awarded per item, failure to do so it will invalidate your quotation.

7.1.7 Failure to comply with all mandatory requirements stipulated in paragraph 7 will invalidate your quotation.

7.2 Phase 2: Price and Specific goals

7.2.1 In terms of Regulation of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), responsive bid will be adjudicated by the Department on the **80/20-preference** point system in terms of which points are awarded to bidders based on:

- a) **Bid price (maximum 80 points)**
- b) **Specific goals (maximum 20 points)**

7.2.2 The following formula will be used to calculate the points for price:

7.2.4 The following documentary proof must be submitted to claim for specific goals:

7.2.4.1 Women: To submit either the signed affidavit (signed off by SAPS) confirming gender OR BBBEE certificate OR Sworn Affidavit as per DTI prescribed template.

7.2.4.2 Disability: Medical certificate signed by the doctor.

7.2.4.3 Black: To submit either the signed affidavit (signed off by SAPS) confirming race OR BBBEE certificate OR Sworn Affidavit as per DTI prescribed template.

7.2.4.4 Youth: To submit either the Certified Identity document OR BBBEE certificate OR Sworn Affidavit as per DTI prescribed template.

Note: For a bidder to qualify for preference points, ownership of 51% or more per procurement goal/historically disadvantaged individual must be obtained.

7.2.5 The date of certification of documents should not be older than six (6) months.

7.2.6 The points scored by a bidder in respect of specific goals will be added to the points scored for price.

7.2.7 The points scored will be rounded off to the nearest 2 decimals.



8. **VALUE ADDED TAX**

- 8.1 All quotation prices are inclusive of 15% Value Added Tax (VAT), except in the case of a person that is not required to register for Value Added Tax.

9. **BIDDER'S DISCLOSURE (SBD 4)**

- 9.1 It is important that bidders acquaint themselves with the content of the Bidder's disclosure (SBD 4).
- 9.2 The Bidder's disclosure (SBD 4) must be completed in full.
- 9.3 Declarations of any nature will not necessarily prejudice any bidder, however should a bidder knowingly submit false declarations, this Department will act against such bidder (company) and/or its Directors in terms of paragraph 23 of the General Conditions of Contract.

10. **PARTICIPATION OF GOVERNMENT OFFICIALS IN THE BIDDING PROCESS**

- 10.1 In accordance with Sections 118 and 121 of the Correctional Services Act, 1998 (Act 111 of 1998), no member of the Department of Correctional Services may participate in the bidding process of the Department.
- 10.2 **The Public Administration Act, 2014 (Act no. 11 of 2014), chapter 3, section 8(2)(a) specifies that an employee of the State may not conduct business with the State.**
- 10.3 Bidders having a kinship with persons employed by the state, including a blood relationship, must declare their interest on the SBD 4 (Declaration of Interest).

11. **FRONTING**

- 11.1 The Department of Correctional Services supports the spirit of Broad Based Black Economic Empowerment and recognizes that real development can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in:
- a) An honest, fair, equitable, transparent and legally compliant manner. Against this background the Department of Correctional Services condemn any form of fronting.



- b) The Department of Correctional Services, in ensuring that bidders conduct themselves in an honest manner will as part of the quotation evaluation processes, conduct or initiate the necessary enquiries, investigations to determine the accuracy of the representations made in the quotation documents.

- 11.2 Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry, be established during such enquiry/ investigation, the onus will be on the bidder/ contractor to prove that fronting does not exist. Failure to do so within a period of 14 days from the date of notification may invalidate the quotation/ contract and may also result in the restriction of the bidder/ contractor to conduct business with the public sector for a period not exceeding ten (10) years, in addition to any other remedies the Department may have against the bidder/ contractor concerned.

12. PRICE AND PRICE QUALIFICATION

- 12.1 Prices submitted for this price quotation are firm.
- 12.2 Prices shall be quoted in South African currency.
- 12.3 The price quotation prices shall be given in the units **shown on the pricing schedule**.
- 12.4 Prices must be inclusive of delivery cost and all applicable taxes.

13. SUBMISSION OF QUOTATIONS

- 13.1 Each quotation should be submitted in a sealed envelope or suitable cover on which the name and address, the quotation number and the closing date must be clearly endorsed. The bidder must submit one original document.

14. LATE QUOTATIONS

- 14.1 Quotations received after the closing date and time, at the address indicated in the quotation documents, will not be accepted for consideration and where possible, be returned unopened to the bidder.

15. COMMUNICATION

- 15.1 The Department may request clarification regarding information provided by bidders. Bidders are to supply the required information within the specified period. Failing to do so will invalidate your quotation.



16. COUNTER CONDITIONS

- 16.1 Bidder's attention is drawn to the fact that amendments to any of the Quotation Conditions or setting of counter conditions by bidders will result in the invalidations of such quotations.

17. DUE DILIGENCE

- 17.1 The Department reserves the right to confirm the ability of bidders to execute this contract successfully.
- 17.2 The premises/factory of the bidder or manufacturer should be open at all reasonable hour for inspection by a representative of the Department and/or its approved institution.
- 17.3 Due diligence will be conducted to ensure ability and capability of the shortlisted bidder to supply and deliver the fertilizer to various Correctional farms.
- 17.4 Due diligence will be applied to ensure that prices are market related and aligned to the department requirements.
- 17.5 **Should the bidder not cooperate in any of these matters and/or do not have the capability to execute the contract his/her offer will be regarded as not acceptable.**

18. NEGOTIATIONS

- 18.1 The Department reserves the right to negotiate price with bidders prior to the award of the quotation.

19. AWARD CONDITIONS

- 19.1 Multiple award

- 20.1.1. The state reserves the rights to award the same item to more than one suppliers to address product availability and compatibility.
- 20.1.2. The following will be taken into consideration when awarding through a multiple award:

- Capacity to meet volume demand as per quotation requirements.
- Estimated volume to be supplied.



- Risk to the department if the item is not available.
- Source of the finished product, raw material and manufacturing side.
- Proof of the previous performance of the bidder.

20. **ORDERS/DELIVERIES/DELIVERY BASIS**

- 20.1 Before delivery of any product on this contract is conducted, the contractor must be in possession of an official order issued by an authorized official of the Department.
- 20.2 The contractors should note that the order(s) will be placed as and when it is required during the duration of the contract period and delivery points will be specified by the relevant purchasing management areas.
- 20.3 The instruction appearing on the order form regarding the supply, dispatch and submission of invoices must be strictly adhered to and no circumstances should the contract deviate from the order issued by the management areas.
- 20.4 **Products must be delivered and off loaded by the contractor in the transit area of the delivery point.**
- 20.5 Delivery will be accepted on weekdays **between 8:00 and 14:00.**
- 20.6 All deliveries and dispatches must be accompanied by a delivery note stating the official order number against which the delivery is affected.
- 20.7 The bidder will be responsible for off-loading of fertilizers to the respective Correctional Centre farms stores.
- 20.8 Items delivered not complying with the order/specifications will be returned to the contractor at the contractor's expense.
- 20.9 The Department of Correctional Services may postpone or delay deliveries if it finds itself in any such position, as a result of circumstances beyond its control, which will make it impossible to comply with the specified delivery dates.

21. **CONTRACT MANAGEMENT**

- 21.1 The contractor shall not abandon, transfer, assign or sublet a contract or part thereof without the prior written approval from the Department.
- 21.2 Contractor must inform DCS immediately when unforeseeable circumstances will adversely affect the execution of the contract. Full particulars of such circumstances as well as the period of delay must be furnished.



- 21.3 **Should the bidder change the supplier (as per submitted BD 27) during the duration of the contract, the bidder must notify Directorate Contract Management in writing and further submit a signed BD 27 between bidder and the new supplier as well as required documents as indicated on paragraph. (DCS reserve the right to inspect the products in this quotation on the premises of the supplier of the bidder)**

22. **PENALTIES**

- 22.1 The Department will impose a penalty as a result of unsatisfactory performance (e.g. poor quality, late delivery, non-delivery, etc.)

- 22.2 The following formula will be utilized for this purpose :

$$Penalty = \left(Vx \frac{10}{100} \right) x N$$

V = Value of delayed goods or services

N = Number of days of delay

- 22.3 A penalty will be limited to 30% of the value of delayed goods or services. In addition to a penalty being imposed, the Department reserves the right to act in accordance with paragraph 21.6 of the General Conditions of Contract (GCC), which reads "Upon delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier."

- 22.4 The Department may terminate the contract at its sole discretion due to unsatisfactory performance (e.g. poor quality, late delivery, non-delivery, etc.) during the window period of two months, following the occurrence of the unsatisfactory performance.

23. **PAYMENTS**

- 23.1 Payments will only be effected by the Department in the following cases:

- 23.1.1 The successful completion of a deliverable/ service in line with the specification/ terms of reference.



23.1.2 Invoices should be delivered/posted or e-mailed to reach the institution that placed the order, timeously.

23.1.3 The invoices must be accompanied by an inspection certificate and/or proof of delivery.

23.2 Companies not registered in terms of Value Added Tax, may not claim VAT on invoices.

24. **SETTLEMENT OF DISPUTES**

24.1 Should any dispute arise from the contract paragraph 27 of the General Conditions of Contract shall apply.
