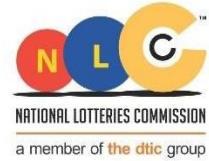

SECTION 1: BACKGROUND AND OVERVIEW

1. INTRODUCTION

- 1.1. The National Lotteries Commission was established in terms of the Lotteries Act No. 57 of 1997, as amended (Lotteries Act) to regulate the National Lottery as well as other lotteries and societies.
- 1.2. The NLC has undergone a transition that was underpinned by changes that brought a new dawn of rebuilding and restoring the integrity of the organisation. Earlier in the 2023/24 financial year, the new Commissioner and new Board members were appointed to steer the ship into a new direction. The Department of Trade, Industry and Competition (DTIC) as the shareholder also introduced the ministerial impact targets, which have a huge direct and indirect impact on the Strategic Plan of the organisation.

2. BACKGROUND

- 2.1. The NLC, being a public entity, is given the opportunities for its employees to further acquire knowledge about the challenges pertaining to governance, ethical conduct and the required behavioural competencies when dealing with public funds, such as engagements with the current NLC-funded organisations as well as the potential beneficiaries to fund in the future.

3. OBJECTIVES

- 3.1. The objective is to conduct the Annual Lecture for the National Lotteries Commission (NLC) employees. The Annual Lecture Sessions will be conducted as and when required. The Annual Lecture sessions will be accessible to a multitude of social media platforms such as the following:
 - YouTube Channels
 - Webinars

4. SCOPE OF WORK

The appointed Service Provider will be responsible for the following tasks as per the process- flow depicted herein:

- 4.1. To source for the appointment of speakers to participate in the critical dialogue series involving the NLC employees from 1st Quarter to 4th Quarter (2025/26).
- 4.2. The Annual Lecture role is to encourage the NLC to initiate discussions on issues that affect the organisations.
- 4.3. The Annual Lecture sessions will be conducted during working days, from the 2nd week of the month after the appointment of the successful service provider.
- 4.4. The Annual Lecture sessions should have an on-demand video streaming capability for conducting live sessions. It should also have provision for two-way real-time audio and video chat support.

5. DELIVERABLES

The appointed service provider is expected to deliver the following:

- 5.1. Appointment of Speakers to participate in the Annual Lecture from 1st Quarter to 4th Quarter (2025/26).
- 5.2. Discussions should be held on different social media platforms (Youtube channel and Webinar)
- 5.3. The proposed topics include:
 - Unpacking of Ethical and Transformational Leadership within the NLC context.
 - Professionalization of NLC, especially Grant Making & Regulatory Compliance
 - Addressing of underperformance and toxic working environment
- 5.4. Key Responsibilities
 - Demonstrate, through a detailed proposal outlining a clear methodology that has the necessary skills, competencies, and experience to undertake this assignment.
 - Provide evidence (including contactable references) of previous experience in implementing Annual Lecture Sessions.
 - Demonstrate an intimate understanding of the research environment and be willing to tailor-make and customize the system to suit NLC needs.
 - Annual Lecture solution
 - Partner with NLC for the duration of the contract to ensure optimal utilization and business impact.

6. DURATION OF THE ANNUAL LECTURE SESSIONS

- 6.1. The total duration of the proposed Annual Lecture Sessions will be for a minimum of 1 day per quarter. - from the 1st Quarter to the 4th Quarter (2025/26) on an “as and when required” basis.

7. FORMAL BRIEFING SESSION

- 7.1. No briefing session.

8. VALIDITY PERIOD

- 8.1. The Commission requires a validity period of 120 Days [from the closing date] against this RFQ.
- 8.2. Bidders are to note that they may be requested to extend the validity period of their bids, on the same terms and conditions. A written letter will be sent through to every bidder that responded to the bid. In terms of procedural fairness, the bidders will be given an opportunity to respond, in writing, to the terms and conditions of the bid and the bid price. Such acceptance of the terms and conditions of bid and bid price becomes legally binding in the procurement process. Any bidder, that did not respond to the extension of the bid validity period, in writing, WILL NOT be considered further for the bid upon expiry of the initial validity period.

SECTION 2: NOTICE TO BIDDERS

9. TERMS AND CONDITIONS OF REQUEST FOR QUOTATION (RFQ)

- 9.1. This document may contain confidential information that is the property of the NLC.
- 9.2. No part of the contents may be used, copied, disclosed, or conveyed in whole or in part to any party in any manner whatsoever other than for preparing a proposal in response to this RFQ without prior written permission from the NLC.
- 9.3. All copyright and intellectual property herein vests with the NLC.
- 9.4. Late and incomplete submissions will not be accepted.
- 9.5. No services must be rendered, or goods delivered before an official NLC Purchase Order form has been received.
- 9.6. This RFQ will be evaluated in terms of the 80/20 preference point system, where 80 is price and 20 is special goal.
- 9.7. Suppliers are required to register on the Central Supplier Database at www.csd.gov.za.
- 9.8. Suppliers must provide their CSD registration number (and attach a CSD Registration report) and ensure that their tax matters are compliant.
- 9.9. All questions regarding this RFQ must be forwarded to penelope@nlcsa.org.za.
- 9.10. Any supplier who has reasons to believe that the RFQ specification is based on a specific brand must inform the NLC via the email addressed in 1.9.

10. GENERAL RULES AND INSTRUCTIONS

10.1. News and press releases

- Bidders or their agents shall not make any news releases concerning this RFP or the awarding of the same or any resulting agreement(s) without the consent of, and then only in co-ordination with, the NLC.

10.2. Precedence of documents

- This RFQ consists of a number of sections. Where there is a contradiction in terms between the clauses, phrases, words, stipulations, or terms and herein referred to generally as stipulations in this RFQ and the stipulations in any other document attached hereto, or the RFQ submitted hereto, the relevant stipulations in this RFQ shall take precedence.
- Where this RFQ is silent on any matter, the relevant stipulations addressing such matter, and which appear in section 217 of the constitution of the republic shall take precedence. Bidders shall refrain from incorporating any additional stipulations in its proposal submitted in terms hereof other than in the form of a clearly marked recommendation that the NLC may in its sole discretion elect to import or to ignore. Any such inclusion shall not be used for any purpose of interpretation unless it has been so imported or acknowledged by the NLC.
- It remains the exclusive domain and election of the NLC as to which of these stipulations are applicable and to what extent. Bidders hereby acknowledging that the decision of the commission in this regard is final and binding. The onus to enquire and obtain clarity in this regard rests with the Bidder(s). The Bidder(s) shall take care to restrict its enquiries in this regard to the most reasonable interpretations required to ensure the necessary consensus.

10.3. Preferential procurement reform

- The Commission supports B-BBEE as an essential ingredient of its business. In accordance with government policy, the NLC insists that the private sector demonstrates its commitment and track record to B-BBEE in the areas of ownership (shareholding), skills transfer, employment equity and procurement practices (SMME Development) etc.

10.4. Language

- Bids shall be submitted in English.

10.5. Gender

- Any word implying any gender shall be interpreted to imply all other genders.

10.6. Headings

- Headings are incorporated into this RFQ document and submitted in response thereto,

for ease of reference only and shall not form part thereof for any purpose of interpretation or for any other purpose.

10.7. Occupational Injuries and Diseases Act 13 of 1993

- The Bidder warrants that all its employees (including the employees of any sub-contractor that may be appointed) are covered in terms of the Compensation for Occupational Injuries and Diseases Act 13 of 1993 and that the cover shall remain in force for the duration of the adjudication of this RFP and/ or subsequent agreement. the commission reserves the right to request the Bidder to submit documentary proof of the Bidder's registration and "good standing" with the Compensation Fund, or similar proof acceptable to the commission.

10.8. Processing of the Bidder's Personal Information

- All Personal Information of the Bidder, its employees, representatives, associates and sub-contractors ("Bidder Personal Information") required under this RFP is collected and processed for the purpose of assessing the content of its tender proposal and awarding the bid. The Bidder is advised that Bidder Personal Information may be passed on to third parties to whom the commission is compelled by law to provide such information. For example, where appropriate, the commission is compelled to submit information to National Treasury's Database of Restricted Suppliers.
- All Personal Information collected will be processed in accordance with POPIA and with the commission Data Privacy Policy.
- The following persons will have access to the Personal Information collected:
 - The commission personnel participating in procurement/award procedures; and
 - Members of the public: within seven working days from the time the bid is awarded, the following information will have to be made available on National Treasury's e-Tender portal:
 - contract description and bid number.
 - names of the successful bidder(s) and preference points claimed.
 - the contract price(s) (if possible).
 - contract period.
 - names of directors; and
 - date of completion/award.
- The commission will ensure that the rights of the Bidder and of its employees and representatives (i.e., the right of access and the right to rectify) are effectively guaranteed in accordance with the procedures specified in the commission PAIA manual.
- In signing this document, the Bidder consents to the use of its Personal Information for the purposes as specified in section 2.9.1 above.

11. NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

- 11.1. Bidders are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information.
- 11.2. The Commission may not award business to a bidder who has failed to register on the CSD.
- 11.3. Only foreign suppliers with no local registered entity need not register on the CSD.

12. CONFIDENTIALITY

- 12.1. Bids submitted for this Request for Proposals will not be revealed to any other bidders and will be treated as contractually binding.
- 12.2. The Commission reserves all the rights afforded to it by the POPIA in the processing of any of its information as contained in Bid Proposals
- 12.3. The Bidder acknowledges that it will obtain and have access to personal information of The NLC and agrees that it shall only process the information disclosed by the NLC in terms of this bid award and only for the purposes as detailed in this RFP and in accordance with any applicable law.
- 12.4. The Bidder shall notify the NLC in writing of any unauthorized access to personal information and the information of a third party, through cybercrimes or suspected cybercrimes, in its knowledge and report such crimes or suspected crimes to the relevant authorities in accordance with applicable laws, after becoming aware of such.

13. COMMUNICATION

- 13.1. Specific queries relating to this RFQ should be submitted quotation@nlcsa.org.za, before the closing date.
- 13.2. In the interest of fairness and transparency the NLC's response to such a query may be made available to other bidders.
- 13.3. It is prohibited for bidders to attempt, either directly or indirectly, to canvass any officer or employee of the NLC in respect to this RFQ between the closing date and the date of the award of the business.
- 13.4. Bidders found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

14. SUPPLIER PERFORMANCE

- 14.1. The National Lotteries Commission conducts regular performance reviews in accordance with

the requirements for the classification of the contract and or stakeholder by making use of supplier evaluation forms. The evaluation is conducted against the deliverables or scope of the contract with a minimum of an annual review done for contracts longer than a year and a review at completion of contract for those contracts less than a year.

- 14.2. Ad-hoc performance reviews shall be conducted where non-performance is identified outside the review period.
- 14.3. Non-performance will be addressed with at least a formal letter advising specific non-performing areas and stating remedial action/s required within specific time frames. Non-adherence to remedial actions shall lead to escalating performance management actions.

SECTION 3: EVALUATION CRITERIA

15.2. Bid Formats

- Bid submissions must be submitted in a PDF format that is protected from any modifications, deletions, or additions.
- Financial/pricing information must be presented in a separate attachment from the Technical/Functional Response information. The onus is on the Bidder to ensure that all mandatory and required documents are included in the electronic submission.
- Submissions must be prominently marked with the full details of the tender namely Bidder's Name, Tender No and Tender Title.
- Tender submissions received after submission date and time will be declared late and will not be accepted for consideration by the NLC.
- The NLC will not be responsible for any failure or delay in the submission or receipt of the bid including but not limited to:
 - Traffic.
 - Struggling to find parking.
 - Courier arriving late.
