1. GENERAL / BACKGROUND

- 1.1 The South African Diamond and Precious Metals Regulator (SADPMR) is a state-owned entity which is based in Gauteng Industrial Development Zone (GIDZ) in Bonaero Park, Kempton Park. The SADPMR would like to enter into a contract with a reputable company that will be able to provide a synthetic testing machine. The appointed service provider will be providing these services for the Diamond Valuers which is a division within the SADPMR. The detecting devices should be able to guarantee the integrity of natural vs synthetic diamond trade that is facilitated and verified by the SADPMR.

2. PROJECT SCOPE

2.1 DELIVERY OF TWO (2) SYNTHETIC DIAMOND TESTING MACHINES WITH THE FOLLOWING FEATURES:

A. FEATURES

- Scanning 3-inch diameter area in 45 to 60 seconds
- Identifying both CVD and HPHT laboratory grown diamonds
- Loose diamonds of any shape
- Identifying diamonds from 0.003 carats and larger
- Primarily D through K colours, including fancy coloured stones

B. ACCESSORIES

- It must have 2 loose diamond trays
- 1 external fluorescent light
- 1 software security USB key
- Wireless keyboard and mouse

- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 6.1, the contractor may be required to furnish documentary proof to the satisfaction of the purchaser that the claims are correct;
- iv) If the B-BBEE status level of contributor has been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the purchaser may, in addition to any other remedy it may have –

- (a) disqualify the person from the bidding process;
- (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
