TERMS OF REFERENCE FOR PREPARATION AND UPDATING OF GRAP COMPLIANT FIXED ASSETS REGISTER FOR A PERIOD OF 24 MONTHS

SCOPE OF WORK

Elias Motsoaledi Local Municipality hereby requests proposals from suitably qualified and experienced service provider for preparation and updating of GRAP Compliant Fixed Assets Register for a period of 24 months

1. Purpose

To provide services of a suitably qualified and experienced service provider for preparation and updating of GRAP Compliant Fixed Assets Register. The service provider will be required to compile a Fixed Assets Register in compliance with GRAP.

2. Background

The Municipality, Budget and Treasury department performed need analysis on Assets Management and discovered the following:

- Staff shortage in the Assets management section, which leads to lack of capacity to perform some of the duties, assigned to Assets management.
- Lack of technical resources and physical verification systems to effectively perform Infrastructure assets verification.
- Non provision of GIS to effectively perform Infrastructure assets verification underground
- Lack of expertise to perform assets condition assessments.
- Lack of skills and expertise to perform landfill rehabilitation provisions:
 - Obtain the closure calculations for the landfill sites done in the previous year
 - Perform a desktop airspace calculation of each of the landfill sites
 - Draft the journals to be passed to ensure that the rehabilitation of landfill site liability as per valuation report agrees to that of the general ledger accounts
 - Present and disclose all the information in the financial statements in accordance with GRAP 19: Provisions, Contingent liabilities and assets

3. Objectives

- Appoint a service provider for the preparation and updating of the Fixed Assets Register in compliance and in accordance with GRAP.
- To improve Assets management performance.
- To improve and properly accounting for Fixed assets in the Annual Financial Statement.

4. Scope of the project

Preparation and Updating of GRAP Compliant Assets Register

- To review a compiled Fixed Asset, Register as at 30 June each year,
- Physical identification and verification of all immovable assets (Land, Buildings, Infrastructure asset, etc.) owned and controlled by the municipality. All roads and roadside assets need to be physically verified each reporting period and no “desktop”, aerial, or GIS verification will be accepted,
- Provide GIS shape files of all physical immovable assets
- Perform verification on the underground Municipal Assets (Storm water and Electrical cables)
- Provide a map of the infrastructure network
- Conduct physical conditional assessment of all municipal assets and review impairment report (testing for impairment and reviewing impairment calculations, including impairment methodology)
- Provide Municipal assets verification system and Handheld verification devices needed to make use of built in GPS receivers and have capability to scan barcodes used by the municipality.
- Compiling a list of all missing or unverified assets. Ensure that the required adjustments regarding de-recognition are captured in the asset register and recommend necessary journals,
- Prepare an investigation report based on the missing or unverifiable assets during physical verification.
- Ensure that municipal officials are trained on job and skills is transferred to officials throughout the contract period,
- Prepare methodology documentation and present to the Municipality,
- Assist with communication of audit finding responses (Resolve the findings raised both current and prior year),
- Assess Landfill Sites and Compile a Landfill Closure Rehabilitation report for each reporting period

5. PROJECT TIMEFRAME

The project timeframe is expected to be over a period of 2 years
