## 1. INTRODUCTION TO THE NRF

The National Research Foundation Act as amended, Act 19 of 2018, establishes the National Research Foundation (“NRF”) as the juristic legal entity that will contract with the awarded bidder. Please visit the NRF website (<https://www.nrf.ac.za>) for more information.

## 2. BACKGROUND TO SARAO

The South African Radio Astronomy Observatory (SARAO) is the National Research Foundation’s National Facility incorporating South Africa’s radio astronomy instruments and programmes such as the MeerKAT and KAT-7 telescopes in the Karoo in the Northern Cape, the Hartebeesthoek Radio Astronomy Observatory (HartRAO) in Gauteng, the African Very Long Baseline Interferometry (AVN) programme in nine African countries as well as the associated human capital development and commercialisation endeavours. ## 3. CONTEXT OF THE PROCUREMENT NEEDED

The SKA Phase 1 (SKA1\_MID) project in the Karoo will comprise 197 telescopes, once completed. The SKA1\_MID footprint covers over 400 000 ha of land in the Karoo, Northern Cape of which approximately 135 000 ha is owned by the National Research Foundation (NRF). The remaining land is being secured through servitude agreements. Currently, of the 197 telescopes, 64 have already been constructed and are operational. These 64 telescopes make up the MeerKAT project array. Originally MeerKAT was developed as a precursor project to the SKA project, but it has since been decided to incorporate this instrument as part of the SKA1\_MID array.

To assist in the land management requirements, environmental monitoring and the monitoring of construction and operational activities on this vast expanse of land covered by the project, SARAO intends to invest in drone applications. This RFQ is for the supply of Remotely Piloted Aircraft (RPA)/drone equipment to allow for effective and efficient drone application for SARAO requirements.

## 4. DETAILED SPECIFICATION

The required drone equipment will enable those SARAO employees with Remote Pilot Licenses (RPLs) to: capture aerial imagery, undertake surveys, monitor and manage various project activities within the land management and construction planning function of the organisation.

SARAO requires the following multi-rotor drone and support equipment:

- DJI Matrice350 RTK (Inc. 2x controllers, attachments and protective casing)
- Intelligent Battery Station
- Intelligent flight batteries (x8 batteries)
- GNSS Mobile Station for Matrice series (Inc. tripod and protective case)
- Landing pad
- Compatible MicroSD cards (x2 1TB)
- Product training and product commissioning and testing with payloads
- Payloads (compatible with Matrice350 RTK) and protective casing:
  - Zenmuse H20 camera; and
  - Zenmuse P1 camera

As part of the bid, respective bidders will need to include:

- A project schedule indicating project lead times for delivery of all equipment;
- Indicate available warranties and/or service plans for the equipment specified above; and
- Provide a maintenance and service schedule for the equipment specified above.

    - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
    - (e) forward the matter for criminal prosecution, if deemed necessary.
