

## CALL FOR PROPOSAL DUBE TRADEPORT CORPORATION

### CALL FOR PROPOSAL (CFP) FOR THE LEASING AND OPERATION OF GREENHOUSE AND PACKHOUSE FACILITY IN THE DUBE AGRIZONE

Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to [www.dubetradeport.co.za](http://www.dubetradeport.co.za) for more information on DTPC.

Dube TradePort has various greenhouses and packhouses for the production and packaging of horticultural products. This is an invitation to independent prospective operators to submit proposals for leasing and operation a Four (4) hectare glass greenhouse (with associated packhouse) known as Block A at Dube AgriZone.

In keeping with its approach of providing world class facilities and infrastructure, DTPC wishes to invite interested companies who may wish to lease and operate the facility to submit proposals to DTPC.

DTPC will evaluate all proposals within a set timeframe and successful companies will be subjected to a due diligence process. If the proposal is accepted and a positive outcome of the due diligence process is achieved, DTPC will then enter into lease negotiation with an independent prospective operator.

DTPC wishes to enter into a market-related lease agreement with the successful operator for the Leasing and Operation of the Greenhouse and Packhouse facility for a period of approximately 5 (Five) years.

### EVALUATION OF PROPOSALS

The proposal will be evaluated in various stages i.e. compliance, functionality, and due diligence, thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points (Specific Goals) will be allocated to the following goals as included in the call for proposal document:

Preference goal	Points allocation
51% Ownership by black people	10
The creation of new jobs or the intensification of labour absorption	10

## REQUESTS FOR DOCUMENTS

Request for documents will be allowed **from 20 August 2025 up until suitable proposals are received by DTPC.**

Documents may be requested during the weekdays (Mon – Fri) between 08h30 and 16h00. Requests for documents must be submitted via e-mail and all documents will be issued via e-mail. No physical collection of documents is required.

## BRIEFING SESSION

A **NON-COMPULSORY**, but recommended, **briefing session meeting (Virtual)** for respondents, who have requested the CFP during the collection period, will be held via Microsoft Teams on **29 August 2025 at 11:00**. The briefing session is not compulsory but will provide CFP respondents with an opportunity to obtain clarity on certain aspects of the CFP process as set out in the CFP document.

A **NON-COMPULSORY site inspection** for any interested parties will be arranged should any prospective operator be interested to view the facility.
