#### 1. BACKGROUND

The National Heritage Council (NHC) seeks to appoint a service provider that will provide support strategic management services in the areas of Strategic Planning and Performance Management.

The NHC is a juristic entity established in terms of the National Heritage Council Act of 1999 (Act 11 of 1999), responds to the PFMA requirements and upholds corporate governance principles for guidance from King IV Report. Whilst NHC is a schedule 3A entity, the shareholder compact requires key performance measures and indicators that are linked to the NHC mandate. As a result, NHC Council requires a facilitator with experience to create a robust strategic planning session focusing on identification of priorities that will determine the future NHC that is responsive to new public sector challenges. The NHC is expected to introduce new and innovative strategies which will foster new beneficial partnerships and engineer a resilient and financially viable schedule 3A public entity.

#### 2. SERVICES REQUIRED

A service provider with experience in public sector strategic and performance management is required to facilitate and align the NHC strategy using best practices to produce and an agile and impactful strategic plan and Annual Performance Plan 2024/25. This calls for an expert with but not limited to; international, national heritage management, cultural diplomacy, shareholder compact alignment and balanced score card development.

#### 3. EXPECTED OUTCOMES

The expected outcome of the initiative is improved and streamlined organizational and employee productivity and impactful reporting, monitoring and evaluation.

In terms of strategic planning the expected outcomes are the Revised 2020/21 – 2024/25 Medium Term Strategic Framework (MTSF) and the 2024/25 Annual Performance Plan (APP) in line with the Revised Framework for Strategic Plans and Annual Performance Plans and produce a balance scorecard that is aligned to the

Strategy and APP. The service provider will be expected to provide an appraisal of the MTSF and conduct a workshop with Council and members of staff on {which date].

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

#### 2. **DEFINITIONS**
