Formal Bids will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management Office at the Shop Nr 7 Union Street Sanlam Building, Donkin Street, Beaufort West.

Telegraphic, telephonic, e-mailed and late Bids will not be accepted. The lowest, only or any Bid shall not necessarily be accepted and the Council reserves the right to accept any part of the Bid. The Bid must be valid for a period of 120 (one hundred and twenty) days after the closing date. The Bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.

It is a prerequisite that all prospective service providers who are not yet registered on the Central Supplier Database, register without delay by completing the prescribed online registration forms which are obtainable on the CSD website www.csd.gov.za. Bidders are further requested to ensure that all compliance documents are submitted with the original bid documents.
