1.1 DESCRIPTION OF SERVICE: SUPPLY OF IRRIGATION EQUIPMENT AND FITTINGS

BACKGROUND:

Installation of irrigation system is one of the major requirements for the project. Without this in place, planting of *Pelargonium sidoides* in this research cannot take place. Therefore, these irrigation equipment and fittings will work together with DFM soil moisture probes to schedule irrigation for these plants.

PURPOSE NEEDED FOR:

These irrigation equipment and fittings are needed in order for the plants to get the water required for optimum growth, especially in the summer months when irrigation is necessary due to very limited rain.

SCOPE OF WORK:

A field trial will be conducted to determine the effect of fertilization on the growth, yield and chemical composition of *Pelargonium sidoides* DC. Without the irrigation system in place, the project cannot commence.
