The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the provision of Consulting Engineering Services for the Resurfacing on National Route R37 Section 2 from Km 26.70 to Km 59.70. This project is in the province of Mpumalanga and in the local municipality of Thaba ChweU and the approximate programme is for design and construction documentation to be completed by **July 2025**, followed by supervision of **15 months** (including 3-month mobilisation period), commencing **November 2025**.

Only tenderers who are registered on the National Treasury Central Supplier Database and meet the minimum requirements for the key persons as stipulated in Clause C.2.1 at the tender closing date, are eligible to tender.

Joint Ventures (JV) will be allowed on condition that one JV partner is a Targeted Enterprise. The JV partner will, however, not contribute to sub-contract target for Targeted Enterprises.
