Sealed bids marked with a relevant **Bid No.** must be placed in the bid box at uPHONGOLO Local Municipality at 61 Martins Street, uPhongolo, 3170 **on or before 12H00 on closing date** and will be opened directly thereafter in public and the bid result will be published on municipal website within three (3) days.

The following conditions will apply:

- Bids must be valid for ninety (90) days from bid closing date.
- Bids will be evaluated in accordance with the applicable Preferential Point Scoring System as set out in the Councils Supply Chain Management Policy. The following form, MBD 1, MBD 3, MBD 4, MBD 5, MBD 6.1, MBD 8 and MBD 9 must be completed and submitted with the bid.
- Bids that are late or incomplete will not be considered, whilst the lowest or only bid will not necessarily be accepted. Bids per fax or E-mail will also not be considered.
- Prospective service providers who will be shortlisted and proceed to the next evaluation stage may be required to do presentations.
- A valid Tax Clearance Compliance Status Pin Certificate or CSD summary report with a compliant tax status must accompany all bids.

- All service providers must submit their BBBEE Verification Certificate from Verification Agency accredited by South African Accredited System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Directors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) in order to claim preference points.
- Bids must be accompanied with CIPRO documentation **to verify ownership**.

The evaluation of the bids will be conducted using stage 1 process in terms of national treasury circular No:53

Stage 1: Assessment of functionality. Only service provider who achieve a minimum score of 70% will qualify.
