### **GENERAL REQUIREMENTS**

The works, as described, are situated in the Overberg District. The quoted amount will be a lump sum bid and must include all material, labour and machinery. The successful bidder must have the capacity to start the works within 7 (seven) days after appointment and complete the work within contract period mentioned in CBD 2.1.

#### **Conditions that may pose a risk:**

This specific area is a very high crime area. The Contractor must put all necessary precautions in place to work under these conditions and to provide his / her own security and for the safekeeping of material and equipment

#### **The scope of works will include:**

1. The supply and installation of a 10.73km long, 1.5-metre-high security fence including pedestrian and farm gates

***In accordance with Casidra's Preferential Procurement Policy, this bid as further indicated in CBD 5.1 is subject to:***

- ***a functionality compliance test;***
- ***B-BBEE certified bids will receive preferential scores;***

For Construction works above the value of R500 000 – Tenderers must have a CIDB contractor grading designation of **3 GB** or **3 SQ** or higher.

The successful bidder will be required to fill in and sign a written Contract Form (CBD 8). Included are a penalty clause of R 500.00/calendar day that apply for late completion of works and a 5% retention fee for 3 months not bearing interest.

**BID DEADLINE:** The closing date for the bid is **10 November 2023 strictly at 12H00.**
