### CONSTRUCTION OF THE CALVINIA BULK WATER SUPPLY PROJECT

#### Tender Notice and Invitation to Tender

Hantam Municipality invites tenders for construction of the Calvinia Bulk Water Supply Project.

The physical address for collection of tender documents is **Hantam Municipality, 20 Dr Nelson Mandela Drive, Calvinia**. Documents may be collected from **Monday 6 March 2023** during working hours: **07h30 to 16h15**.

**A non-refundable tender deposit of R 627.90 payable in cash or by electronic transfer in favour of the Employer is required on collection of the tender documents. (Documents will also be available at the Compulsory Site Briefing)**

Sealed tenders, marked: **"Contract No. NC065 / T01 / 2023: CONSTRUCTION OF THE CALVINIA BULK WATER PROJECT"** must be placed in the tender box at the Hantam Municipal Offices at 20 Dr Nelson Mandela Drive, Calvinia before **12h00 on Tuesday, 04 April 2023**. The tenders will be opened publicly directly afterwards.

The following conditions will apply:

- Prices must be valid for ninety (90) days from tender closing date.
- Prices quoted must be inclusive of VAT.
- A firm delivery period must be indicated.
- Bids will be evaluated in accordance with the applicable Preferential Point Scoring System as set out in Councils' Supply Chain Management Policy. The following forms, MBD 1, MBD 2, MBD 4, MBD 5, MBD 6.1, MBD 6.2, MBD 8, MBD 9 and Certificate for Payment of Municipal Services must be completed and submitted with the bid.
- **Bidders are required to, together with their bids, submit an original and valid B-BBEE Status Level Verification Certificate or certified copies thereof to substantiate their B-BBEE rating claims.**
- Bids that are late or incomplete will not be considered, whilst the lowest or only bid will not necessarily be accepted. Bids per fax or e-mail will also not be considered.
- Pre- Qualification Criteria will be implemented.
- It is required that tenderers should have a CIDB contractor grading designation of **9CE**. Contractors registered as **8CE Potentially Emerging** enterprises, who satisfy criteria stated in the Tender Data may also submit tender offers. Tenderers who do not comply with this condition will not be considered.
- **An original tax clearance certificate (Tax Compliance Status Pin) as issued by SARS, for the tenderers must accompany the Tender Document. Tenders received without an attached original Tax Clearance Certificate (Tax Compliance Status Pin), will not be considered.**
- **Bidders must provide sound evidence in the tender document that they are financially and technically capable to complete the contract successfully.**
- Financial statements of the last three (3) financial years **must** be included as part of their bid document.
- Bids must be accompanied with CIPRO documentation to verify ownership.
- The 90/10 preferential points system, as determined by the Hantam Preferential Procurement Policy Regulations, 2023, will be applied to evaluate this tender.
- Points will also be awarded for "Locality". A bidder who fails to submit proof of locality with his/ her Bid will not be disqualified, but will only score 0 points for locality. Proof of locality means:
  - A municipal account in the name of the of the tenderer not older than 90 days;
  - A lease agreement where the tenderer is the lessee; or
  - An official letter from the bank confirming the registered business address of the tenderer.
- Points for B- BBEE and Locality must be claimed as per the tables below:
