**1 Submissions to RFQ**

Submissions to this RFQ [**Quotation**] must not include documents or reference relating to any other quotation or quotations. Any additional conditions must be embodied in an enclosed letter.

**2. Broad-Based Black Economic Empowerment [B-BBEE]**

CEF (SOC) Ltd fully endorses and supports the Government's Broad-Based Black Economic Empowerment Programme, and it would therefore prefer to do business with local business enterprises who share these same values. CEF (SOC) Ltd will accordingly allow a "preference" to companies who provide a valid B-BBEE verification certificate. All procurement transactions will be evaluated accordingly.

**2.1 B-BBEE Scorecard and Rating**

As prescribed in terms of the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of 2000 and its Regulations, bidders are to note that the following preference point systems are applicable to all tenders:

- the 80/20 system for requirements with a Rand value of up to R 50,000,000 (all applicable taxes included); and
- Bidders are to note that if the 80/20 preference point system is stipulated in this RFQ and if all tenders received exceed R 50, 000,000.00, the RFQ must be cancelled. Similarly, if the 90/10 preference point system is stipulated in this RFQ and all Tenders received are equal to or below R 50, 000,000.00, the RFQ must be cancelled.

**The value of this tender is estimated to be below R50, 000,000 (all applicable taxes included) and therefore the 80/20 system shall be applicable.**

When CEF (SOC) Ltd invites prospective suppliers to submit quotations for its various expenditure plans, it requires bidders to have their B-BBEE status verified in compliance with the Codes of Good Practice issued in terms of the Broad Based Black Economic Empowerment Act No. 53 of 2003.

Bidders are required to complete SBD 6.1: the B-BBEE Preference Point Claim Form and submit it together with proof that they meet CEF's preferential procurement specific goals as stipulated in the Claim Form to obtain preference points.

**Note: Failure to submit a valid proof demonstrating compliance to specific goals at the closing date of this RFQ will result in a score of zero being allocated for specific goals.**

### **3. Communication**

- a) Bidders are warned that a submission will be liable for disqualification should any attempt be made by a bidder either directly or indirectly to canvass any officer(s) or employee of CEF (SOC) Ltd in respect of this RFQ between the closing date and the date of the award of the business.

- reject all quotations, if it so decides;
- place an order in connection with this quotation at any time after the RFQ's closing date;
- award only a portion of the proposed goods / service/s which are reflected in the scope of this RFQ;
- split the award of the order/s between more than one Supplier/Service Provider; or
- Make no award at all.

## **PART 2**

### **SCOPE OF WORK**

CEF requires the services of a service provider a service provider to assist with the migration of users' backup data to Cibecs End-Point Cloud, provide licenses and support for 3 years.

#### **Background**

CEF, IT performs on-premises daily data backup using Cibecs backup software. Data is backed by Cibecs daily and send daily report. A total number of 130 of users hosted a virtual machine. The total 4TB of data is currently backed up.

#### **Minimum Requirements**

The Service provider should be able to provide the following migration project plan:

- Provide Pre-implementation Plan.
- Assess the readiness of the current service condition.
- Provide the Configuration.
- Piloting of the Deployment.
- Discovery and Activation of the agent
- Provide monitoring and Control.
- Handover and Training.
- Project Finalization and acceptance Test Documentation.
- Provide Daily Backup Report.
- Provide Continuous Maintenance and Support

**Tenders must submit their B\_BBEE certificate issued by an authorized body or person or a B-BBEE affidavit to claim preference points.**

- The points scored for the specific goal must be added to the points scored for price and the total must be rounded off to the nearest two decimal places.
- The contract must be awarded to the tenderer scoring the highest points.
- If two or more tenders score an equal total number of points, the contract must be awarded to the tenderer that scored the highest points for specific goals, and if two or more tenderers score equal total points in all respects, the award must be decided by the drawing of lots.
