1. INTRODUCTION AND PURPOSE

The City of Tshwane Metropolitan Municipality seeks qualified service providers to render the calibration and repairs of the Audiometer as and when for a period of a year.

2. BACKROUND

According to the OHS Act, (Act 85 of 1993) as amended, the employer must provide and maintain a healthy and safe work environment. It is the Employers responsibilities to ensure that employees exposed to the noise levels at or above the legal limit (85dBA) undergo routine medical evaluations.

Exposure to high levels of noise causes hearing loss and may cause other harmful health effects. The extent of damage depends on the intensity of the noise and the duration of the exposure. Noise-induced hearing loss can be temporary or permanent. Temporary hearing loss results from short-term exposure to noise, with normal hearing returning within 48 hours, after a period of rest. Prolonged exposure to high noise levels causes permanent damage. Hence hearing conservation programmes are designed to protect workers with significant occupational noise exposure from hearing impairment.

The City of Tshwane renders a holistic occupational health service, free of charge, to its employees who are exposed to noise, quantify the extent of exposure, and provide for proactive and reactive mitigation measures to provide a safe and healthy workplace. The service is rendered at all 7 main and 7 satellite occupational health clinics. It is the responsibility of the managers and supervisors to ensure that all employees who are exposed to noise are sent yearly to the occupational health clinics to be medically evaluated.

Such evaluations require for all City of Tshwane Occupational Health Clinics to have both the audio meter and audio booth. And to use to measure the level of noise exposure to monitor employee's health as per the legislative requirements. The audio meters need to be calibrated before use to ensure the integrity of the results obtained thereafter.

3. PROJECT SCOPE

The primary objective is to prevent noise-induced hearing loss and thus optimise employee performance and well-being. And to ensure that the risk associated with noise is effectively managed according to the City of Tshwane policy and legal requirements.

The City of Tshwane is currently using AMPLIVOX PC 850 audiometer therefore the booth supplied must be compatible with AMPLIVOX PC 850 audiometer

The Bidders are required to adhere to the following legislative and regulatory specifications. Non-compliance with these conditions may invalidate the bid for such services offered. Medical Surveillance is done to comply with relevant Acts and their regulations and with Corporate Policies, e.g.

- Occupational Health and Safety Act No.85 of 1993 and its regulations
- Noise-induced Hearing Loss Regulations
- SANS 083 (Code of Practice for the Measurement and Assessment of Occupational Noise for Hearing Conservation Purposes)
- Mine Health and Safety Act 29 of 1996
- City of Tshwane standard operating procedure on Hearing Conservation
- City of Tshwane standard operating procedure on Hazardous Chemical Substances

During the execution of the medical surveillance examinations the hearing tests that are performed require specialized equipment, including audiometers (hearing tests). To be subjected to a hearing test, the employee is required to sit in a soundproof booth that adheres to the required legal specifications including yearly calibration. The sound levels in the room need to comply with specification.

The following equipment and action are required:

- Audiometers complying with legal specifications
- Booths complying with legal specifications
- Calibration of audiometers and booths performed on a yearly basis by an Authorized Inspection Authority.
- Software for audiometers must comply with legal requirements.
- Software must be updated annually.

The target group who should be evaluated using such meters are:

- Machine operators (Jack hammer, chain saw, etc.)
- Artisans (Welders, plumbers, vehicle mechanics, etc.)

- Artisan's assistants
- Metro Police Officers
- Lawnmower operators
- Ride on operators
- Tractor drivers

Screening Audiometers and Sound Booths must comply with SANS 10083:2004

Conduct audiometric test as indicated in SANS Code 10083-2004, clauses 15,16,17 & 18, according to Instruction 171 of Act.130/1993 and NIHL Regulations 8.

Screening Audiometers and Sound Booths must:

- Comply with IEC (International Electrotechnical Commission) 60645-1 specifications for Type 4 audiometer, and is provided with an additional frequency of 8000 Hz for which a hearing level of at least 70 dB applies
- Be issued with a calibration certificate of compliance by an accredited inspection authority that contains at least the information required in 6.3 of SANS 10154-1:2000

• Be calibrated annually by an accredited inspection authority in accordance with **SANS 10154: 2000**

NB: The City of Tshwane is currently using Everest program.

Further action on failures by the supplier to deliver will be handled in terms of the contract, including performance warnings, and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market-related price with a tenderer scoring the highest points.

If the tenderer does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring the second-highest points. If the tenderer scoring the second-highest points does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring the third-highest points. If a market-related price is not agreed upon, the City reserves the right to cancel the quotation.
