Z1 Cession delegation and assignment

- Z1.1 The *Contractor* does not cede, delegate or assign any of its rights or obligations to any person without the written consent of the *Employer*.
- Z1.2 Notwithstanding the above, the *Employer* may on written notice to the *Contractor* cede and delegate its rights and obligations under this contract to any of its subsidiaries or any of its present divisions or operations which may be converted into separate legal entities as a result of the restructuring of the Electricity Supply Industry.

Z2 Joint ventures

- Z2.1 If the *Contractor* constitutes a joint venture, consortium or other unincorporated grouping of two or more persons or organisations then these persons or organisations are deemed to be jointly and severally liable to the *Employer* for the performance of this contract.
- Z2.2 Unless already notified to the *Employer*, the persons or organisations notify the *Service Manager* within two weeks of the Contract Date of the key person who has the authority to bind the *Contractor* on their behalf.
- Z2.3 The *Contractor* does not alter the composition of the joint venture, consortium or other unincorporated grouping of two or more persons without the consent of the *Employer* having been given to the *Contractor* in writing.

Z3 Change of Broad Based Black Economic Empowerment (B-BBEE) status

- Z3.1 Where a change in the *Contractor's* legal status, ownership or any other change to his business composition or business dealings results in a change to the *Contractor's* B-BBEE status, the *Contractor* notifies the *Employer* within seven days of the change.
- Z3.2 The *Contractor* is required to submit an updated verification certificate and necessary supporting documentation confirming the change in his B-BBEE status to the *Service Manager* within thirty days of the notification or as otherwise instructed by the *Service Manager*.
- Z3.3 Where, as a result, the *Contractor's* B-BBEE status has decreased since the Contract Date the *Employer* may either re-negotiate this contract or alternatively, terminate the *Contractor's* obligation to Provide the Service.
- Z3.4 Failure by the *Contractor* to notify the *Employer* of a change in its B-BBEE status may

constitute a reason for termination. If the *Employer* terminates in terms of this clause, the procedures on termination are P1, P2 and P4 as stated in clause 92, and the amount due is A1 and A3 as stated in clause 93.

Z4 Confidentiality

- Z4.1 The *Contractor* does not disclose or make any information arising from or in connection with this contract available to Others. This undertaking does not, however, apply to information which at the time of disclosure or thereafter, without default on the part of the *Contractor*, enters the public domain or to information which was already in the possession of the *Contractor* at the time of disclosure (evidenced by written records in existence at that time). Should the *Contractor* disclose information to Others in terms of clause 25.1, the *Contractor* ensures that the provisions of this clause are complied with by the recipient.
- Z4.2 If the *Contractor* is uncertain about whether any such information is confidential, it is to be regarded as such until notified otherwise by the *Service Manager*.
- Z4.3 In the event that the *Contractor* is, at any time, required by law to disclose any such information which is required to be kept confidential, the *Contractor*, to the extent permitted by law prior to disclosure, notifies the *Employer* so that an appropriate protection order and/or any other action can be taken, if possible, prior to any disclosure. In the event that such protective order is not, or cannot, be obtained, then the *Contractor* may disclose that portion of the information which it is required to be disclosed by law and uses reasonable efforts to obtain assurances that confidential treatment will be afforded to the information so disclosed.
- Z4.4 The taking of images (whether photographs, video footage or otherwise) of the Affected Property or any portion thereof, in the course of Providing the Service and after the end of the *service period*, requires the prior written consent of the *Service Manager*. All rights in and to all such images vests exclusively in the *Employer*.
- Z4.5 The *Contractor* ensures that all his subcontractors abide by the undertakings in this clause.

Z5 Waiver and estoppel: Add to core clause 12.3:

- Z5.1 Any extension, concession, waiver or relaxation of any action stated in this contract by the Parties, the *Service Manager* or the *Adjudicator* does not constitute a waiver of rights, and does not give rise to an estoppel unless the Parties agree otherwise and confirm such agreement in writing.

Z6 Health, safety and the environment: Add to core clause 27.4

Z6.1

The Contractor undertakes to take all reasonable precautions to maintain the health and safety of persons in and about the execution of the service. Without limitation the Contractor:

- accepts that the Employer may appoint him as the "Principal Contractor" (as defined and provided for under the Construction Regulations 2014 (promulgated under the Occupational Health & Safety Act 85 of 1993) ("the Construction Regulations") for the Affected Property;
- warrants that the total of the Prices as at the Contract Date includes a sufficient amount for proper compliance with the Construction Regulations, all applicable health & safety laws and regulations and the health and safety rules, guidelines and procedures provided for in this contract and generally for the proper maintenance of health & safety in and about the execution of the service; and
- undertakes, in and about the execution of the service, to comply with the Construction Regulations and with all applicable health & safety laws and regulations and rules, guidelines and procedures otherwise provided for under this contract and ensures that his Subcontractors, employees and others under the Contractor's direction and control, likewise

observe and comply with the foregoing.

Z6.2 The *Contractor*, in and about the execution of the *service*, complies with all applicable environmental laws and regulations and rules, guidelines and procedures otherwise provided for under this contract and ensures that his Subcontractors, employees and others under the *Contractor's* direction and control, likewise observe and comply with the foregoing.

Z7 Provision of a Tax Invoice and interest. Add to core clause 51

Z7.1 Within one week of receiving a payment certificate from the *Service Manager* in terms of core clause 51.1, the *Contractor* provides the *Employer* with a tax invoice in accordance with the *Employer's* procedures stated in the Service Information, showing the amount due for payment equal to that stated in the payment certificate.

Z7.2 If the *Contractor* does not provide a tax invoice in the form and by the time required by this contract, the time by when the *Employer* is to make a payment is extended by a period equal in time to the delayed submission of the correct tax invoice. Interest due by the *Employer* in terms of core clause 51.2 is then calculated from the delayed date by when payment is to be made.

Z7.3 The *Contractor* (if registered in South Africa in terms of the companies Act) is required to comply with the requirements of the Value Added Tax Act, no 89 of 1991 (as amended) and to include the *Employer's* VAT number 4740101508 on each invoice he submits for payment.

Z8 Notifying compensation events

Z8.1 Delete the last paragraph of core clause 61.3 and replace with:

If the *Contractor* does not notify a compensation event within eight weeks of becoming aware of the event, he is not entitled to a change in the Prices.

Z9 Employer's limitation of liability

Z9.1 The *Employer's* liability to the *Contractor* for the *Contractor's* indirect or consequential loss is limited to R0.00 (zero Rand)

Z9.2 The *Contractor's* entitlement under the indemnity in 82.1 is provided for in 60.1(12) and the *Employer's* liability under the indemnity is limited to compensation as provided for in core clause 63 and X19.11 if Option X19 Task Order applies to this contract.

Z10 Termination: Add to core clause 91.1, at the second main bullet point, fourth sub-bullet point, after the words "against it":

Z10.1 or had a business rescue order granted against it.

Z11 Ethics

For the purposes of this Z-clause, the following definitions apply:

Affected Party means, as the context requires, any party, irrespective of whether it is the *Contractor* or a third party, such party's employees, agents, or Subcontractors or Subcontractor's employees, or any one or more of all of these parties' relatives or friends,

Coercive Action means to harm or threaten to harm, directly or indirectly, an Affected Party or the property of an Affected Party, or to otherwise influence or attempt to influence an

- Committing Party** means, as the context requires, the *Contractor*, or any member thereof in the case of a joint venture, or its employees, agents, or Subcontractors or the Subcontractor's employees,
- Corrupt Action** means the offering, giving, taking, or soliciting, directly or indirectly, of a good or service to unlawfully or illegally influence the actions of an Affected Party,
- Fraudulent Action** means any unlawfully or illegally intentional act or omission that misleads, or attempts to mislead, an Affected Party, in order to obtain a financial or other benefit or to avoid an obligation or incurring an obligation,
- Obstructive Action** means a Committing Party unlawfully or illegally destroying, falsifying, altering or concealing information or making false statements to materially impede an investigation into allegations of Prohibited Action, and
- Prohibited Action** means any one or more of a Coercive Action, Collusive Action Corrupt Action, Fraudulent Action or Obstructive Action.

- Z11.1 A Committing Party may not take any Prohibited Action during the course of the procurement of this contract or in execution thereof.
- Z11.2 The *Employer* may terminate the *Contractor's* obligation to Provide the Services if a Committing Party has taken such Prohibited Action and the *Contractor* did not take timely and appropriate action to prevent or remedy the situation, without limiting any other rights or remedies the *Employer* has. It is not required that the Committing Party had to have been found guilty, in court or in any other similar process, of such Prohibited Action before the *Employer* can terminate the *Contractor's* obligation to Provide the Services for this reason.

- Z11.4 A Committing Party co-operates fully with any investigation pursuant to alleged Prohibited Action. Where the *Employer* does not have a contractual bond with the Committing Party, the *Contractor* ensures that the Committing Party co-operates fully with an investigation.

Z13 Nuclear Liability

- Z13.3 Subject to clause Z13.4 below, the *Employer* waives all rights of recourse, arising from the aforesaid, save to the extent that any claims arise or liability is incurred due or attributable to the unlawful intent of the *Contractor* or any other person, or the presence of the *Contractor* or that person or any property of the *Contractor* or such person at or in the KNPS or on the KNPS site, without the permission of the *Employer* or of a person acting on behalf of the *Employer*.
- Z13.4 The *Employer* does not waive its rights provided for in section 30 (7) of Act 47 of 1999, or any replacement section dealing with the same subject matter.
- Z13.5 The protection afforded by the provisions hereof shall be in effect until the KNPS is decommissioned.

Z14 Asbestos

For the purposes of this Z-clause, the following definitions apply:

- AAIA** means approved asbestos inspection authority.
- ACM** means asbestos containing materials.
- AL** means action level, i.e. a level of 50% of the OEL, i.e. 0.1 regulated asbestos fibres per ml of air measured over a 4-hour period. The value at which proactive actions is required in order to control asbestos exposure to prevent exceeding the OEL.
- Ambient Air** means breathable air in area of work with specific reference to breathing zone, which is defined to be a virtual area within a radius of approximately 30cm from the nose inlet.
- Compliance** means compliance sampling used to assess whether or not the personal exposure of

- Z14.1 The *Employer* ensures that the Ambient Air in the area where the *Contractor* will Provide the Services conforms to the acceptable prescribed South African standard for asbestos, as per the regulations published in GNR 155 of 10 February 2002, under the Occupational Health and Safety Act, 1993 (Act 85 of 1993) ("Asbestos Regulations"). The OEL for asbestos is 0.2 regulated asbestos fibres per millilitre of air as a 4-hour TWA, averaged over any continuous period of four hours, and the short term exposure limit of 0.6 regulated asbestos fibres per millilitre of air as a 10-minute TWA, averaged over any 10 minutes, measured in accordance with HSG248 and monitored according to HSG173 and OESSM.
- Z14.2 Upon written request by the *Contractor*, the *Employer* certifies that these conditions prevail. All measurements and reporting are effected by an independent, competent, and certified occupational hygiene inspection body, i.e. a SANAS accredited and Department of Employment and Labour approved AAIA. The *Contractor* may perform Parallel Measurements and related control measures at the *Contractor's* expense. For the purposes of compliance the results generated from Parallel Measurements are evaluated only against South African statutory limits as detailed in clause Z14.1. Control measures conform to the requirements stipulated in the AAIA-approved asbestos work plan.
- Z14.3 The *Employer* manages asbestos and ACM according to the Standard.
- Z14.4 In the event that any asbestos is identified while Providing the Services, a risk assessment is conducted and if so required, with reference to possible exposure to an airborne concentration of above the AL for asbestos, immediate control measures are implemented and relevant air monitoring conducted in order to declare the area safe.
- Z14.5 The *Contractor's* personnel are entitled to stop working and leave the contaminated area forthwith until such time that the area of concern is declared safe by either Compliance Monitoring or an AAIA approved control measure intervention, for example, per the emergency asbestos work plan, if applicable.
- Z14.6 The *Contractor* continues to Provide the Services, without additional control measures presented, on presentation of Safe Levels. The contractually agreed dates to Provide the Services, including the Completion Date, are adjusted accordingly. The contractually agreed dates are extended by the notification periods required by regulations 3 and 21 of the Asbestos Regulations, 2001.
- Z14.7 Any removal and disposal of asbestos, asbestos containing materials and waste, is done by a registered asbestos contractor, instructed by the *Employer* at the *Employer's* expense, and

This confirms that Option A is a priced contract where the Prices are derived from a list of items of service which can be priced as lump sums or as expected quantities of service multiplied by a rate or a mix of both.

Function of the Price List

Clause 54.1 in Option A states: "Information in the Price List is not Service Information". This confirms that instructions to do work or how it is to be done are not included in the Price List but in the Service Information. This is further confirmed by Clause 20.1 which states, "The *Contractor* Provides the Service in accordance with the Service Information". Hence the *Contractor* does **not** Provide the Service in accordance with the Price List. The Price List is only a pricing document.

Link to the *Contractor's* plan

Clause 21.4 states "The *Contractor* provides information which shows how each item description on the Price List relates to the operations on each plan which he submits for acceptance". Hence when compiling the *price list*, the tendering contractor needs to develop his first clause 21.2 plan in such a way that operations shown on it can be priced in the *price list* and result in a satisfactory cash flow in terms of clause 11.2(17).

Preparing the *price list*

Before preparing the *price list*, both the *Employer* and tendering contractors should read the TSC3 Guidance Notes pages 14 and 15. In an Option A contract, either Party may have entered items into the *price list* either as a process of offer and acceptance (tendering) or by negotiation depending on the nature of the *service* to be provided. Alternatively the *Employer*, in his Instructions to Tenderers or in a Tender Schedule, may have listed some items that he requires the *Contractor* to include in the *price list* to be prepared and priced by him.

If the *Contractor* is to be paid an amount for an item of work which is the rate for the work multiplied by the quantity completed, the tendering contractor enters the rate which is then multiplied by the Expected Quantity to produce the Price, which is also entered.

C3.1: EMPLOYER’S SERVICE INFORMATION

1. Description of the service

1.1 Executive overview

Eskom Generation has identified the need to replace the old, armoured security vehicles at various power stations. The objective is to ensure the same level of protection of convectional armoured vehicles across each power station.

The level of Political and Socio-Economic status of the country substantially has increased over the past few years. Generation sites have to frequently deal with unrest /unprotected strikes and marches by communities and labour forums. Armed robberies, hijackings and cash heists are unfortunately just some of the dangers faced by security forces in South Africa. In order to protect our National Key Point sites, with the view of security personnel responding to these issues, they need to be adequately protected to perform their functions as protective services. Eskom cannot solely depend on external stakeholders to render their assistance when required. The current Generation old armoured modified vehicles are unable to withstand the weight impact of armour package and resulting in frequent mechanical maintenance issues and long lead times of unavailability.

Approval by GEXCO committee was granted to purchase and supply one (01) X double cab and one (01) single cab Landcruiser armoured convectional vehicles per station.

1.2 Employer’s requirements for the service

The Eskom Generation Security Division requires the services of a Manufacture and/or manufacture Accredited installer to convert supplied vehicles into B6 armoured vehicles according to the set specifications. The type of vehicles that will be supplied by Eskom are:

- 21 x Toyota Land Cruiser Diesel Single Cabs or similar.
- 21 x Toyota Land Cruiser Diesel Double Cabs or similar

2.4 Provision of bonds and guarantees

The form in which a bond or guarantee required by the *conditions of contract* (if any) is to be provided by the *Contractor* is given in Part 1 Agreements and Contract Data, document C1.3, Sureties.

The *Employer* may withhold payment of amounts due to the *Contractor* until the bond or guarantee required in terms of this contract has been received and accepted by the person notified to the *Contractor* by the *Service Manager* to receive and accept such bond or guarantee. Such withholding of payment due to the *Contractor* does not affect the *Employer's* right to termination stated in this contract.

2.5 Documentation control

All contractual communications will be in the form of properly compiled letters or a message in the e mail itself. The Contractor complies with the requirements of Eskom document Management system. All documents provided to the Contractor shall remain part of the Employer asset at the end of the contract. The contractor shall submit a copy of all documents to the Employer to ensure the Employer and Contractor possesses same documents.

2.6 Invoicing and payment

Within one week of receiving a payment certificate from the *Service Manager* in terms of core clause 51.1, the *Contractor* provides the *Employer* with a tax invoice showing the amount due for payment equal to that stated in the *Service Manager's* payment certificate.

2.9 Training workshops and technology transfer

The contractor must provide a "Training the trainer" training, on the equipment fitted on the vehicles as well as how to maintain the vehicles to ensure that the vehicle and the ballistic equipment are always in good operating state.

The training shall consist of the theory and practical training, the training shall be conducted in the contractor's facility, the contractor shall provide the training material, manuals, boardroom, lunch and other logistics. The employer shall be responsible for traveling to the contractor's premises. The contractor shall provide several sessions, up to four sessions, training 42 trainees in total.

The contractor to provide the Employer with the training manuals, the training manuals shall be reviewed and accepted by the Employer prior to conducting the training.

2.10 Design and supply of Equipment

The contractor shall provide the Employer with the method statement, showing how the armouring on the vehicles will be done. The equipment shall consist of the data pack showing the armouring designs, all the tests and certificates of compliance.

Details of the specifications of the armouring equipment must be shared with the Service Manager on delivery of the armoured vehicles

It is the responsibility of the contractor to ensure that the designs or specifications of the armouring material to use are compatible to the provided vehicles.

- Will adhere to Eskom’s Occupational Health and Safety policies, standards, procedures, directives, OHS Specification/requirements, applicable health and safety laws and regulations and other requirements, as amended.
- May not commence work until the Health and Safety file has been approved by the respective Contract Custodian together with the OHS professional.
- Warrants that the total of the Prices as at the Contract date includes a sufficient amount for proper compliance with all applicable health & safety laws and regulations and the health and safety rules, guidelines and procedures provided for in this contract and generally for the proper maintenance of health & safety in and about the execution of works.

3.1.2 The service provider shall comply with the health and safety requirements contained in Occupational Health and Safety (OHS) Specification issued by the respective Power Stations.

- The service provider shall compile and submit the Safety file to the respective Power Station. The safety file shall be evaluated and approved by the respective site OHS professional and the Contract custodian.
- Access to site shall be granted once the safety file is approved and the service provider’s employees have attended the site OHS induction.
- Below are minimum Safety requirements to be adhered to by contractors/service providers, to gain access to Eskom Power Stations:
 - Valid Medical fitness certificate
 - Identification document (RSA ID or equivalent)
 - National Drivers Licence (applicable to drivers)

3.2 Environmental constraints and management

3.2.2 Compliance obligation

The *Contractor* must be aware that all Eskom sites stipulated as per scope of work have own site specific Environmental Management Plan (EMP), Environmental Authorisations (EA), environmental permits, licenses and a set of procedures that the contractor need to comply with when on their sites. 3.3 Quality assurance requirements

The QM 58 Category 2 Quality requirements shall apply for the contract duration (12 months). The final CQP and QCP based on NEC Works information shall be provided 30 days after contract award (TBC) to the Supply Manager. Supplier documentation shall comply with the latest ISO 9001 standard.

Eskom encourages its suppliers to constantly strive to improve their B-BBEE rating. Whereas Tenderer/s will be allocated points in terms of a preference point system based on specific goals, Eskom also requests that tenderer/s submits their B-BBEE improvement or retention plan within 30 days of signing the contract.

Subcontract documentation shall not form part of the contractual relationship between the *Employer* and the *Contractor*, unless the documentation is for a statutory nature and have direct impact on the legal compliance of the Employer

4.10 Plant and Materials

4.10.1 Specifications

The Plant / workshop and materials to Armor the vehicles shall be provided by the Contractor and its maintenance vehicles will be the responsibility of the Contractor within the stipulated maintenance plan. Post maintenance plan, the Employer reserves the right to maintain the armouring of the vehicles from their preferred service provider.

4.10.2 Correction of defects

In the event where a failure occurs during armouring of the vehicles, the *Contractor* shall report to the Employer within an hour of an incident and the *Contractor* shall be responsible for the

In the event where a failure occurs after the armoured vehicles has been handed over to the Employer, NEC3 TSC core clause 4 Testing & defects shall apply.

4.10.3 Contractor's procurement of Plant and Materials

The contractor shall ensure that the armouring equipment is procured from certified suppliers and ensure that the warranty of the equipment is preserved. The contractor shall include the warranties from suppliers in the quality file and hand over at the end of the service.

4.10.4 Tests and inspections before delivery

Refer to NEC3 TSC Core Clause 41.1.

It is the Contractor's responsibility to ensure the machinery and equipment intended for use on this contract is inspected, tested and certified prior to using to ensure they do not damage the vehicles.

Regular inspections on the vehicles shall be carried out by the *Employer* on an as and when required basis. The Contractor and the Employer must maintain communication regarding the test and inspections that must be done and give feedback on the result obtained.

The Contractor must inform the Employer in time (at least 5 days) for a test or inspection to be arranged and done before doing the work.

The employer reserves the right to conduct non-pre-destined inspection of the vehicles, and the contractor shall not deprive the employer access.

All armoured vehicles are to be inspected before delivery.

4.10.5 Plant & Materials provided "free issue" by the *Employer*

The *Employer* shall supply the vehicles to the *Contractor*, these are the vehicles to be armoured. The vehicles shall be delivered to the Contractor's workshop by the Employer. The Contractor shall be responsible for the safety of the vehicles ensuring that the vehicles are kept safe from any theft and any damage, including but not limited to weather damages.

Working on the Affected Property

5.1 Conduct

The *Contractor* and his employees are always required to maintain professional and ethical conduct, that upholds the Employer's values while working on the vehicles to safeguard the vehicle. This includes but not limited to ensuring that the people who work on the vehicles of the Employer are Sober, which is one of the Employer's Life Saving Rules.

The *Contractor* shall not utilise the vehicles for any other purpose rather than the intended as stated in the service information, without the consent from the *Employer*.

5.2 *Employer's* site entry and security control, permits, and site regulations

5.3 People restrictions, hours of work, conduct and records

The *Contractor* keeps records of his people working on the supplied vehicles to ensure that they are NEVER used for any unintended purpose. The *Service Manager* shall have access to the records as and when requested.

5.4 Health and safety facilities on the Affected Property

The Contractor shall ensure that their workshop /building is safe to keep the supplied vehicles, armour and test the vehicles and further ensures that the workshop complies to the health and safety requirements for workshops.

5.5 Environmental controls, fauna & flora

The Contractor shall ensure they comply with all relevant environmental legislation and regulations to manage and reduce environment degradation.

5.6 Cooperating with and obtaining acceptance of Others

Refer to NEC3 TSC clause 25.1
See clause 11.2(9) for the definition of Others

5.7 Records of Contractor's Equipment

The contractor shall keep record of the equipment they utilise to Armour the vehicles and shall make it available to the Employer as and when required. The record must include the supplier's details, calibrations certificates, testing conducted, maintenances record, operational records etc.

5.8 Equipment provided by the Employer

The Employer shall not provide any equipment to the Contractor

5.9 Site services and facilities

Provided by the Employer

The Employer shall provide the vehicles to the Contractor and further collects once the vehicles has been successfully armoured.

Provided by the Contractor

The contractor shall provide a Safe storage for vehicles during armouring and/or when the vehicles are in the possession of the contractor.

5.10 Control of noise, dust, water and waste

The Contractor shall be responsible to manage all the risks related to car damages, keep the vehicles safe from any damage, ensure cars are not exposed to weather damage while the vehicles are at their premises .

5.11 Hook ups to existing works

If applicable, the contractor shall ensure the fall protection plan is in place and complied to.

5.12 Tests and inspections

Description of tests and inspections

The test and inspection to be carried out by the Contractor. The tests and inspections will be determined by the Contractor and communicated to the Employer for acceptance prior to the testing.

Materials facilities and samples for tests and inspections

The materials facilities and samples for test and inspection to be carried out by the Contractor. The Materials facilities and samples for tests and inspections will be determined by the Contractor and communicated to the Employer for approval.
