## INVITATION TO BID

**TLM05/2025/26 - PANEL OF SERVICE PROVIDERS FOR THE REPAIR AND MAINTENANCE OF PUMPS AND PUMP STATION INFRASTRUCTURE FOR A PERIOD OF THREE (3) YEARS AS AND WHEN NEEDED**

**CLOSING DATE AND TIME: 19 SEPTEMBER 2025 at 12h00**

The Thembelihle Local Municipality invites tenders for Tender No.TLM05/2025/26 – Panel of Service Providers for the repair and maintenance of pumps and pump station infrastructure for a period of three (3) years as and when needed. Only Tenderers who are registered with CIDB in a contractor grading of **4ME** and higher will be eligible to tender.

Tender documents shall be available at Thembelihle Local Municipality Offices, Church Street, Hopetown, 8750 from the 19<sup>th</sup> of August 2025 during office hours from 08:00 – 16:00 on weekdays or on the e-tender portal and Municipal website for free of Charge. The Hard Copy Document can also be obtained from the Municipality at a non-refundable fee of R500.00 at the Cashier Point in Hopetown. Tender documents are to be completed in black ink and in accordance with the conditions and rules contained in the bid documents and must be placed in a sealed envelope and clearly marked as with tender number and name.

Before completing the bid document, bidders must be cognizant of the following:

- Council's Supply Chain Management Policy and other applicable legislation.
- Bidders shall provide a copy of a CSD Summary Report as proof of registration.
- Bidders shall provide the Municipality with a Tax Compliance Status PIN.
- **NB: Bidders who are listed in the National Treasury register of defaulters and restricted suppliers will be automatically disqualified.**
- **A copy of Municipal Utility Bill (not older than 3 months) in which the business is registered. Metro, District Municipality and Local municipality or if the bidder is a tenant, the Lease agreement should be submitted along with the Rates and Taxes Account for the premise, unless otherwise stated in the Lease Agreement.**

- **A copy of Municipal Utility Bill (not older than 3 months) of all Directors of the Company. Metro, District Municipality and Local municipality or if the bidder is a tenant, the Lease agreement should be submitted along with the Rates and Taxes Account for the premise, unless otherwise stated in the Lease Agreement.**
- Bidders with a CIDB Certificate with a grading of 4 ME or higher will be eligible to tender.
- Compliance with the tender technical specification requirements.
- **Submission of relevant documentation must be attached.**
- Subject to the above the Municipality reserve a right to appoint additional contractor/s if deemed necessary in order to complete the scope of work.

The tenders will be evaluated on Functionality and the 80/20 Point System of the PPPFA of 2022.

**Telephonic, facsimile, email and/or late bids will not be accepted. Bids must be valid for a period of ninety (90) days after the closing date of the bid.**
